### Summary Information

**Overview.** The bill requires the Department of Personnel and Administration to conduct or commission a statewide language access assessment covering all principal departments except the Departments of State, Treasury, and Law.

**Types of impacts.** The bill is projected to affect the following area through FY 2026-27:

**Appropriations.** For FY 2025-26, the bill requires an appropriation of \$100,000 to the Department of Personnel and Administration.

## Summary of Legislation

---

The bill requires the Department of Personnel and Administration (DPA), in collaboration with the Office of New Americans (ONA) in the Department of Labor and Employment, to conduct a statewide language access assessment covering all principal departments except the Departments of State, Treasury, and Law. The assessment will evaluate departments' needs for compliance with language access standards, identify existing language services, and recommend improvements to ensure linguistically diverse Coloradans can access government services. At the conclusion of the assessment, and no later than December 31, 2026, the DPA and ONA will create a report summarizing the assessment's findings and recommendations, which must be posted online and included in the DPA's 2027 SMART Act hearing.

## Background

---

Enhancing state agencies' language accessibility plans in coordination with the DPA is part of [ONA's State Integration Plan](#). ONA and the DPA are expected to coordinate an Interim Language Access Working Group involving impacted state agencies this year.

## State Expenditures

---

Assuming that the DPA will contract for the language access assessment, the department requires an estimated \$100,000 in FY 2025-26 from the General Fund. Actual costs will depend on contract terms, and the fiscal note assumes roll-forward spending authority is required based on the bill's timelines. It is assumed the work associated with this effort will be absorbed by affected state agencies as part of their involvement in the working group.

## Effective Date

---

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.

## State Appropriations

---

For FY 2025-26, the bill requires a General Fund appropriation of \$100,000 to the Department of Personnel and Administration, with roll-forward spending authority through FY 2026-27.
