Fiscal note status: The fiscal note reflects the introduced bill, which was recommended by the Joint Budget Committee as part of its supplemental budget package.

Summary Information

Overview. On June 30, 2025, the bill repeals the FLEX program and transfers all unspent and unencumbered money in the FLEX Fund to the General Fund.

Types of impacts. The bill is projected to affect the following areas starting in the current FY 2024-25:

- State Transfers
- State Expenditures

Appropriations. No appropriation is required.

Summary of Legislation

On June 30, 2025, the bill transfers all the unexpended and unencumbered money in the FLEX Fund to the General Fund, and repeals the FLEX program on July 1, 2025.

Background

In 2022, the General Assembly created the Financial Literacy and Exchange (FLEX) program, which allows households participating in the state housing voucher program to open an escrow-like savings account. FLEX account holders would receive a \$200 monthly match and access to services such as financial mentoring, life skills training, and asset management. No households have been enrolled in the FLEX program.

The program is funded by an annual General Fund appropriation into a continuously appropriated cash fund. The FLEX Fund has received \$708,952 since FY 2022-23, and accounting for interest earned, is projected to have approximately \$625,000 available to transfer on June 30, 2025.

State Transfers and Expenditures

In the current FY 2024-25, the bill transfers \$625,000 from the FLEX Fund to the General Fund. Correspondingly, the bill will reduce any future spending from FLEX Fund on the repealed program, and make this money available to spend or save in the General Fund starting in FY 2025-26.

Effective Date

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.
