## Overview of Department

The Department of Public Health and Environment's public health programming resides primarily in the following divisions. The Office of Health Equity and Environmental Justice and the Office of Planning, Partnerships, and Improvement reside within the Executive Director's Office that was discussed during a separate briefing on December 3<sup>rd</sup>, 2024.

The **Center for Health and Environmental Data (CHED)** maintains a database of all Colorado births, deaths, marriages, and divorces and provides certificates upon request. The Center also operates the Medical Marijuana Registry and analyzes health data for use by public and private entities.

The **Division of Disease Control and Public Health Response (DCPHR)** includes the immunization program, disease surveillance system, network for emergency preparedness and response and state laboratory. The division:

- Operates the Immunization Program, including the Immunization Outreach Program, the Colorado Immunization Information System, and grants to local public health agencies (LPHAs);
- Operates the state laboratory; and
- Coordinates a statewide network of laboratories, local agencies, hospitals, and other resources that can be utilized during disaster response.

The **Office of HIV, Viral Hepatitis, and STI's (OHVS)** identifies, contains, controls, and tracks the spread of communicable diseases, with a focus on hepatitis, tuberculosis, sexually transmitted infections, and HIV/AIDS. The office includes the Colorado HIV and AIDS Prevention Grant Program (CHAPP) and Ryan White Program.

The **Prevention Services Division (PSD)** is responsible for prevention programs across the state, including many grants to LPHAs and community-based organization as well as reimbursement for preventative healthcare services. These programs/grants include:

- Tobacco Education, Prevention, and Cessation Program and the Cancer, Cardiovascular Disease, and Chronic Pulmonary Disease Prevention, Early Detection, and Treatment Program;
- Breast and Cervical Cancer Screening Program;
- Programs for children with special needs and the Genetics Counseling Program;
- The School-Based Health Centers Program;
- Injury and suicide prevention programs;
- Primary Care Office and Oral Health Program; and
- Women, Infants, and Children and Child and Adult Care Food federal assistance programs.

The **Health Facilities and Emergency Medical Services Division (HFEMSD)** enforces, through certification and inspections, the standards for the operation of health care facilities, including hospitals and nursing facilities. The division also inspects and certifies emergency medical and trauma service providers.





#### Department's Share of Statewide General Fund





#### **Department Funding Sources**





The divisions' largest cash funds are TABOR exempt. The Tobacco Master Settlement Agreement (MSA) is exempt as settlement revenue and other fund sources were voter approved.

Reported cash fund balances above \$500,000 are listed in the tables below, separated by funds that primarily receive revenue subject to TABOR and those that primarily receive TABOR exempt revenue.

Two cash funds that have the largest reserve relative to their annual expenditures are (1) the Nursing Home Penalty Cash Fund and (2) the Community Crime Victims Grant (CCVG) Program Cash Fund. However, the Nursing Home Penalty Cash Fund has federal restrictions on what the funds may be used for and the CCVG fund does not have a consistent revenue source.

The Nursing Home Penalty Cash Fund supports a \$6.0 million appropriation for Nursing Home Grants that is consistently underspent. This is due to federal restrictions on allowable uses of grant funds. Additionally, the Centers for Medicare and Medicaid Services (CMS) must approve all grants and has recently changed grant parameters, including the addition of a new limit of \$5,000 per facility per grant category per year. The Department has indicated that is working with nursing homes, industry leaders, and other stakeholders in order to promote the grant opportunity.

The majority of cash funds that receive TABOR exempt revenue are used for grants and drug assistance. The fund balances do not include grant obligations. Most of these funds rely on tobacco-related revenue (Master Settlement Agreement, Amendment 35, and Proposition EE).

## General Factors Driving the Budget

## **Federal Funds**


Federal funds account for 37.5 percent (\$326.0 million) of the entire Department's FY 2024-25 total appropriation. This percentage is even greater (52.4 percent) for the health divisions of the Department.

The Department receives federal funds from multiple federal agencies ranging from the Environmental Protection Agency to the U.S. Department of Health and Human Services. The majority of the federal funds in the Department's Long Bill are shown for informational purposes.

The majority of federal funds (64.8 percent) are allocated to five federally funded program areas:

- the Women, Infants, and Children Program or WIC (28.3 percent);
- immunizations for local public health agencies (16.4 percent);
- the Adult and Child Food Care Program (9.0 percent);
- the Ryan White Act program (5.8 percent); and
- emergency preparedness and response (5.4 percent).

The Prevention Services Division, which houses the WIC program and Adult and Child Food Care program, comprises the largest share of the Department's federal funds. The division also uses federal funds to support reproductive health programs, maternal and child health, and injury prevention.




### Tobacco Revenue

The Department receives annual revenue from the Amendment 35 tobacco tax, the Proposition EE nicotine tax, and the Tobacco Master Settlement Agreement. These revenue sources are TABOR exempt.

Amendment 35 revenues and a portion of Proposition EE revenues are deposited into the Tobacco Tax Cash Fund (TTCF). This funding is then distributed annually based on the State's constitutional formula to the Tobacco Education Programs Fund (16.0 percent) and the Prevention, Early Detection, and Treatment (PEDT) Fund (16.0 percent). The majority of this funding is distributed to local public health agencies and community-based organizations as grants. Within the PEDT Fund, the money is further allocated to:

- The Breast and Cervical Cancer Program (20.0 percent);
- The Health Disparities Fund (15.0 percent);
- A fixed amount (\$116,942) to the Center for Health and Environmental Data; and
- The rest is allocated to Cardiovascular, Pulmonary, and Chronic Disease (CCPD) Grants.



Distributions from the Tobacco Tax Cash Fund are declining

The Tobacco Master Settlement Agreement (MSA) is a 1998 legal settlement between tobacco manufacturers and states that sued manufacturers to recover Medicaid and other health-related costs incurred by treating smoking-related illnesses. Statutory formulas dictate the distribution of MSA revenue, which is estimated to be \$10.8 million in FY 2025-26, to the following programs in CDPHE:

- Drug assistance programs (ADAP, Ryan White) (5.0 percent);
- Colorado AIDS and HIV Prevention Grant Program (CHAPP) (3.5 percent);
- Colorado Immunizations Program (2.5 percent);
- Colorado Health Services Corps (1.0 percent); and
- Dental Loan Repayment Program (1.0 percent).

As these two revenue streams are expected to decrease over time, programs must continually reassess the allocation of funds towards administrative overhead and grants.

## Marijuana Revenue

Voters legalized recreational marijuana in 2012 and subsequently approved new taxes on recreational marijuana. The General Assembly adopted legislation authorizing the Department to use a portion of the new marijuana tax revenue for new and existing programs. Over time, the General Assembly has increased the number of programs and the amount of funding the Department receives from the Marijuana Tax Cash Fund. Funding was reduced in FY 2020-21 in order to provide General Fund relief during the COVID pandemic, and has remained fairly consistent since.





The table below provides an overview of the FY 2024-25 appropriation and FY 2025-26 request for programs funded by the Marijuana Tax Cash Fund. The total for both years is \$23.8 million.

**R5b Public health technical adjustments**: The Department requests two net-zero technical adjustments that correct a letternote within the Disease Control and Public Health Response Division (DCPHR) and adjust cash funds within the Center for Health and Environmental Data (CHED) in order to properly reflect funding used to complete public health surveys.

**R8 LPHA 5.0 percent reduction:** The request includes a reduction of 5.0 percent, or \$945,220 General Fund, in FY 2025-26 and ongoing that would decrease the Department's distribution to

Local Public Health Agencies (LPHAs). The request would reduce both Local Planning and Support Dollars as well as base funding for local environmental health services.

**R9 Reduce coroner reimbursements:** The request includes a reduction of \$79,500 General Fund in FY 2025-26 and ongoing that would reduce the funds available to reimburse coroners for toxicology screenings for non-natural deaths of people under 25 years old. The Department indicates that coroners have not utilized the full appropriation in FY 2022-23 and FY 2023-24.

**R11 Sunset disordered eating program [Requires Legislation]:** The request includes a reduction of \$91,398 General Fund and 1.0 FTE in FY 2025-26 and ongoing as a result of eliminating the Disordered Eating Prevention Program. The Department indicates that all funded activities outlined in S.B. 23-014, which created the program, were completed. The bill also created an unfunded grant program, which was not implemented.

**R12 Sunset kidney disease task force [Requires Legislation]:** The request includes a decrease of \$86,549 General Fund in FY 2025-26 and ongoing as a result of an early sunset to the Kidney Disease Task Force created in H.B. 21-1171. The task force is currently scheduled to sunset in September 2026 after completion of a final report discussing a plan to raise awareness about early detection of kidney disease.

**Non-prioritized decision items:** The request includes a net increase of \$66,626 total funds, including \$5,855 General Fund, for requests that originate in the Department of Personnel and Health Care Policy and Financing.

**Annualize prior year legislation:** The request includes a net increase of \$5.0 million total funds to reflect the FY 2025-26 impact of bills passed in previous sessions. The increase is comprised of a \$9.2 million reduction in General Fund and cash funds, offset by a \$14.0 million increase in reappropriated funds. Legislation highlighted in blue primarily impacts public health divisions.

**Centrally appropriated line items:** The request includes a net increase of \$10.7 million total funds, including \$3.7 million General Fund, for centrally appropriated line items. These are managed within the Department's Administration and Support Division covered in a separate briefing on December 3, 2024.

**Indirect cost assessment:** The request includes a net increase of \$1.4 million total funds, including no General Fund, to indirect costs across all divisions.

**Technical adjustments:** The request includes a \$225,180 decrease in total funds to properly account for the transfer of behavioral health facility licensing responsibilities to the Behavioral Health Administration.

## **Budget Reduction Options**

The Executive Budget Request includes reductions of \$2.1 million General Fund for the public health divisions of the Department of Public Health and Environment. This represents 3.1 percent of the General Fund appropriations in this section of the budget. This issue brief reviews these proposals and additional options identified by staff.

## **Summary**

- The divisions in this briefing represent 0.4 percent of total state General Fund appropriations in FY 2024-25. The executive budget request includes proposed reductions of \$2.1 million or 3.1 percent of the General Fund appropriations. When adding in reductions from prior year legislation and budget actions, the General Fund appropriation in this section of the budget is requested to decrease by 4.0 percent.
- Since FY 2018-19, General Fund in this section of the budget has grown by 70.4 percent compared to the state growth of 11.3 percent. This is largely attributed to legislation and budget actions that increased ongoing expenditures for public health programs.
- Distributions to local public health agencies are a primary subject of both requested and additional reductions.

### Recommendation

- Staff recommends that the Department discuss the impact of the proposed reductions to DCPHR and local public health agencies – considering a both a 5.0 percent and 10.0 percent General Fund reduction to each.
- Staff also recommends that the Department provide a list of new and expanded programs (see pages 16 and 17) that are not fully implemented or consistently revert funds.

### Discussion

## Funding History FY 2018-19 to FY 2024-25


The public health divisions of the Department of Public Health and Environment represent 0.4 percent of total state General Fund appropriations in FY 2024-25. As reflected in the table below, General Fund in this section of the budget has increased by 70.4 percent since FY 2018-19 after adjustments for inflation<sup>1</sup>. This is more than the statewide increase in General Fund

appropriations of 11.3 percent over the same period after adjustments. Over the same period total funding in this section of the budget, after adjustments, has decreased by 6.9 percent.

The divisions' General Fund appropriations peaked in FY 2022-23 with an addition of pandemic-related funding, but have generally remained elevated since FY 2021-22.



While total General Fund appropriations have fluctuated over time due to one-time funding adjustments, the ongoing base funding for programs has continued to increase. The growth of the ongoing General Fund appropriation is largely attributed to legislation outside of the Long Bill and more recently, decision items within the Long Bill. The below table shows the largest ongoing General Fund increases since FY 2021-22.

## **Budget Requests for General Fund Relief**

For this section of the budget, the budget request includes proposals for General Fund relief totaling \$2.1 million, representing 3.1 percent of the General Fund appropriations within this section of the budget. These reductions do not include additional reductions from the out-year impacts of prior year legislation and budget actions. The total General Fund appropriation covered in this section of the budget is requested to decrease by 4.0 percent. The proposals for

#### **Revenue Enhancements**

### Reduce funding for select ARPA programs

*Description:* This one-time option would reduce funding for certain ARPA programs that were refinanced to General Fund in FY 2024-25. As of September 2024, the Department had \$141.6 million General Fund for ARPA programs that was unencumbered. The Department is already expecting to return \$5.5 million of these funds in FY 2024-25.

#### **Key Considerations:**

- Of the \$141.6 million in unencumbered funds, \$100.6 million are allocated for COVID-19 testing. The Department has indicated that it is waiting for reimbursement from the Federal Emergency Management Agency (FEMA) and plans to utilize these funds in case reimbursement is not obtained. The funds were initially expended on a FEMA line of credit.
- The Department has indicated that it plans to fully expend all ARPA allocations outside of the \$5.5 million allocation for "Healthcare Workforce Recruitment and Re-engagement" from S.B. 22-226.

Additional background: As of September 2024, the following ARPA projects have been allocated General Fund that remains unencumbered.

## Transfer remaining balance from the Emergency Medical Services Peer Assistance Fund to the General Fund

Description [Requires Legislation]: This one-time option would transfer the remaining fund balance (\$2,729) of the EMS Peer Assistance Fund to the General Fund in FY 2025-26.

#### **Key Considerations:**

- Historically, the fund received revenue from a provider certification fee that was used to support providers through physical, emotional, or psychological challenges.
- Since July 2022, fees have been suspended and the Department indicates that the EMS Peer Assistance Program is funded through other means.
- Money in the fund is not subject to annual appropriation by the General Assembly.

#### **Expenditure Reductions**

## Reduce administrative funding for the Division of Disease Control and Public Health Response (DCPHR) by 5.0 percent

Description: This ongoing option is a 5.0 percent (\$397,321) General Fund reduction to the Administration and Support line item within DCPHR. This line received funding to respond to the COVID-19 pandemic through S.B. 21-243 and recently received \$5.6 million in ongoing General Fund through the committee's budget actions in FY 2024-25.

#### **Key Considerations:**

 DCPHR's Administration and Support funding has decreased since peak appropriations during the COVID-19 pandemic, but remains more than double the pre-pandemic appropriation.

- From FY 2021-22 to FY 2023-24, S.B. 21-243 (CDPHE Appropriation Public Health Infrastructure) allocated \$11.1 million in additional funds for DCPHR to respond to the COVID-19 pandemic and additional outbreaks.
- In FY 2024-25, the committee approved 75.0 percent of the Department's R1 request to continue a portion of pandemic-era funding for DCPHR. This included \$5.6 million in ongoing General Fund for the division. Staff recommends asking the Department for an update on how the \$5.6 million General Fund that was approved for DCPHR in FY 2024-25 has been spent.
- The FY 2024-25 funds were requested to support administration and fiscal services, strategy and operations, policy and equity work, emergency preparedness and response, epidemiology and reporting, and laboratory services.
- DCPHR's Administration and Support line item fully spent its General Fund appropriation in FY 2023-24.

Additional background: The below table outlines the staff that were funded by S.B. 21-243, the staff that were requested for continuation, and the associated funding that was requested.

Within "Administration and Fiscal Services", fifteen FTE were requested for human resources functions, nine for financial, three for communications, and three for "Performance Strategy, Oversight, and Improvement". Within each of the remaining program areas, the Department also requested additional administrative staff.

Of the funding requested, \$5,625,000 General Fund and 62.1 FTE ongoing were approved by the JBC.



#### Reduce funding for Local Public Health Agencies (LPHAs) by 10.0 percent

Description: This option expands on the Department's R8 request to reduce state distributions to LPHAs by 5.0 percent, and instead proposes a 10.0 reduction (\$1.9 million General Fund). This is an ongoing option that is likely to impact program operations.

#### **Key Considerations:**

 Total distributions to LPHAs approximately doubled in FY 2021-22 and have remained fairly consistent since then.



- From FY 2021-22 to FY 2023-24, S.B. 21-243 (CDPHE Appropriation Public Health Infrastructure) allocated \$10.0 million in additional funds for distribution to LPHAs. This allowed the Department to increase the base funding for every LPHA to \$55,000 with the intent to support at least one FTE at each LPHA.
- In FY 2024-25, the committee approved \$11.0 million in ongoing General Fund for LPHAs. The majority of these funds are distributed as Local Planning and Support Dollars (LPSD) and may be used for any Core Public Health Service.<sup>2</sup> This is one of the most flexible funding sources for LPHAs.
- There is evidence that supports that local public health interventions reduce medical costs and provide returns on investments.<sup>3</sup>
- LPHAs have indicated that even a 5% reduction would affect operations including emergency response, family health programs, immunizations, maternal and child health, and health education. In particular, they suggested that this impact would be greater for smaller and rural agencies that rely on flexible funding streams.

Additional background: More detail on the appropriation for funding distributed to LPHAs is detailed below. Beginning in FY 2021-22, state distributions to LPHAs have doubled compared to pre-pandemic appropriations.

The above distributions are primarily comprised of Local Planning and Support Dollar formulaic distributions. The additional funding allowed LPHAs to hire additional staff including data analysts, epidemiologists, community outreach coordinators, nurses, finance staff, mobile clinic staff, dietitians, harm reduction staff, and behavioral health staff.

If a 10.0 percent (\$1.9 million) reduction were spread evenly across all 57 LPHAs, each agency's distribution would decrease by \$33,166. If a 5.0 percent reduction applied in the same manner, each agency's distribution would decrease by \$16,583. In reality, the formula is based on a \$55,000 base and additional adjustments based on metrics including the CDC Social Vulnerability Index, population density, and health outcomes.

Furthermore, state funding comprises a larger portion of smaller LPHA budgets (see figure below) and a reduction may have a greater impact on these agencies. The Department has also indicated that over the past decade, LPHAs have typically spent 99.0 percent of their appropriation.



## Reduce regulatory oversight program for gamete agencies, gamete banks, and fertility clinics by 15.0 percent or delay full implementation

*Description:* Reduce funding for the regulatory oversight program, created in S.B. 22-224 (Protections for Donor-conceived Persons and Families), by 15.0 percent or \$43,998 General Fund. This is an ongoing option expected to impact program operations.

#### **Key Considerations:**

- This is a new program that has not yet been fully implemented. S.B. 22-224 requires the licensing of gamete agencies, gamete banks, and fertility clinics starting January 1, 2025.
- The program is entirely funded by General Fund. It reverted 72.7 percent (\$139,830) in FY 22-23 and 31.2 percent (\$91,441) in FY 23-24, which the Department attributes to slow program startup. The Department has indicated as of June 2024, the program is fully staffed and expected to spend its full appropriation.
- This option is reflective of a number of new, additional programs in the Department that are not yet fully implemented, but have reverted funds in their first few years.

Additional background: More details on the General Fund appropriation and reversion for the Regulatory Oversight Program is included below. The program is entirely funded by General Fund and anticipating a cost increase in FY 24-25 as the licensure requirement goes into effect. Eventually, the program plans to use fee revenue to support program operations.

#### Temporarily reduce Health Disparities and Community Grant Program funding

*Description:* Temporarily reduce the General Fund appropriation for the Health Disparities and Community Grant Program by 20.0 percent (\$940,000).

#### **Key Considerations:**

- The program is one of few, large grant programs in the Department that is partially supported by General Fund.
- In addition to General Fund, the program is supported by declining tobacco tax revenues.
- A reduced appropriation is likely to impact grantees. In July 2024, the Department awarded \$3.1 million to 18 grantee projects for a three-year grant cycle.
- A 20.0 reduction is projected to remove funding for five grants or result in a \$52,222 reduction for each grantee. The average grant award in 2024 was \$174,055

#### Additional Background:

The Health Disparities and Community Grant Program aims to reduce the risk of disease and health disparities in underrepresented populations.

The program is in demand. In its latest Request for Applications earlier this year, the program received 190 applications that requested \$33.5 million in FY 2024-25. The program had \$3.1 million to disburse in FY 2024-25 and has awarded grants to 18 grantees. Grantees included local public health departments, non-profits, a food bank, health clinic, and the Ute Mountain Ute Tribe. The average award was \$174,055.

The Health Disparities and Community Grant Program is funded by General Fund (initiated through S.B. 21-181) and 2.4 percent of Amendment 35 tax revenues. In FY 2024-25, the program received a \$4,700,000 General Fund appropriation and \$2,098,592 appropriation from the Health Disparities Grant Program Fund that receives tobacco revenue. Distributions from Amendment 35 revenue have decreased over the past five years.

## Cash Funds with Revenue Challenges

This issue brief provides an overview of two program areas that do not generate adequate revenue to fully support program appropriations.

## Summary

- The state laboratory received \$3.7 million General Fund in FY 2024-25 to support operations, as its Laboratory Cash Fund does not generate enough fee revenue to support the laboratory's full appropriation.
- The EMS provider grant consistently distributes fewer funds than its cash fund spending authority allows due to concerns about the long-term solvency of the EMS Account.

### Discussion

## **State Laboratory**

The State Laboratory had an appropriation of \$17.7 million in FY 2024-25. Of this amount, \$3.9 million was appropriation from General Fund, \$5.9 from the Newborn Screening and Genetic Counseling Cash Funds, \$1.8 million from the Laboratory Cash Fund, and \$1.2 million from the Marijuana Tax Cash Fund.

Over the past five years, the two largest line items within the laboratory have reverted 7.0 to 35.5 of annual cash appropriations. The Department has indicated that these reversions occurred because the Laboratory Cash Fund did not have adequate revenue to support the full appropriation. These reversions are outlined in the table below.

The Laboratory Cash Fund, created in 25-1.5-101 (1)(e)(II), C.R.S., receives fees from customers that submit microbiological and environmental samples. The fund also receives fees from laboratory certifications.

General Fund has been used to support recent state laboratory budget requests. For example, the FY 2024-25 R5 request to pay for laboratory operating expenses and courier services was approved with \$1.3 million General Fund and \$1.4 million cash funds.

#### Questions to consider:

- What is the Department's strategy to ensure laboratory fees generate adequate revenue to laboratory expenses?
- How does the Department determine how to set fees that generate revenue for the Laboratory Cash Fund?
- Should the state laboratory be solely funded by cash funds, or is General Fund support appropriate?

## **Emergency Medical Services (EMS)**

Emergency Medical Service provider grants are awarded to emergency medical and trauma services provider to maintain and improve local services. The grants fund areas including vehicles, communications, data collection, equipment, prevention, personnel, and recruitment and retention.

The Department has indicated that it does not distribute the full appropriation for EMS provider grants in order to support the long term solvency of the EMS Account within the Highway Users Tax Fund (HUTF), Section 25-3.5-603, C.R.S.

The grants received an FY 2024-25 appropriation of \$8.4 million cash funds from the EMS Account. Revenue is generated from a \$2.00 fee on motor vehicle registrations and fees for provisional certification, licensure, or registration of EMS providers and responders. The Department projects a \$3.8 million cash fund balance at the end of FY 2024-25.

In addition to EMS provider grants, the EMS Account also supports the Division's administration and operations, State EMS Coordination, Planning, and Certification Program and distributions to regional emergency and medical trauma councils (RETACs). The division reverted significantly fewer cash funds within these program areas and fully distributes funds to RETACs every year.

#### Questions to consider:

- When was the last time the Department distributed the full cash fund appropriation for EMS Provider Grants? When did revenue limitations become a barrier to full distribution?
- What is the Department's plan to generate additional revenue to fully support the cash fund appropriation for EMS Provider Grants?

## Footnotes and Requests for Information

## **Update on Long Bill Footnotes**

The General Assembly includes footnotes in the annual Long Bill to: (a) set forth purposes, conditions, or limitations on an item of appropriation; (b) explain assumptions used in determining a specific amount of an appropriation; or (c) express legislative intent relating to any appropriation. Footnotes to the 2024 Long Bill (H.B. 24-1430) can be found at the end of each departmental section of the bill at <a href="https://leg.colorado.gov/bills/HB24-1430">https://leg.colorado.gov/bills/HB24-1430</a>.

The Long Bill footnotes relevant to this document are listed below.

Department of Public Health and Environment, Disease Control and Public Health Response, General Disease Control, and Surveillance, Immunization Operating Expenses -- It is the General Assembly's intent to provide flexibility in the use of these funds toward a menu of evidence based immunization interventions, including but not limited to mobile health clinics, community and school based vaccination clinics, data improvement efforts, funding for VISTA/AmeriCorps volunteer efforts and family participation incentives.

**Comment:** This footnote represents legislative intent to allow the Department to flexibly use funding for immunizations.

<u>93</u> Department of Public Health and Environment, Division of Disease Control and Public Health Response, Office of Emergency Preparedness and Response, Emergency Preparedness and Response Program -- Amounts in this line item are calculated based on the assumed federal match rate of 90.9 percent federal funds to 9.1 percent state funds which is assumed to be demonstrated on a federal fiscal year basis.

**Comment:** This footnote expresses legislative intent and provides flexibility in the use of the federal funds so the Department may "overspend" the state share during the state fiscal year while ensuring match rate compliance during the federal fiscal year. This footnote is being recommended in place of an (M) note on the General Fund in this line item.

Department of Public Health and Environment, Prevention Services Division, Chronic Disease Prevention Programs, Transfer to Health Disparities Grant Program Fund -- It is the General Assembly's intent that if the amount of actual Amendment 35 tobacco tax revenues that are required by statute to be transferred to the Health Disparities Grant Program Fund are higher than the appropriation set forth in this line item, then the transfer to the Health Disparities Grant Program Fund of such tobacco tax revenues will be increased by an amount equal to the difference between such actual tobacco tax revenues and the appropriated amount.

**Comment:** This footnote provides the Department the authority to transfer the constitutionally amount of Amendment 35 revenue credited to the Prevention, Early Detection, and Treatment Fund to the Health Disparities Program Fund, regardless of the appropriation in the Long Bill. This footnote provides the Department the authority to comply with constitutional

requirements without exceeding the Long Bill appropriation if actual Amendment 35 revenues are higher than the projected amount used to set the Long Bill appropriation.

Department of Public Health and Environment, Prevention Services Division, Family and Community Health, Women's Health, Family Planning Program Administration; Family Planning Purchase of Services; and Family Planning Federal Grants -- Article V, Section 50 of the Colorado Constitution states that "No public funds shall be used by the State of Colorado, its agencies or political subdivisions to pay or otherwise reimburse, either directly or indirectly, any person, agency or facility for the performance of any induced abortion, provided however, that the General Assembly, by specific bill, may authorize and appropriate funds to be used for those medical services necessary to prevent the death of either a pregnant woman or her unborn child under circumstances where every reasonable effort is made to preserve the life of each."

**Comment:** This footnote reiterates the Colorado constitutional restriction on using state funds for abortion services. The Department is in compliance with this footnote.

Department of Public Health and Environment, Prevention Services Division, Family and Community Health, Children and Youth Health, School-based Health Centers -- It is the General Assembly's intent that this appropriation be used for the purpose of assisting the establishment, expansion, and ongoing operations of school-based health centers in Colorado.

**Comment:** This footnote expresses the General Assembly's intent for how the funds are used.

<u>100</u> Department of Public Health and Environment, Prevention Services Division, Family and Community Health, Injury and Violence Prevention, Community Crime Victims Grant Program -- This appropriation remains available until all grantees in this fiscal year have been reimbursed or the close of the 2025-26 state fiscal year, whichever comes first.

**Comment:** This footnote allows the Department to extend grant funding to grantees over a two-year period to ensure grantees can fully expend funds.

<u>101</u> Department of Public Health and Environment, Health Facilities and Emergency Medical Services Division, Operations Management, Administration and Operations -- Of this appropriation, \$156,045 General Fund remains available until the close of the 2025-26 state fiscal year pursuant to Section 25-3.5-1401(2), C.R.S.

**Comment:** This footnote allows the Department to spend funds across multiple fiscal years to distribute stop the bleed materials as outlined in H.B.23-1213 (Stop The Bleed School Training And Kits).

Department of Public Health and Environment, Health Facilities and Emergency Medical Services Division, Emergency Medical Services, Emergency Medical Services Provider Grants -- This appropriation remains available until all grantees in this fiscal year have been reimbursed or the close of the 2024-25 2025-26 state fiscal year, whichever comes first.

**Comment:** This footnote allows the Department to extend grant funding to grantees over a two-year period to ensure grantees can fully expend funds.

# Department of Public Health and Environment (Public Health Divisions) Requests

Department of Public Health and Environment, Division of Disease Control and Public Health Response, Office of Emergency Preparedness and Response, Emergency Preparedness and Response Program. The Department is requested to provide the federal grant funding received for the current fiscal year as well as any changes to the match rate or expected changes in available federal funds by November 1st of each fiscal year.

**Comment:** This RFI, in coordination with a footnote, replace an (M) note, and ensure the General Fund appropriated to the program is reflective of the federal grant funding the state receives. If the federal funding the Department received in the current fiscal year is lower than the expected amount that the initial General Fund appropriation was based on, then the General Fund appropriation in the current fiscal year should be reduced to reflect the 10.0 percent state funds to federal funds match.

In FY 2024-25, the Office of Emergency Preparedness and Response received \$14,151,493 in federal grant funding, which requires a 10.0 percent match (\$1,415,149). The program's FY 2024-25 General Fund appropriation is \$1,681,202 and could potentially be reduced by \$266,053 to align with the federal funds received. The Office does not anticipate changes to the federal funding.

- Department of Public Health and Environment, Office of HIV, Viral Hepatitis, and STI's -The Department is requested to provide a report related to the statewide syphilis
  response and congenital syphilis prevention program with the following information to
  the Joint Budget Committee by November 1st of each fiscal year:
  - Number of participants who receive a syphilis screening while detained in local county jails, from community sites, or in an emergency room;
  - Number of participants who receive a positive screen who receive syphilis treatment prior to release from detention at a local county jail, from community sites, or in an emergency room;
  - Number of participants who receive referrals for supportive services;
  - Number of participants who test positive for syphilis and are pregnant.

**Comment:** The Department provided the requested information related to statewide syphilis response and the congenital syphilis county prevention project.

At the county-level, a total of 544 participants received a syphilis screening. 118 of these individuals received a positive syphilis screening, as shown in the table below.

Of those who received a positive screen, 51 individuals (81.0 percent) received treatment within the local county detention center and 14 individuals (74.0 percent) received treatment in a community setting. Two individuals who tested positive for syphilis were pregnant, and both received treatment. This averted two cases of congenital syphilis.

Within emergency departments, 316 women of reproductive age were screened. The outcomes of these screenings are described in the table below.

Of those that received a positive syphilis screening, five did not indicate treatment.

At the state level, 35 individuals received field delivered therapy, six of whom were pregnant. Furthermore, 950 rapid tests were distributed to over 34 different agencies. These tests indicate a preliminary positive rate of 2.3 percent.

State Tobacco Education and Prevention Partnership: The program provides funding for community-based and statewide tobacco education programs intended to reduce initiation of tobacco use by children and youth, promote cessation of tobacco use, and reduce exposure to secondhand smoke. In FY 2023-24, the first year of a multi-year grant cycle, the program funded 60 projects across 59 organizations. Grantee activities reached 15,751 individuals that received direct-to-consumer services from cessation programs, including the QuitLine and Baby and Me Tobacco Free program. Additionally, non-intervention services, including media campaigns, provider education, and technical assistance to health organization, engaged Colorado residents at least 192,523 times.

Cancer, Cardiovascular and Chronic Pulmonary Disease Grants Program: The program supports grants that address prevention, early detection, and treatment of cancer, cardiovascular disease, and chronic pulmonary disease. In FY 2023-24, the program funded 18 grantee projects including:

- Hypertension control programs through self-monitored blood press monitoring,
- Promotion and expansion of the National Diabetes Prevention Program,
- Home-based asthma control strategies,
- Clinical programs to reduce cancer, cardiovascular disease, asthma, and diabetes, and
- Policy and environmental change.

**Women's Wellness Connection:** The program provides navigation and diagnostic services for breast and cervical cancer screening, and funds community organizations that provide assistance to reduce barriers to screening.

**Health Disparities and Community Grant Program:** The program aims to use a systemic approach to reduce health disparities across the state, and is in its final year of a three-year grant cycle. Current funding supports 14 grantees across 12 counties, working with 211 community-based partner organizations. Grantees have organized 701 events that reached 17,890 community members.

**Immunization Core Services Contracts:** This funding supports 38 local public health agencies, who administered 83,639 doses of non-COVID vaccines to 42,214 individuals. Per Section 24-22-117, C.R.S., the funding is limited to county or district public health agencies in areas that were served by county public health nursing services prior to July 1, 2008.
