

JOINT BUDGET COMMITTEE STAFF FY 2021-22 BUDGET BRIEFING SUMMARY

Colorado General Assembly Joint Budget Committee

Department of Natural Resources

Division of Reclamation, Mining, and Safety, Oil and Gas Conservation Commission, the State Board of Land Commissioners, and severance tax policy.

Funding for the divisions covered in this briefing packet consists of 89.0 percent cash funds, 0.7 percent reappropriated funds, and 10.3 percent federal funds in FY 2020-21. These divisions did not receive General Fund appropriations in FY 2020-21 and have not requested General Fund appropriations in FY 2021-22.
