HOUSE COMMITTEE OF REFERENCE AMENDMENT  
Committee on Transportation, Housing & Local Government.  
HB23-1173 be amended as follows:

1 Amend printed bill, page 3, line 16, after "(1)," insert "(2) introductory  
2 portion,".

3 Page 3, line 17, strike "(2.3) and".

4 Page 4, line 1, after "OF" insert "ELEVEN".

5 Page 4, strike lines 5 through 27.

6 Strike page 5.

7 Page 6, strike line 1 and substitute:

8 "(2) FOR TERMS COMMENCING BEFORE FEBRUARY 1, 2027, one  
9 member of the commission shall be appointed by the governor from each  
10 of the following districts, AND FOR TERMS COMMENCING ON OR AFTER  
11 FEBRUARY 1, 2027, ONE MEMBER SHALL BE ELECTED FROM EACH OF THE  
12 FOLLOWING DISTRICTS:

13 (2.5) (a) AT THE NOVEMBER 2026 GENERAL ELECTION, ALL  
14 ELEVEN MEMBERS OF THE COMMISSION SHALL BE ELECTED FOR TERMS  
15 COMMENCING ON FEBRUARY 1, 2027. THE INITIAL TERMS OF THE MEMBERS  
16 ELECTED FROM THE DISTRICTS DESCRIBED IN SUBSECTIONS (2)(a), (2)(c),  
17 (2)(e), (2)(g), (2)(i), AND (2)(k) OF THIS SECTION ARE FOUR YEARS, AND  
18 THE INITIAL TERMS OF THE MEMBERS ELECTED FROM THE DISTRICTS  
19 DESCRIBED IN SUBSECTIONS (2)(b), (2)(d), (2)(f), (2)(h), AND (2)(j) OF THIS  
20 SECTION ARE TWO YEARS. THEREAFTER, AS TERMS EXPIRE, MEMBERS OF  
21 THE COMMISSION SHALL BE ELECTED AT GENERAL ELECTIONS FOR TERMS  
22 OF FOUR YEARS.

23 (b) THE MEMBERS OF THE COMMISSION SHALL BE NOMINATED AND  
24 ELECTED BY THE REGISTERED ELECTORS OF EACH DISTRICT DESCRIBED IN  
25 SUBSECTION (2) OF THIS SECTION AS SPECIFIED BY LAW."

26 Page 6, line 2, strike "(e)" and substitute "(c)".

27 Page 6, strike lines 12 through 26 and substitute:

28 "(3) Each ~~district~~ member OF THE COMMISSION shall actually  
29 reside in the district ~~he or she~~ THAT THE MEMBER represents. BEFORE  
30 FEBRUARY 1, 2027, if a ~~district~~ member ceases to reside in the district ~~he~~  
31 ~~or she~~ THAT THE MEMBER represents, ~~such district~~ THE member shall be  
32 deemed to have resigned as a member of the commission."

- 2 Page 9, line 5, strike "FOR" and substitute "WHO RESIDES IN".
- 3 Page 10, line 21, strike "CONGRESSIONAL DISTRICT" and substitute
- 4 "DISTRICT DESCRIBED IN SECTION 43-1-106 (2)".
- 5 Page 11, line 9, strike "(1)(c)(II)(B) and".
- 6 Page 11, strike lines 23 through 27.
- 7 Page 12, strike lines 7 and 8 and substitute "ON OR AFTER FEBRUARY 1,
- 8 2027, THE LESSER OF ONE THOUSAND FIVE HUNDRED OR, IF APPLICABLE,
- 9 TWO AND ONE-HALF PERCENT OF THE VOTES CAST IN THE MOST RECENT
- 10 GENERAL ELECTION FOR THE OFFICE OF MEMBER OF THE TRANSPORTATION
- 11 COMMISSION FOR THE APPLICABLE DISTRICT DESCRIBED IN SECTION
- 12 43-1-106 (2);".
- 13 Page 14, line 15, strike "number of members of and".
- 14 Page 1, line 103, strike "NUMBER OF MEMBERS OF AND".
