- 9 Page 9, line 26, strike "RETENTION" and substitute "CONTINUED
- 10 ENROLLMENT".
- Page 11, strike lines 22 through 27 and substitute:
- 12 "(b) For a child with disabilities who is enrolled in a
- 13 CHARTER SCHOOL THAT PARTICIPATES IN AN ALTERNATIVE
- 14 ADMINISTRATIVE UNIT, THE ALTERNATIVE ADMINISTRATIVE UNIT, FOR THE
- 15 DURATION OF THE CHILD'S ENROLLMENT IN THE CHARTER SCHOOL, IS
- 16 SOLELY LEGALLY AND FISCALLY RESPONSIBLE FOR SPECIALIZED

- 28 CONDITION OF APPROVAL OF ITS APPLICATION OR APPROVAL OR RENEWAL
- 29 OF ITS CONTRACT WITH THE SCHOOL DISTRICT.".
- 30 Page 15, after line 2 insert:
- 31 "(f) THE STATE CHARTER SCHOOL INSTITUTE SHALL NOT REQUIRE
- 32 AN INSTITUTE CHARTER SCHOOL TO PARTICIPATE IN AN ALTERNATIVE
- 33 ADMINISTRATIVE UNIT AS A CONDITION OF APPROVAL OF ITS APPLICATION
- 34 OR APPROVAL OR RENEWAL OF ITS CONTRACT WITH THE STATE CHARTER
- 35 SCHOOL INSTITUTE.".
