

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business Affairs & Labor.

HB22-1314 be amended as follows:

1 Amend printed bill, page 15, line 9, strike "(3)(b)(III)" and substitute  
2 "(3)(b)(IV)".

3 Page 15, line 19, strike "OR".

4 Page 15, strike line 22 and substitute "ROADWAY;

5 (E) THE VEHICLE IS PARKED IN VIOLATION OF SECTION 42-4-1208  
6 (4) OR IN RESERVED PARKING FOR PEOPLE WITH DISABILITIES WITHOUT  
7 DISPLAYING AN IDENTIFYING PLACARD OR AN IDENTIFYING PLATE, AS  
8 THOSE TERMS ARE DEFINED IN SECTION 42-3-204 (1)(f) AND (1)(g), THAT  
9 IS CURRENTLY VALID OR HAS BEEN EXPIRED FOR NO MORE THAN SIXTY  
10 DAYS;

11 (F) THE VEHICLE IS PARKED IN OR EFFECTIVELY OBSTRUCTING A  
12 DESIGNATED AND MARKED FIRE ZONE;

13 (G) THE VEHICLE IS OCCUPYING WITHOUT PERMISSION OR  
14 EFFECTIVELY OBSTRUCTING ACCESS TO OR FROM AN INDIVIDUALLY  
15 DESIGNATED, RENTED, OR PURCHASED PARKING SPACE OF A RESIDENT; OR

16 (H) THE VEHICLE IS PARKED WITHOUT DISPLAYING VALID  
17 AUTHORIZATION IN A PARKING LOT MARKED FOR THE EXCLUSIVE USE OF  
18 RESIDENTS."

19 Page 16, after line 22 insert:

20 "(c) IN ORDER FOR A TOWING CARRIER TO CONDUCT A  
21 NONCONSENSUAL TOW UNDER SUBSECTION (3)(b)(I)(G) OR (3)(b)(I)(H) OF  
22 THIS SECTION, THE PROPERTY OWNER MUST HAVE POSTED SIGNAGE VISIBLE  
23 AND FACING THE DRIVER AT EACH ENTRY WAY INTO A PARKING AREA  
24 INDICATING THAT PARKING SPACES ARE DESIGNATED FOR ONE OR MORE  
25 SPECIFIED RESIDENTS AND THAT A VEHICLE PARKED WITHOUT  
26 AUTHORIZATION IS SUBJECT TO BEING TOWED. THE SIGN MUST ALSO  
27 CONTAIN THE INTERNATIONAL TOWING SYMBOL NO SMALLER THAN FOUR  
28 INCHES BY FOUR INCHES AND BE PERMANENTLY MOUNTED IN A POSITION  
29 THAT IS NO LOWER THAN FIVE FEET AND NO HIGHER THAN EIGHT FEET."

30 Reletter succeeding paragraph accordingly.
