It would take away the opportunities for physical and mental health as well as belonging, leadership and identity formation that participating in sports can offer. Transgender people participate in sports for the same reasons everyone else does, and no evidence supports the claim that excluding some from participating in school sponsored sports protects women or youth. Even the bill's sponsors cannot cite an example in Colorado of when transgender athletes have posed a problem. If the bill were intended to protect the rights of some student athletes, it would be ill-conceived, as it seeks to solve a problem that is imagined only, but in fact it is disingenuous it is mean-spirited, politically-motivated discrimination against a vulnerable population masquerading as compassion. I am strongly opposed to **Against** legislation changing to force teams to divide based on biological sex because it would both be harmful to the players and sports and their themself environment as a whole as well as not beneficial for anyone As a nonconforming player, I'm given the chance and opportunity to play on teams and with people that I couldn't if only based on my assigned sex at birth. This is something that, as my community supports me and is accepting of whichever team I chose to play on, allows me to be comfortable while on the fields and enjoy the games. But if this new legislation passes, not only would that option for me, other people on my team and who I know on other teams and a large section of athletes as a whole would be forced into an uncomfortable and even unsafe position. This legislation, despite being pushed as something to help people be safer on the field and on the team would forcefully out a vast number of athletes, and while I know my team would likely be accepting, others would not be. My name is Megan Burch, I am a resident of HD-39, and I am opposed to this legislation, "Women's Rights in Athletics." I am one of Rep. Bradley's constituents, and I want you to know that this bill does NOT represent our community or our interests. It is discouraging to be represented by an individual that plays into hateful anti-LGTBQ+ rhetoric, especially when living in close proximity to a mass shooting that targeted LGTBQ+ people less than three months ago.

This bill guised as "women's rights" is really about bigotry and hatred against the trans community. The implication of this legislation is that there is some "agenda" of trans children taking over sports and that including them would "create harm" to other children. This is absolutely false and firmly rooted in bigotry.

Legislation like this is fueled by a national agenda of hatred and bigotry against the LGBTQ+ community, and has dire consequences, as we know from the Club Q shooting and the additional nationwide threats against LGBTQ+ community spaces. While the rhetoric seems to be effective in garnering political points with extremists and donations for anti-LGBTQ+ legislators, it fuels the hatred and bigotry that leads to violence.

Additionally, legislation like this targeting the trans community has consequences that are widespread. For example, we just saw an attempt to track the menstruation of female athletes in Florida, a consequence that was a result of Florida's own anti-trans sports bills. That effort was struck down.

Unfortunately, sponsoring this legislation is not the first time that Rep. Bradley has protested the right of the LGBTQ+ community to gather in community and have fun. In 2022, she attended a protest against a drag show in Highlands Ranch, and additionally sent a formal letter of opposition to the event as a candidate running for HD-39 to the Highlands Ranch Community Association. Rep. Frizell, another sponsor of this legislation, also signed off on that letter.

Please see this legislation for what it really is, the use of the government to attack trans people and restrict the right of trans children to play, have fun, and be in community with other children.

Please vote no on this legislation. Please vote no and firmly reject extremism in Colorado. A full 11-0 vote will demonstrate a strong stance against hatred and bigotry in Colorado.

This bill is an insult to women's rights by reducing women to their reproductive organs. Excluding trans women from women's sports is not protecting women. If anything, such laws endanger women regardless of their sex assigned at birth. Laws such as this one often subject women (both cis and trans) to invasive genital examinations and/or blood testing.

The premise of this bill is also insulting to women since it is predicated on the assumption that women are weak, whereas actual science shows there is far more variation among women and among men than there is between the average woman and the average man. There are also countless ways in which people differ in athletic ability due to physical traits (e.g., height, weight, body proportions), and we do separate people based on these characteristics.

Finally, this bill fails to consider trans men in sports. Such men, likely thought of as "women" by the writers and sponsors of the bill, often take testosterone. Their assigned sex at birth would have them to participate in women's/girl's sports, but these teams are typically subject to testosterone limits. Thus this ban effectively prevents trans men from participating in competitive sports altogether.

Not only is this bill poorly reasoned and written, it endangers the same women it purports to protect. It is a blatant attempt to gatekeeper womanhood, attack trans women, and earn "culture war" points from right wing extremists. Politicians need to mind their own genitals.

My testimony:

As a Coloradan, mom, athlete and sports coach, I am disappointed at the presentation of this bill for several reasons, oppose it, and urge you to vote no. The headline grabbing bill title is erroneous. This bill will not protect women in sports. In fact, it will harm women and girls sports and put both those designated female at birth and those not designated female at birth at risk.

This bill actually violates Title IX, which guarantees EQUAL educational opportunities (including sporting) to all, including our LGBTQIA students and athletes. And most of us could not agree more that Title IX has grown the opportunities for women in sport. Sport is a human right, and one our trans students deserve. Trans athletes have been able to compete at the highest levels, the Olympics, for decades. And in over 21 years, only two trans athletes become Olympians and only one competed.

In states where anti trans sports bills have passed, such as Idaho and Florida, the enforcement of these bills has led to period reporting for teen female athletes, as well as genital inspection of a young female athlete, who was born female at birth, simply because a parent challenged whether she was actually female because she was good at her sport. We have a

hard enough time keeping young women and girls in sport and this will only lead to more leaving sports.

And if these aspects don't seem disturbing enough, as a taxpayer, I am disappointed that we are wasting time and resources on a bill that is not an issue. Utah passed such a bill despite the governor's veto. In his letter vetoing the bill, the governor pointed out not only how punitive it was against the trans community, but how much resource was wasted to legislate the issue when there were TWO known trans youth athletes in the state, and only one was a trans female. In Michigan, out of 180,000 youth athletes, only 4 were trans and one trans female competing. Before this bill leaves committee, I would ask if this is an actual issue Coloradans are facing and if they wish to override federal law to regulate women's sports.

The Colorado Education Association strongly opposes HB 23-1098 and asks the House State, Civic, Military & Veteran Affairs Committee to please vote no on this bill.

Proactive inclusion of all genders, ethnicities, sexualities and lifestyles is critical to the mental health and happiness of our students and educators. In 2022, CEA surveyed Colorado educators to get a better grasp on the education landscape for LGBTQ+ educators and students. The report found that the majority of LGBTQ+ educators work in school environments where they feel neither safe nor supported.

The bill requires that any interscholastic, intramural, or club athletic team, sport, or athletic event sponsored by a public school or district, an activities association, or a state supported institution of higher education only allow student to participate in extracurricular sport team if their expressed sex matches their biological sex at birth. HB 23-1098 is a solution in search of a problem and will undoubtedly exacerbate LGBTQ+ students and staff feeling unsafe at school. This is an inappropriate intrusion into an individual student's privacy and will do irreparable harm to all trans people in Colorado.

In order for our students and educators to thrive, it's critical that pro-active inclusion policies are enacted. According to GLSEN's National School Climate Survey, students with an inclusive curriculum have better academic and mental health outcomes, and are less likely to miss school.
