Committee on Judiciary.

HB23-1178 be amended as follows:

1 Amend printed bill, page 9, line 24, after "(7)" insert "(a)".

2 Page 10, after line 1 insert:

3           "(b) (I) SUBSECTIONS (1), (2)(a), (2)(b), (2)(c), (2)(e), (3), (5), AND  
4 (6) OF THIS SECTION TAKE EFFECT AT 12:01 A.M. THIRTY DAYS AFTER THE  
5 DATE IDENTIFIED IN THE WRITTEN NOTICE PROVIDED TO THE REVISOR OF  
6 STATUTES BY THE STATE COURT ADMINISTRATOR THAT THE JUDICIAL  
7 BRANCH HAS BEEN AWARDED A GRANT INCREASE PURSUANT TO THE  
8 FEDERAL "KEEPING CHILDREN SAFE FROM FAMILY VIOLENCE ACT", 34  
9 U.S.C. SEC. 10446, AS AMENDED, OR ON THE DATE OF THE NOTICE TO THE  
10 REVISOR OF STATUTES IF THE NOTICE DOES NOT SPECIFY A DIFFERENT  
11 DATE.

12           (II) THE STATE COURT ADMINISTRATOR SHALL NOTIFY THE  
13 REVISOR OF STATUTES IN WRITING WHEN THE CONDITION SPECIFIED IN  
14 (7)(b)(I) OF THIS SECTION HAS OCCURRED BY EMAILING THE NOTICE TO  
15 REVISOROFSTATUTES.GA@COLEG.GOV."

16 Page 11, strike lines 22 through 26 and substitute:

17           "**SECTION 4. Effective date.** (1) Except as otherwise provided  
18 in subsection (2) and (3) of this section, this act takes effect upon passage.

19           (2) Section 14-10-127.5 (2)(d) and (4), Colorado Revised Statutes,  
20 as enacted in section 1 of this act, take effect only if House Bill 23-1108  
21 becomes law, in which case section 24-10-127.5 (2)(d) and (4) take effect  
22 on the effective date of this act or House Bill 23-1108, whichever is later.

23           (3) Section 14-10-127.5 (1), (2)(a), (2)(b), (2)(c), (2)(e), (3), (5),  
24 and (6), Colorado Revised Statutes, and section 2 and 3 of this act take  
25 effect only if the federal department of justice's office of the attorney  
26 general awards a grant increase pursuant to the federal "Keeping Children  
27 Safe From Family Violence Act", 34 U.S.C. sec. 10446, as amended, and  
28 take effect thirty days after the date identified in the written notice from  
29 the state court administrator to the revisor of statutes, as required in  
30 section 1 of this act, that the judicial branch has been awarded a grant  
31 increase or, if the notice does not specify that date, on the date of the  
32 notice to the revisor of statutes, or on the effective date of this act,  
33 whichever is later."
