SB23-053 be amended as follows:

- 1 Amend printed bill, page 3, line 21, strike "employment or in".
- 2 Page 3, strike line 22 and substitute "employment; and".
- 3 Page 4, strike lines 9 through 12 and substitute "being hired. The general
4 assembly intends that, absent the".
- 5 Page 5 line 22, strike "SETTLEMENT AGREEMENT" and substitute "OTHER
6 AGREEMENT THAT AN EMPLOYEE MUST AGREE TO AS A CONDITION OF
7 EMPLOYMENT".
- 8 Page 6, line 5, after the second "ANY" insert "SUCH".
- 9 Page 7, line 1, after the period add "HOWEVER, NOTHING IN THIS SECTION
10 PROHIBITS AN EMPLOYER AND AN EMPLOYEE FROM VOLUNTARILY
11 ENTERING INTO A NONDISCLOSURE AGREEMENT UPON THE EMPLOYEE'S
12 SEPARATION FROM EMPLOYMENT WITH THE EMPLOYER.".
- 13 Page 8, line 3, strike "SETTLEMENT AGREEMENT" and substitute "OTHER
14 AGREEMENT THAT AN EMPLOYEE MUST AGREE TO AS A CONDITION OF
15 EMPLOYMENT".
- 16 Page 8, line 9, after the second "ANY" insert "SUCH".
- 17 Page 9, line 3, after the period add "HOWEVER, NOTHING IN THIS SECTION
18 PROHIBITS AN EMPLOYER AND AN EMPLOYEE FROM VOLUNTARILY
19 ENTERING INTO A NONDISCLOSURE AGREEMENT UPON THE EMPLOYEE'S
20 SEPARATION FROM EMPLOYMENT WITH THE EMPLOYER.".
- 21 Page 10, line 13, strike "SETTLEMENT AGREEMENT" and substitute "OTHER
22 AGREEMENT THAT AN EMPLOYEE MUST AGREE TO AS A CONDITION OF
23 EMPLOYMENT".
- 24 Page 10, line 20, after the second "ANY" insert "SUCH".
- 25 Page 11, line 15, after the period add "HOWEVER, NOTHING IN THIS
26 SECTION PROHIBITS AN EMPLOYER AND AN EMPLOYEE FROM VOLUNTARILY
27 ENTERING INTO A NONDISCLOSURE AGREEMENT UPON THE EMPLOYEE'S
28 SEPARATION FROM EMPLOYMENT WITH THE EMPLOYER.".
