HB23-1071 be amended as follows:

- 13 Renumber succeeding subsections accordingly.
  
- 14 Page 5, strike lines 5 through 9.
  
- 15 Renumber succeeding subsection accordingly.
  
- 16 Page 7, line 26, strike "(2)(a)(IV)(B) OF THIS SECTION" and substitute
- 17 "(2)(a)(IV)(A) OF THIS SECTION,".
  
- 18 Page 8, line 5, strike "(2)(a)(IV)(B)" and substitute "(2)(a)(IV)(A)".
  
- 19 Page 10, lines 14 and 15, strike "OR THE LICENSED PSYCHOLOGIST WITH
- 20 A CONDITIONAL PRESCRIPTION CERTIFICATE".
  
- 21 Strike "OR A LICENSED PSYCHOLOGIST WITH A CONDITIONAL PRESCRIPTION
- 22 CERTIFICATE" on: **Page 10**, lines 22 and 23; **Page 11**, lines 12 and 13; and
- 23 **Page 13**, lines 7 and 8.
  
- 24 Strike "OR LICENSED PSYCHOLOGIST WITH A CONDITIONAL PRESCRIPTION
- 25 CERTIFICATE" on: **Page 11**, lines 3 and 4, and 18 and 19; and **Page 12**,
- 26 lines 3 and 4, 8 and 9, 17 and 18, and 25 and 26.
