10	LICENSURE, AS A TEACHER IN ANOTHER STATE AND WHO HAS NOT
11	SUCCESSFULLY COMPLETED THE ASSESSMENT OF PROFESSIONAL COMPETENCIES
12	TO OBTAIN AN INITIAL LICENSE UNDER SECTION 22-60.5-201 (1)(B) BUT WHO
13	MEETS THE OTHER REQUIREMENTS FOR AN INITIAL LICENSE SPECIFIED IN SAID
14	SECTIONS; AND
15	(B) IS A MILITARY SPOUSE.

21	(III) THE COLORADO BUREAU OF INVESTIGATION SHALL RETURN THE
22	RESULTS OF EACH FINGERPRINT-BASED CRIMINAL HISTORY RECORD CHECK
23	SUBMITTED PURSUANT TO THIS SECTION TO THE DEPARTMENT OF EDUCATION NO
24	LATER THAN SIXTY DAYS FOLLOWING RECEIPT OF THE REQUEST.

32	COLORADO, IS DOMICILED IN COLORADO, OR HAS MOVED TO COLORADO ON A
33	PERMANENT CHANGE-OF-STATION BASIS.".
