The adverse events seem to increase from ages 18-65 with a peak at ages 31-50 which represents your employed/working population. This is comparable to what insurance companies are now reporting globally for death rates; death rates that have increased by 40% since the vaccine rollout.

"And what we saw just in the third quarter—we're seeing it continue into the fourth quarter—is that **death rates are up 40 percent over what they were pre-pandemic**. Just to give you an idea of how bad that is, a three-sigma or a one-in-200-year catastrophe would be a 10 percent increase over pre-pandemic. So 40 percent is just unheard of."

This 40 percent figure doesn't represent folks dying of old age, but is instead a reflection of deaths in working-age adults, aged 18 to 65. However, what's responsible for the alarming spike in fatalities in this age group isn't clear.
