Committee on Business Affairs & Labor.

HB22-1314 be amended as follows:

1 Amend printed bill, page 7, line 13, strike "(1) Whenever an" and
2 substitute "(1) (a) ~~Whenever~~ IN ACCORDANCE WITH THE ATTACHMENT
3 SCHEDULE IN SUBSECTION (1)(b) OF THIS SECTION, an".

4 Page 7, strike lines 17 through 19 and substitute "authorized person in
5 control of ~~such~~ THE motor vehicle, or from the owner or lessee of real
6 property upon which a motor vehicle is illegally parked or ~~such~~
7 ABANDONED OR THE owner's or lessee's agent authorized in writing, ~~such~~
8 THE".

9 Page 7, after line 27 insert:

10 "(b) THE LIEN GRANTED IN SUBSECTION (1)(a) OF THIS SECTION
11 ATTACHES TO THE MOTOR VEHICLE IN ACCORDANCE WITH THE FOLLOWING
12 SCHEDULE:

13 (I) IF THE OPERATOR RECOVERED, REMOVED, OR STORED THE
14 MOTOR VEHICLE UPON INSTRUCTIONS FROM THE OWNER OF RECORD OR
15 ANY OTHER LEGALLY AUTHORIZED PERSON IN CONTROL OF THE MOTOR
16 VEHICLE, THE LIEN ATTACHES TO THE MOTOR VEHICLE WHEN THE
17 OPERATOR TAKES POSSESSION OF THE MOTOR VEHICLE; OR

18 (II) IF THE OPERATOR RECOVERED, REMOVED, OR STORED THE
19 MOTOR VEHICLE UPON INSTRUCTIONS OF THE OWNER OR LESSEE OF REAL
20 PROPERTY UPON WHICH A MOTOR VEHICLE WAS ILLEGALLY PARKED OR
21 ABANDONED OR UPON THE OWNER'S OR LESSEE'S AGENT AUTHORIZED IN
22 WRITING, THE LIEN ATTACHES TO THE MOTOR VEHICLE THIRTY DAYS AFTER
23 THE POSTMARKED DATE THE NOTICE WAS MAILED IN ACCORDANCE WITH
24 SECTION 42-4-2103 (4) OR THE DATE THE OPERATOR RECEIVED NOTICE
25 THAT NO RECORD EXISTS FOR THE MOTOR VEHICLE."

26 Page 8, line 15, after "~~such~~" insert "THE LIEN IS NOT PERFECTED UNTIL
27 THE LIEN ATTACHES IN ACCORDANCE WITH THE SCHEDULE DESCRIBED IN
28 SECTION 42-4-2105 (1)(b)."

29 Page 20, line 4, strike "THE VEHICLE OR".

30 Page 20, line 8, strike "CONSENT," and substitute "CONSENT WITHIN
31 THIRTY DAYS AFTER THE POSTMARKED DATE THE NOTICE WAS MAILED IN
32 ACCORDANCE WITH SECTION 42-4-2103 (4) OR THE DATE THE OPERATOR
33 RECEIVED NOTICE THAT NO RECORD EXISTS FOR THE MOTOR VEHICLE,".

34 Page 28, line 7, strike "A VEHICLE OR".
