HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public & Behavioral Health & Human Services.

HB23-1243 be amended as follows:

- 1 Amend printed bill, page 12, line 5, strike "**compliance.**" and substitute
- 2 "**compliance - rules.**".

- 3 Page 12, line 7, strike "MATERIAL".

- 4 Page 12, line 14, strike "EXCEPT AS PROVIDED FOR IN".

- 5 Page 12, line 15, strike "SUBSECTION (1)(b) OF THIS SECTION, IF" and
- 6 substitute:
- 7 "(b) IF".

- 8 Page 12, line 16, strike "THE".

- 9 Page 12, strike lines 17 through 20.

- 10 Page 12, line 21, strike "(b) If" and substitute "OR IF".

- 11 Page 12, line 25, strike "AMOUNT OF NOT MORE THAN TWENTY" and
- 12 substitute "AMOUNT."

- 13 Page 12, strike line 26 and 27.

- 14 Page 13, strike line 1 and substitute "FOR A REPORTING HOSPITAL OWNED
- 15 BY OR AFFILIATED WITH A HOSPITAL SYSTEM COMPRISED OF THREE OR
- 16 MORE HOSPITALS, THE FINE MUST BE NOT MORE THAN TWENTY THOUSAND
- 17 DOLLARS PER WEEK PER VIOLATION. FOR ALL OTHER REPORTING
- 18 HOSPITALS, THE FINE MUST BE NOT MORE THAN FIVE THOUSAND DOLLARS
- 19 PER WEEK PER VIOLATION.
- 20 (2) REPORTING HOSPITALS SHALL EXPEND THE AMOUNT FINED
- 21 PURSUANT TO SUBSECTION (1)(b) OF THIS SECTION ON COMMUNITY
- 22 BENEFIT INVESTMENT PRIORITIES DESCRIBED IN THE HOSPITAL'S CURRENT
- 23 COMMUNITY BENEFIT IMPLEMENTATION PLAN WITHIN ONE YEAR AFTER
- 24 THE FINE IS IMPOSED. EACH REPORTING HOSPITAL SHALL REPORT ON HOW
- 25 THE MONEY COLLECTED THROUGH FINES IS EXPENDED IN THE REPORTING
- 26 HOSPITAL'S ANNUAL REPORT TO THE STATE DEPARTMENT PURSUANT TO
- 27 SECTION 25.5-1-703.
- 28 (3) THE STATE BOARD SHALL PROMULGATE ANY RULES NECESSARY
- 29 FOR THE IMPLEMENTATION OF THIS SECTION."
