During the SMART hearings in 2017, the folks that do the Guardian Ad Litum testified that they have limited full time employees (12) and they contract with many attorneys and social workers during the year. 40% of their time is used to monitor the folks they contract with to make certain their clients are being represented effectively and fairly.

The SOMB lists treatment providers, polygraph examiners and evaluators based on defined educational and experience criteria. Importance should be placed on the SOMB to not only accurately list these folks but expand their responsibility to monitor them for adherence to statute, best practices, professionalism, ethical standards and effective job performance.

An individual on probation or parole and in treatment can file a complaint with the SOMB and/or DORA but the reality is, they don't because of retribution. The retribution can be everything from loss of privileges, safety plans being pulled, extra classes or groups, possible house arrest, revocation and maybe going back to prison. Since there is no monitoring of the providers by the SOMB, filing a complaint is the only monitoring that is done. Consequently, implementing effective change and correcting appropriate problems doesn't happen because most won't file a complaint. Changes that are progressive, benefit the human condition and adhere to the intent of the legislature aren't happening.

I would suggest each of you reach out and talk to folks that are in treatment and ask them how they feel about filing any complaint. Get it from the horse's mouth, so to speak. They may even have suggestions on how to improve things because of their knowledge and experience. They need to be represented also.

How effective have the treatment providers been in changing their programs from the "No Known Cure" model to the RNR (Risk, Need, Responsivity) model or another evidence based correctional model as written in HB16-1345? Has the SOMB sent out questionnaires asking how providers have changed their programs to comply with statute? This bill was signed 8/10/2016. If you want to get perspective on what is happening at street level, ask the guys in treatment.

The SOMB noted in its 2019 Annual Legislative Report that it had only conducted three Standards Compliance Reviews in 2018. This is noted on page 6 and page 37. On page 34 of the report the SOMB notes there are a total of 309 adult providers and 230 juvenile providers.

The report states that data collection is to start June, 2019. HB16-1345, requiring the data collection, went into effect on August 10, 2016. Did any of the the SOMB board members question the SOMB staff about the lack of timeliness for data collection? If not, perhaps a change in the makeup or responsibilities of the board is due. Standardization perpetuates mediocrity.

- 1) The general assembly finds that, to protect the public and to work toward the elimination of sexual offenses, it is necessary to comprehensively evaluate, identify, treat, manage, and monitor adult sex offenders who are subject to the supervision of the criminal justice system and juveniles who have committed sexual offenses who are subject to the supervision of the juvenile justice system.
- (2) Therefore, the general assembly declares that it is necessary to create a program that establishes evidence-based standards for the evaluation, identification, treatment, management, and monitoring of adult sex offenders and juveniles who have committed sexual offenses at each stage of the criminal or juvenile justice system...

§ 16-11.7-101, C.R.S.

But this definition is ESSENTIAL to properly read the rest of the SOMB statutes:

- (4) "Treatment" means therapy, monitoring, and supervision of any sex offender which conforms to the standards created by the board pursuant to section 16-11.7-103.
- § 16-11.7-102, C.R.S.
- (b) Guidelines and standards for treatment of adult offenders. (I) The board shall develop, implement, and revise, as appropriate, guidelines and standards to treat adult sex offenders, including adult sex offenders with intellectual and developmental disabilities, incorporating in the guidelines and standards the concepts of the risk-need-responsivity or another evidence-based correctional model, which guidelines and standards can be used in the treatment of offenders who are placed on probation, incarcerated with the department of corrections, placed on parole, or placed in community corrections. ...
- § 16-11.7-103(4), C.R.S.
- (II) The board, in collaboration with the department of corrections, the judicial department, and the state board of parole, shall establish standards for community entities that provide supervision and treatment specifically designed for adult sex offenders who have developmental disabilities. At a minimum, the standards shall determine whether an entity would provide adequate support and supervision to minimize any threat that the adult sex offender may pose to the community.
- § 16-11.7-103(4)(f), C.R.S.
- (j)(I) Guidelines and standards for treatment of juvenile offenders. The board shall develop, implement, and revise, as appropriate, guidelines and standards to treat juveniles who have committed sexual offenses, including juveniles with intellectual and developmental disabilities, incorporating in the guidelines and standards the concepts of the risk-need-responsivity or another evidence-based correctional model, which guidelines and standards may be used for juvenile offenders who are placed on probation, committed to the department of human services, placed on parole, or placed in out-of-home placement. ...
- § 16-11.7-103, C.R.S.
- (k) Evaluation of policies and procedures for juvenile offenders. The board shall research and analyze the effectiveness of the evaluation, identification, and treatment procedures developed pursuant to this article for juveniles who have committed sexual offenses. The board shall revise the guidelines and standards for evaluation, identification, and treatment, as appropriate, based upon the results of the board's research and analysis. The board shall also develop and prescribe a system to implement the guidelines and standards developed pursuant to paragraph (j) of this subsection (4). § 16-11.7-103, C.R.S.
