SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB23-039 be amended as follows:

- 1 Amend printed bill, page 15, line 17, strike "SHALL" and substitute  
2 "SHALL, WHEN POSSIBLE,".
- 3 Page 16, line 2, strike "TECHNOLOGY." and substitute "TECHNOLOGY, SO  
4 LONG AS THE REQUIREMENTS PURSUANT TO SECTION 19-3-502 (5.5)(b)(I)  
5 ARE SATISFIED.".
- 6 Page 16, line 16, strike "PARENT'S CASE MANAGER AT THE FACILITY" and  
7 substitute "DESIGNATED INDIVIDUAL WITHIN THE LEGAL SERVICES UNIT".
- 8 Page 16, line 19, strike "DEVELOP" and substitute "ENSURE CHILDREN AND  
9 PARENTS HAVE ACCESS TO".
- 10 Page 16, strike lines 21 through 23 and substitute "PARENTS WHO ARE  
11 INCARCERATED, REGARDLESS OF WHETHER THEY ARE A RESPONDENT IN A  
12 DEPENDENCY AND NEGLECT PROCEEDING. THE OPPORTUNITIES MUST  
13 INCLUDE:".
- 14 Page 16, line 24, strike "REGULARLY SCHEDULED EVENTS" and substitute  
15 "EVENTS".
- 16 Page 17, strike lines 7 and 8 and substitute "INDIVIDUAL WITHIN THE  
17 LEGAL SERVICES UNIT TO ASSIST IN FAMILY SERVICES COORDINATION. THE  
18 INDIVIDUAL'S DUTIES".
- 19 Page 18, strike line 12 and substitute:
- 20 "(6) THE DEPARTMENT SHALL ENSURE THAT DEPARTMENTAL  
21 POLICIES:".
- 22 Page 18, line 16, strike "DEPARTMENT." and substitute "DEPARTMENT,  
23 REGARDLESS OF WHETHER THEY ARE A RESPONDENT IN A DEPENDENCY  
24 AND NEGLECT PROCEEDING.".
- 25 Page 18, strike line 27 and substitute "PARENT, WHEN APPROPRIATE. THE  
26 POLICIES MUST PRIORITIZE ACCESS TO SERVICES PROVIDED BY THE  
27 DEPARTMENT FOR PARENTS WITH OPEN DEPENDENCY AND NEGLECT  
28 CASES.".
