SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

SB23-069 be amended as follows:

- 1 Amend printed bill, page 2, strike line 5 and and substitute "(1) No person
2 under ~~sixteen~~ FOURTEEN years of age SHALL OPERATE A MOTORBOAT IN
3 THIS STATE. AN INDIVIDUAL BORN ON OR AFTER "
- 4 Page 2, lines 6 and 7, strike "OR AN INDIVIDUAL WHO IS UNDER SIXTEEN
5 YEARS OF AGE".
- 6 Page 2, line 10, after "BORN" insert "ON OR".
- 7 Page 2, lines 11 and 12, strike "INDIVIDUAL IS AT LEAST SIXTEEN YEARS
8 OF AGE AND:" and substitute "INDIVIDUAL:".
- 9 Page 2, line 14, strike "wildlife;" and substitute "wildlife OR COMPLETES
10 A BOATING SAFETY COURSE IN ANOTHER JURISDICTION THAT MEETS THE
11 COMMISSION'S REQUIREMENTS AS SET FORTH BY RULE;".
- 12 Page 3, strike lines 5 and 6, and substitute "~~age~~ AN INDIVIDUAL BORN ON
13 OR AFTER JANUARY 1, 1984; except that ~~a person fourteen years~~".
- 14 Page 3, strike lines 8 and 9 and substitute "INDIVIDUAL BORN ON OR AFTER
15 JANUARY 1, 1984, may be permitted or authorized to operate a motorboat
16 if".
- 17 Page 3, strike lines 12 through 21, and substitute "(4) (a) ~~No owner or
18 operator of a vessel livery or an agent or employee of such owner or operator
19 shall lease, hire, or rent a motorboat to or for operation by any person under
20 sixteen years of age; except that a person fourteen years of age or older who has
21 not reached his or her sixteenth birthday may be permitted or authorized to
22 operate a motorboat if he or she has met the boating safety and certificate
23 requirements of subsection (2) of this section~~ THE PROVISIONS OF THIS
24 SECTION APPLY TO ALL MOTORBOAT OPERATORS, INCLUDING
25 OWNER-OPERATED MOTORBOATS, INDIVIDUALS OPERATING A MOTORBOAT
26 WITH THE MOTORBOAT OWNER PRESENT, AND INDIVIDUALS RENTING A
27 MOTORBOAT.
- 28 (b) THE COMMISSION MAY PROMULGATE RULES ESTABLISHING
29 REQUIREMENTS AND QUALIFICATIONS FOR THE RENTAL OF MOTORBOATS."
