



### THE SYSTEM IS FAILING **Outcomes for Foster Youth**



From 2012-2021, 13% of adoptions in CO failed.



The four-year graduation rate for CO youth is 82%, but for youth in foster care, this rate drops to 30%.

Up to 80% of children in foster care have significant mental health issues, compared to approximately 18-22% of the general population.
