## Review of Committee's Work<sup>3</sup>

The committee met twice during the 2022 legislative session. The members considered 12 bills and 10 were approved for introduction, passed by the General Assembly, and signed into law by Governor Polis.

## Descriptions of Bills Approved for Introduction

### [H.B. 22-1250](#) – *Recommended by: Colorado Bar Association*

The bill makes nonsubstantive changes in title 7, C.R.S., including: revising references from "owners' interest" to "owner's interest." For detailed descriptions of the changes, see the memo presented at the February 11, 2022, meeting [here](#).

### [H.B. 22-1264](#) – *Recommended by: Office of Legislative Legal Services*

The bill update references to "food and drug administration" in article 16 of title 10, C.R.S., to use the defined term "FDA."

**[H.B. 22-1307](#) – *Recommended by: Office of Legislative Legal Services***

The bill updates and makes technical changes to the practice acts regulating mental health professionals. For detailed descriptions of the changes, see the memo presented at the March 11, 2022, meeting [here](#).

**[H.B. 22-1311](#) – *Recommended by: Department of Revenue***

The definitions for the excise tax on gasoline and special fuel created in article 27 of title 39, C.R.S., are set forth in section 39-27-101, C.R.S. In 2021, the Colorado General Assembly enacted [H.B. 21-1322](#) to restructure the gasoline and special fuel tax, and that legislation included two errors in the definitions:

- The definition of "bulk transfer and terminal system" unintentionally omitted a reference to "special fuel" in one portion of the definition, creating an inconsistency in the treatment of gasoline and special fuel in one instance; and
- In relocating a type of aircraft fuel from the definition of "gasoline" to a tax exemption provision, a type of aircraft fuel that continues to be subject to a type of gasoline tax was removed from the bill.

**[H.B. 22-1312](#) – *Recommended by: Department of Revenue***

The bill corrects defects and anachronisms identified by the Department of Revenue in Article 26 of title 39, C.R.S., which sets forth the sales tax statutes. For detailed descriptions of the changes, see the memo presented at the March 11, 2022, meeting [here](#).

**[S.B. 22-141](#) – *Recommended by: Office of Legislative Legal Services***

The bill makes various technical changes in title 43, C.R.S.

**[S.B. 22-142](#) – *Recommended by: Department of Regulatory Agencies***

The bill repeals the Colorado municipal bond supervision advisory board, as it no longer meets or performs its duties and is now obsolete.

**[S.B. 22-143](#) – *Recommended by: Office of Legislative Legal Services***

The bill updates references to "licensing board" in section 12-30-114, C.R.S., to use the defined term "regulator."

**S.B. 22-162** – *Recommended by: Office of Legislative Legal Services*

The bill modernizes the terminology used in the Colorado Revised Statutes relating to the organization of Colorado state governmental agencies without altering the status of the powers assigned to those agencies pursuant to the "Administrative Organization Act of 1968."

**S.B. 22-164** – *Recommended by: Office of Legislative Legal Services*

The bill corrects an incorrect statutory reference to county "assessor's" made in section 38-35.7-110 (2)(e), C.R.S., by substituting the word "treasurer's" in its place.
