

OCR ATTORNEYS

OCR contracts with approximately 270 attorneys covering all 22 Judicial Districts

- GAL or CFY is appointed for every child or youth named in a D&N case in Colorado.
- CFY is appointed for every youth in a Foster Youth in Transition Program Case.
- GALS are appointed at the discretion of the court in Juvenile Delinquency, Truancy, Paternity, Probate, Adoption, Mental Health, and Domestic Relations matters.
- GALS may also be appointed for a victim or witness.
- GALS are appointed for every youth 16 or 17 years old seeking a marriage license.

OCR establishes attorney practice standards and provides itigation support, accessible high-quality statewide training, and oversight of the practice


Goal 3

GOAL 1: PROVIDE CHILDREN A VOICE IN THE COLORADO LEGAL SYSTEM THROUGH EFFECTIVE AND EFFICIENT ATTORNEY SERVICES AND ADVOCACY.

In FY22 the OCR:

- Conducted 193 references interviews (62 from youth).
- 214 court observations.
- In FY22, 95% of initial 30day visits with youth were completed.
- Received 239 judicial stakeholder surveys and 140 youth surveys.
- Attended or sponsored 12 youth events.



2009 to 2014 \$65


2015 to July 1, 2018 \$75




