To manage and conserve Colorado's natural resources for the benefit and enjoyment of people today and tomorrow.


DNR's vision:


# Division of Reclamation, Mining & Safety

The Division of Reclamation, Mining and Safety's mission is to return Colorado's mined lands to a beneficial use. The Mined Land Reclamation Board is the Regulatory Authority under statute.

The Active Mines Program consists of the Coal Program and Minerals Program that have oversight of all active mining in the state since 1976. Staff conducts inspections on a regular basis, initiates enforcement, and reviews all permitting actions. Minimizing environmental impacts is a key component of permitting and this includes water quality, heavy metal monitoring, and revegetation. Staff ensures there are adequate funds for reclamation of disturbed lands if an operator fails to reclaim.

**The Inactive Mines Program** has oversight of pre-1977 mining disturbances and any revoked permits from the Active Mines Program. The Program completes safety closures on hazardous mine features, monitors and mitigates historic coal mine fires, and conducts reclamation projects on legacy mine sites.

# Division of Reclamation, Mining & Safety

### Active Mines: Mineral Program - 2023

- 1368 permitted mine sites
  - (1142 Construction Materials, 110 Hard Rock, 116 Prospecting)
- 194,230 permitted acres, 2,668 acres reclaimed and released
- Holds \$535.3 million in financial warranties for reclamation

### Active Mines: Coal Program - 2023

- 6 actively producing sites, 20 sites in reclamation
- 162,693 permitted acres, 37 reclaimed and released
- Holds \$247 million in financial warranties for reclamation

### Inactive Active Mines - 2023

- Safeguarded 353 hazardous mine features
- Injected \$7.3M into local economies for abandoned mine reclamation
- Recent infrastructure funding is focused on addressing Colorado's highest priority coal mine fire sites

## Colorado Parks and Wildlife

CPW's mission is to perpetuate the wildlife resources of the state, to provide a quality state parks system, and to provide enjoyable and sustainable outdoor recreation opportunities that educate and inspire current and future generations to serve as active stewards of Colorado's natural resources.

#### 2023 Accomplishments

- Introduced the \$29 Keep Colorado Wild Pass
- Completed, with partners, the acquisition of Mt Tom
- Celebrated 10 years of efforts to reintroduce Black Footed Ferrets
- Parks and Wildlife Commission approves final Wolf Reintroduction Plan
- Completed year two of the Aquatic Nuisance Species roadside inspection pilot program
- Trail to the summit opens at Fishers Peak
- First successful reintroduction of Gray wolves to implement Proposition 114
- Human and Bear conflict grant program grants \$1 million to reduce conflict
- Motorized Trails grants \$6.24 million to expand and maintain recreation opportunities
- Partnered with Colorado Youth Core to perform \$519,000 of OHV trail work
- Colorado Outdoor Regional Partnerships grows to \$3 million
- Outdoor Equity Grant Program awards \$2.2 million for youth outdoor programing





## State Board of Land Commissioners

### An innovative land trust funding Colorado schools since 1876

**Mission**: manage an endowment of assets held in perpetual, intergenerational public trusts for the financial support of Colorado's public schools and other public institutions to generate reasonable and consistent income over time by protecting and enhancing the long-term productivity and sound stewardship of working trust lands.

- Created by Constitution Article IX
- 2.8m acres of land and 4m acres of subsurface minerals
- Working lands leased for agriculture, oil & gas, recreation, renewable energy, commercial buildings, ecosystem services
- No General Fund support; 44 FTE

## State Board of Land Commissioners

# Energy & Carbon Management Commission

As a result of SB 23-016 & SB 23-285, the Division became the Colorado Energy & Carbon Management Commission (ECMC) with increased regulatory oversight on July 1, 2023.

**ECMC Mission:** To regulate the development and production of oil & gas, deep geothermal resources, the capture and sequestration of carbon, and the underground storage of natural gas in a manner that protects public health, safety, welfare, wildlife resources and the environment.





# Stimulus Funds

The Department has been appropriated stimulus funds in the following categories:

- Wildfire Mitigation: \$19.5M total for the Colorado Strategic Wildfire Action Program (COSWAP). An additional \$16.5M one-time funds for wildfire mitigation at the Colorado State Forest Service (CSFS).
- Water: \$85M total for groundwater sustainability efforts, state water plan projects, and technical assistance for federal grants.
- Watershed Restoration: \$44M total for post-fire watershed restoration efforts and CWCB's new Wildfire Ready Watersheds initiative.
- **Parks, Wildlife, and Recreation:** \$42.8M total for staff, operating, and capital projects at state parks, implementation of the State Wildlife Action Plan, and backcountry avalanche safety.

# Outdoor Equity Grant Program - An Update

Since its inception the Outdoor Equity Grant Program:

- Over 37,000 participants have been reached
- \$5 million has been awarded to 92 organizations to increase access to the outdoors

In calendar year 2023, demographics of participants reached were:

- 83% youth under 25, 17% adults
- 29% of participants were disabled
- Ethnic makeup of participants: 25% Hispanic or Latino, 17% White (not Hispanic/Latino), 7% Black or African American, 2% American Indian and Alaska Native, 6% Multiracial, 1% Asian American or Pacific Islander, 42% Unknown





# Keep Colorado Wild - An Update

Since launching the Keep Colorado Pass in January 2023, we have:

- Sold 1,490,954 passes
- Maintained a 28.6% opt-in rate
- Generated \$41,088,650 in revenue
  - The first \$32.5 million will go toward state park maintenance and development
  - The next \$2.5 million will go towards search and rescue and \$1 million to the Colorado Avalanche Information Center
  - Additional revenue will go to wildlife projects and outdoor educational programs





# Colorado Native Pollinating Insects Health Study

Directed by Senate Bill 22-199, the Colorado Department of Natural Resources commissioned a study on native pollinating insects.

Outlines how Colorado is home to a rich community of native insects whose pollinating services are at the heart of healthy environments and economies, but concludes that overall, the status of Colorado's native pollinating insects is tenuous

The study, completed January 1, 2024 establishes:

- Baseline information including a synthesis of the research providing evidence for the importance of native pollinating insects to agricultural and natural resources within the state, including key factors impacting their diversity and health
- Conservation practices currently in place
- Future priorities for enhancing pollinating insect health

# Colorado Strategic Wildfire Action Program - An Update

COSWAP is a wildfire mitigation and forest health grant program designed to support strategic projects throughout Colorado that reduce wildfire risk and improve watershed health. COSWAP also supports workforce development through partnerships with the Colorado Youth Corps Association and the Department of Corrections SWIFT crews.

- To date, 54 projects totalling ~\$16M have been awarded using State stimulus funding
  - Received add'l \$16M between FY23/FY24 from Sevs. Tax Trust Fund and SB23-005
  - Beginning FY25, COSWAP will operate on a \$6M annual budget





# Colorado Strategic Wildfire Action Program - An Update

Recent COSWAP News:

- COSWAP received 32 applications totalling \$4.7M during the second Workforce Development Grant release in 2023; currently awarding new projects to be announced 2/2024
- Special release ARPA funding is supporting two landscape scale projects in Jefferson and Routt Counties, totalling \$1,960,000
- Colorado Forest Restoration Institute (CFRI) performing a 4 year effectiveness monitoring study
- Organizational Analysis of state supported wildfire mitigation efforts in Colorado is complete





# Colorado Produced Water Consortium - An Update

Primary Goal: To reduce the use of freshwater and increase the recycling of produced water in oil and gas operations

Established in July 2023, the Colorado Produced Water Consortium has:

- Appointed 31-member Consortium
- Created Strategic Plan and Priorities
  - Five strategic priorities: implementing legislative requirements, education, communities & environment, research, and identifying regulatory and policy recommendations
- Hired Director, in process of hiring Assistant Director for Research
- Begun development of required deliverables, including:
  - Guidance documents and case studies to promote best practices for infield reuse and recycling
  - Recommendations for better coordination between state and federal agencies related to produced water
  - Recommendations for legislation or agency rules needed to remove barriers to the safe recycling and reuse of produced water
- Served as an informational resource to ECMC
- Coordinated with ECMC on data needs





# Colorado Wolf Restoration Update

- Implementation of CRS 33-2-105.8, a result of the passage of Proposition 114
  - Mandated to establish a self-sustaining population of wolves
  - Provide compensation for confirmed wolf depredation
- Utilized important perspectives of the Stakeholder Advisory Group and Technical Working Group to develop the Wolf Restoration and Management Plan over a 2 year process
- Plan was unanimously supported by Parks and Wildlife Commission in May 2023
- 10 wolves were reintroduced to west slope of Colorado in December 2023
- There has been no livestock depredation from any of the reintroduced wolves
- There will be additional reintroductions in the coming years, all releases will be west of the continental divide
