CCIA Staff Roles and Responsibilities

CCIA has a team of four including 1 Executive Director, 2 Interagency Tribal Liaisons, and 1 Executive Assistant/Program Coordinator charged with:

- Supporting the needs and expectations of offices and agencies throughout the state
- Education on Tribal Affairs, Tribal sovereignty, data sovereignty, and current initiatives in the State of Colorado
- Making connections with Tribal leadership, Tribal offices and program staff, and supporting meaningful Tribal engagement and consultation.
- Streamlining Tribal affairs across the state
- Ensuring Tribes and AI/AN community
 members have a voice in any and all policy
 making impacting them



State-Tribal Consultation

- Tribal Consultation has become a major part of the current U.S. federal policy recognizing and respecting Tribal sovereignty and government-to-government relations with Tribal Nations. Some specific federal laws require federal departments and agencies to conduct Tribal Consultations on specific matters.
- Consultation is the development of a relationship based on trust, an effort to understand and consider any effects an undertaking may have on the consulting parties.
- Meaningful consultations are typically based on mutually agreed-upon written protocols for timely communication, coordination, cooperation, and collaboration.
- An accountable process ensuring meaningful and timely input from Tribal officials in the development of Department policies that have Tribal implications.
- CCIA Roadmap to Conduct Tribal and American Indian and Alaska Native Affairs within the State.



Senate Bill 22-104 Tribal Governments Included in State Programs Report:

CCIA produced this report as part of Senate Bill 22-104 (SB22-104): Tribal Governments Included In State Programs to explore and make recommendations concerning the inclusion of Tribal Governments in State programs.

Federal Indian Boarding Schools in Colorado, 1880-1920: required by HB 22-1327 which directed History Colorado to investigate the lived experiences of students at the one-time federal Native American boarding school in Hesperus, Colorado.

Tribal Health and Colorado Medicaid Report: support the Department of Health Care Policy and Financing (HCPF), Colorado's Tribal Nations and interested stakeholders by providing a set of holistic recommendations for Health First Colorado that can improve the state of Tribal health and advance Tribal Health priorities.

Indian Education Needs Assessment: CDE partnered with CCIA to conduct a needs assessment to examine key indicators, multiple groups' perspectives, and programmatic challenges. This evaluation aims to provide a comprehensive analysis of how well the Title VI program meets its goals in Colorado and what changes may be needed to supplement and improve upon efforts to support Indigenous students
