Why do we need to do this?

• State and Federal Regulations are that a contract maximum term is 10 years (including 2 extensions).

The Department executed contracts with core vendors expire in 2025:

Gainwell: Medicaid Management Information System (MMIS)


IBM: Business Intelligence Data management (BIDM)

Magellan: Pharmacy Benefits Management System (PBMS)

24 months prior approval planning from CMS is minimum required for these procurements

Colorado's Medicaid Enterprise Services (MES) Procurement Update

 The Notice of Proposed Rulemaking (NPRM) (CMS-2392-P) published on April 16, 2015 (80 FR 20455) by CMS ushered in modularity as states' recommended approach to MMIS replacement.

Under the revised rule 42 CFR Part 433, Subpart C - Mechanized Claims
 Processing and Information Retrieval Systems, CMS requires states to follow a modular approach that supports timely, cost-effective projects.

Research procurement documents from other states


- 9 states interviewed in this procurement

- Review security and network diagrams for any vendors who would have state of Colorado network connections for approval/conduct appropriate testing on vendor networks for security approval
- Provide Authority to Operate (ATO) to the Department for any vendors that would have state of Colorado network connections
- Attend CMS certification meetings
- Provide feedback on platforms and avoiding technical debt (see MIDA systems integrator)
