## **BILL TOPIC:** Transparency in Water Right Transactions

	A BILL FOR AN ACT
101	CONCERNING TRANSPARENCY IN WATER RIGHT TRANSACTIONS, AND,
102	IN CONNECTION THEREWITH, DIRECTING THE DIVISION OF
103	WATER RESOURCES TO PUBLISH AND MAINTAIN A DATABASE OF
104	PURCHASES AND SALES OF WATER RIGHTS.

## **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Water Resources and Agriculture Review Committee. The bill requires the division of water resources (division) in the department of natural resources to maintain a database of all water rights that are offered

for sale and purchased in Colorado on or after January 1, 2026. A seller of a water right must submit information related to the water right being offered for sale to the division prior to the sale of the water right. A purchaser of a water right must submit information related to the water right that was purchased to the division after completing the transaction. The division may charge a fee to purchasers and sellers of water rights in order to offset the cost of publishing and maintaining the database. The division must make the database available on its public website and update the database as necessary to maintain accurate records of water rights that are listed for sale and purchases of water rights in Colorado.

Current law excludes the conveyance of ownership of stock in ditch companies or other companies that constitutes a water right from the procedures and formalities required of real estate transactions. The bill requires that the conveyance of ownership of stock in ditch companies or other companies that constitutes a water right must follow the same procedures and formalities that are required for real estate transactions.

**38-30-102.** Water rights conveyed as real estate - well permit transfers - legislative declaration - definitions. (2) (a) In the conveyance of water rights in all cases, except INCLUDING where the ownership of stock in ditch companies or other companies constitutes the ownership of a water right, the same formalities shall be observed and complied with as in the conveyance of real estate.

- (b) As used in this subsection (2), "water right" has the same meaning as set forth in section 37-92-103 (12).
- (3) (d) The Buyer of Real estate that includes the transfer of ownership of a water right must comply with the filing requirements for the water right pursuant to section 37-80-125.

SECTION 2. In Colorado Revised Statutes, add 37-80-125 as follows:

9	AND PURCHASE OF WATER RIGHTS.
10	(d) IN ORDER TO MAINTAIN THE DATABASE IN ACCORDANCE WITH
11	Subsections $(3)$ and $(4)$ of this section, the division shall create
12	A FORM BY WHICH A SELLER AND A PURCHASER OF A WATER RIGHT MUST

23	(a) (I) On or after January 1, 2026, the purchaser of a water
24	RIGHT SHALL FILE A FORM WITH THE DIVISION THAT RECORDS THE
25	PURCHASE OF THE WATER RIGHT WITHIN SIXTY-THREE DAYS AFTER THE
26	DATE THE PURCHASE WAS COMPLETED.
27	(II) FOR THE PURCHASE OF A WATER RIGHT THAT IS INCLUDED IN

1	A REAL ESTATE TRANSACTION, THE FILING OF THE FORM REQUIRED BY THIS
2	SUBSECTION (4) SHALL BE INCORPORATED WITH THE REQUIREMENTS OF
3	SECTION 38-30-102 (3), INCLUDING THE REQUIREMENTS RELATED TO A

3	(5) <b>Rules.</b> The state engineer shall promulgate any rules
4	NECESSARY TO EFFECTUATE THE PUBLICATION AND OPERATION OF THE
5	DATABASE IN ACCORDANCE WITH THIS SECTION.
6	SECTION 3. In Colorado Revised Statutes, 37-80-102, add (11)
7	as follows:
8	37-80-102. General duties of state engineer - supervision and
9	utilization of employees - satellite and telemetry-based monitoring
10	systems - database of water rights sales and purchases - rules.
11	(11) The state engineer, in consultation with the executive
12	DIRECTOR OF THE DEPARTMENT OF NATURAL RESOURCES, ESTABLISHED BY
13	SECTION 24-1-124, SHALL PROMULGATE ANY RULES NECESSARY TO
14	EFFECTUATE THE PUBLICATION AND MAINTENANCE OF AN ONLINE
15	DATABASE FOR THE PURCHASE AND SALE OF WATER RIGHTS IN COLORADO
16	IN ACCORDANCE WITH SECTION 37-80-125.
17	SECTION 4. In Colorado Revised Statutes, 37-80-111.7, amend

20	(2) The state engineer shall collect the following fees and transmit them

8	to section 1 (3) of article V of the state constitution against this act or an
9	item, section, or part of this act within such period, then the act, item,
10	section, or part will not take effect unless approved by the people at the
11	general election to be held in November 2026 and, in such case, will take
12	effect on the date of the official declaration of the vote thereon by the
13	governor.
14	(2) This act applies to the offer for sale and purchase of water
15	rights in Colorado that occur on or after January 1, 2026.
