101 **CONCERNING THE ADMINISTRATION OF RETIREMENT PLANS**
102 **ADMINISTERED BY THE FIRE AND POLICE PENSION ASSOCIATION,**
103 **AND, IN CONNECTION THEREWITH, MERGING THE STATEWIDE**
104 **DEFINED BENEFIT PLAN, THE STATEWIDE HYBRID PLAN, AND THE**
105 **SOCIAL SECURITY SUPPLEMENTAL PLAN INTO A SINGLE NEW**
106 **STATEWIDE RETIREMENT PLAN.**

ESTABLISHMENT AND ADMINISTRATION

31-31.5-101. Establishment of the statewide retirement plan

- definitions. (1) THE STATEWIDE RETIREMENT PLAN IS HEREBY ESTABLISHED TO PROVIDE DEFINED BENEFIT AND MONEY PURCHASE RETIREMENT BENEFITS TO MEMBERS OF EMPLOYERS AFFILIATED WITH THE PLAN. INITIAL EMPLOYERS AFFILIATED WITH THE PLAN INCLUDE THOSE DEPARTMENTS THAT PARTICIPATED IN THE STATEWIDE DEFINED BENEFIT PLAN ESTABLISHED PURSUANT TO PART 4 OF ARTICLE 31 OF THIS TITLE 31, THE STATEWIDE HYBRID PLAN ESTABLISHED PURSUANT TO PART 11 OF ARTICLE 31 OF THIS TITLE 31, AND THE SOCIAL SECURITY SUPPLEMENTAL PLAN ESTABLISHED PURSUANT TO PART 7 OF ARTICLE 31 OF THIS TITLE 31 AS SUCH PLANS EXISTED BEFORE THEIR MERGER INTO THE STATEWIDE RETIREMENT PLAN PURSUANT TO _____ BILL 22-_____, ENACTED IN 2022.

(2) THE BOARD IS THE TRUSTEE OF THE STATEWIDE RETIREMENT PLAN, AND HAS THOSE FIDUCIARY DUTIES TO THE PLAN AND THE MEMBERS OF THE PLAN AS EXPRESSLY PROVIDED BY LAW.

(3) THE BOARD, AS A FIDUCIARY, MAY DELEGATE ONE OR MORE OF ITS RESPONSIBILITIES UNDER THIS ARTICLE 31.5 BUT SHALL MAINTAIN ITS RESPONSIBILITY FOR OVERSIGHT OF THE DELEGATION.

(4) (a) THE STATEWIDE RETIREMENT PLAN IS INTENDED TO COMPLY WITH THE QUALIFICATION REQUIREMENTS SPECIFIED IN SECTION 401(a) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED AND APPLICABLE TO GOVERNMENTAL PLANS, AS DEFINED IN SECTION 414(d) OF SAID CODE.

(b) THE BOARD MAY ADOPT ANY PROVISION FOR THE PLAN THAT IS NECESSARY OR IN THE BOARD'S JUDGMENT PRUDENT TO COMPLY WITH STATE OR FEDERAL LAW.

(5) AS USED IN THIS ARTICLE 31.5, UNLESS THE CONTEXT

1 OTHERWISE REQUIRES:

2 (a) "ACTUARIALLY SOUND" MEANS A POLICE OFFICERS' OR
3 FIREFIGHTERS' PENSION FUND DETERMINED BY THE BOARD TO BE
4 RECEIVING OR SCHEDULED TO RECEIVE EMPLOYER AND MEMBER
5 CONTRIBUTIONS IN EACH FISCAL YEAR EQUAL TO THE ANNUAL
6 CONTRIBUTIONS ACTUARIALLY DETERMINED TO BE NECESSARY TO PAY
7 THE ANNUAL CURRENT SERVICE COST OF PENSION BENEFITS ATTRIBUTABLE
8 TO ACTIVE EMPLOYEES AND TO PAY THE ANNUAL CONTRIBUTION
9 NECESSARY TO AMORTIZE ANY UNFUNDED ACCRUED LIABILITY OVER A
10 PERIOD NOT TO EXCEED FORTY YEARS. THE ACTUARIAL COST METHOD TO
11 BE UTILIZED SHALL BE THE ENTRY AGE-NORMAL COST METHOD. THE DATE
12 FROM WHICH UNFUNDED LIABILITIES SHALL BE AMORTIZED SHALL BE
13 DETERMINED PURSUANT TO PART 3 OF ARTICLE 30.5 OF THIS TITLE 31.

14 (b) "ASSOCIATION" MEANS THE FIRE AND POLICE PENSION
15 ASSOCIATION CREATED IN SECTION 31-31-201 (1).

16 (c) "BOARD" MEANS THE BOARD OF DIRECTORS ESTABLISHED AS
17 THE GOVERNING BODY OF THE FIRE AND POLICE PENSION ASSOCIATION AS
18 PROVIDED IN SECTION 31-31-201 (2).

19 (d) "EMPLOYER" MEANS ANY MUNICIPALITY IN THIS STATE
20 OFFERING POLICE OR FIRE PROTECTION SERVICE EMPLOYING ONE OR MORE
21 MEMBERS AND ANY SPECIAL DISTRICT, FIRE AUTHORITY, OR COUNTY
22 IMPROVEMENT DISTRICT IN THIS STATE OFFERING FIRE PROTECTION
23 SERVICE EMPLOYING ONE OR MORE MEMBERS.

24 (e) "LIFETIME BENEFIT COMPONENTS" MEANS THE DEFINED
25 BENEFIT COMPONENT, THE SOCIAL SECURITY COMPONENT, AND THE
26 HYBRID COMPONENT, AS DESCRIBED IN THIS ARTICLE 31.5, COLLECTIVELY.

27 (f) "MEMBER" MEANS AN ACTIVE EMPLOYEE WHO IS A FULL-TIME

1 SALARIED EMPLOYEE OF A MUNICIPALITY, FIRE PROTECTION DISTRICT, FIRE
2 AUTHORITY, OR COUNTY IMPROVEMENT DISTRICT NORMALLY SERVING AT
3 LEAST ONE THOUSAND SIX HUNDRED HOURS IN ANY CALENDAR YEAR AND
4 WHOSE DUTIES ARE DIRECTLY INVOLVED WITH THE PROVISION OF POLICE
5 OR FIRE PROTECTION, AS CERTIFIED BY THE MEMBER'S EMPLOYER.
6 "MEMBER" ALSO INCLUDES AN ACTIVE EMPLOYEE WHO WORKS LESS THAN
7 SIXTEEN HUNDRED HOURS PER YEAR BUT OTHERWISE QUALIFIES AS A
8 MEMBER AND WHOSE EMPLOYER ELECTS TO TREAT ALL SUCH OTHER
9 SIMILAR EMPLOYEES AS MEMBERS. THE TERM DOES NOT INCLUDE
10 CLERICAL OR OTHER PERSONNEL WHOSE SERVICES ARE AUXILIARY TO
11 POLICE PROTECTION, OR ANY VOLUNTEER FIREFIGHTER, AS SUCH TERM IS
12 DEFINED IN SECTION 31-30-1102 (9). FOR THE PURPOSE OF PARTICIPATION
13 IN THE STATEWIDE DEFINED BENEFIT PLAN PURSUANT TO PART 4 OF THIS
14 ARTICLE OR THE STATEWIDE MONEY PURCHASE PLAN PURSUANT TO PART
15 5 OF THIS ARTICLE 31.5, BUT NOT FOR THE PURPOSE OF PARTICIPATION IN
16 THE STATEWIDE DEATH AND DISABILITY PLAN PURSUANT TO PART 8 OF
17 THIS ARTICLE 31.5, THE TERM MAY INCLUDE CLERICAL OR OTHER
18 PERSONNEL EMPLOYED BY A FIRE PROTECTION DISTRICT, FIRE AUTHORITY,
19 OR COUNTY IMPROVEMENT DISTRICT, WHOSE SERVICES ARE AUXILIARY TO
20 FIRE PROTECTION. FOR THE PURPOSE OF ELIGIBILITY FOR DISABILITY OR
21 SURVIVOR BENEFITS, "MEMBER" INCLUDES ANY EMPLOYEE ON AN
22 AUTHORIZED LEAVE OF ABSENCE.

23 (g) "MONEY PURCHASE PLAN" OR "MONEY PURCHASE PENSION
24 PLAN" MEANS A RETIREMENT PLAN UNDER WHICH:

25 (I) THE EMPLOYER HAS A FIXED OBLIGATION TO MAKE AN ANNUAL
26 CONTRIBUTION TO THE PLAN;

27 (II) AN INDIVIDUAL ACCOUNT FOR EACH MEMBER IS PROVIDED;

1 AND

2 (III) THE MEMBER'S BENEFITS ARE BASED SOLELY ON THE AMOUNT
3 CONTRIBUTED TO THE MEMBER'S ACCOUNT AND ANY INCOME, EXPENSES,
4 GAINS, AND LOSSES ALLOCATED TO THE MEMBER'S ACCOUNT.

5 (h) "PREDECESSOR PLANS" MEANS THE STATEWIDE DEFINED
6 BENEFIT PLAN FORMERLY GOVERNED BY PART 4 OF ARTICLE 31 OF THIS
7 TITLE 31, THE STATEWIDE HYBRID PLAN FORMERLY GOVERNED BY PART 11
8 OF ARTICLE 31 OF THIS TITLE 31, AND THE SOCIAL SECURITY
9 SUPPLEMENTAL PLAN FORMERLY GOVERNED BY PART 7 OF ARTICLE 31 OF
10 THIS TITLE 31.

11 (g) "RETIRED MEMBER" MEANS ANY MEMBER WHO IS RETIRED,
12 DISABLED, OR ELIGIBLE FOR A BENEFIT AS PROVIDED IN SECTION 31-31-404
13 (2).

14 **31-31.5-102. Administration of the plan - definitions.**

15 (1) (a) CONTRIBUTIONS AND EARNINGS TO ALL COMPONENTS OF THE
16 STATEWIDE RETIREMENT PLAN SHALL BE HELD IN TRUST AS PART OF THE
17 DEFINED BENEFIT SYSTEM TRUST FUND.

18 (b) THERE IS HEREBY ESTABLISHED IN THE DEFINED BENEFIT
19 SYSTEM TRUST FUND, A LIFETIME BENEFITS ACCOUNT INTO WHICH
20 CONTRIBUTIONS MADE PURSUANT TO SECTIONS 31-31.5-301, 31-31.5-302,
21 AND 31-31.5-303 MUST BE DEPOSITED. THE DEFINED BENEFITS OF THE
22 LIFETIME BENEFIT COMPONENTS, INCLUDING COST OF LIVING
23 ADJUSTMENTS PROVIDED BY THE PLAN PURSUANT TO PART 4 OF THIS
24 ARTICLE 31.5, TOGETHER WITH THE EXPENSES OF ADMINISTERING THE
25 LIFETIME BENEFIT COMPONENTS OF THE PLAN, SHALL BE PAID FROM THE
26 ACCOUNT. THE LIFETIME BENEFITS ACCOUNT SHALL BE INVESTED WITHIN
27 THE FIRE AND POLICE MEMBERS' BENEFIT INVESTMENT FUND.

1 (c) THERE IS ESTABLISHED IN THE DEFINED BENEFIT SYSTEM TRUST
2 FUND, A MONEY PURCHASE ACCOUNT INTO WHICH CONTRIBUTIONS MADE
3 PURSUANT TO SECTION 31-31.5-304 MUST BE DEPOSITED AND ASSIGNED TO
4 INDIVIDUAL ACCOUNTS AND ADMINISTERED PURSUANT TO PART 5 OF THIS
5 ARTICLE 31.5. THE BOARD MAY CREATE SUBACCOUNTS WITHIN THE
6 ACCOUNT TO ADEQUATELY TRACK THE VESTING AND THE SOURCE OF
7 MONEY DEPOSITED INTO THE ACCOUNT ON BEHALF OF EACH MEMBER. THE
8 MONEY PURCHASE COMPONENT ACCOUNT MUST BE INVESTED WITHIN THE
9 FIRE AND POLICE MEMBERS' SELF-DIRECTED INVESTMENT FUND.

10 (d) THE BOARD SHALL KEEP AN ACCURATE ACCOUNT OF THE
11 ASSETS AND LIABILITIES OF THE LIFETIME BENEFITS ACCOUNT AND THE
12 MONEY PURCHASE COMPONENT ACCOUNT.

13 (2) THE BOARD MAY ADOPT BY RULE SUCH MATTERS AS MAY BE
14 NECESSARY TO CODIFY THE BOARD'S INTERPRETATION, ADMINISTRATION,
15 AND MANAGEMENT OF THE STATEWIDE RETIREMENT PLAN.

16 (3) THE BOARD MAY PROVIDE FOR THE ADMINISTRATION OF
17 DOMESTIC RELATIONS ORDERS ISSUED PURSUANT TO ARTICLE 10 OF TITLE
18 14 WITH REGARD TO THE PLAN OR ITS PREDECESSOR PLANS.

19 PART 2

20 MEMBER PARTICIPATION

21 **31-31.5-201. Membership.** EXCEPT AS OTHERWISE PROVIDED IN
22 THIS ARTICLE 31.5 OR ARTICLE 31 OF THIS TITLE 31, A MEMBER WHOSE
23 EMPLOYER IS AFFILIATED WITH A COMPONENT OF THE STATEWIDE
24 RETIREMENT PLAN SHALL PARTICIPATE IN THE STATEWIDE RETIREMENT
25 PLAN ON THE FIRST DAY OF EMPLOYMENT IF THE EMPLOYER WITHHOLDS
26 MEMBER CONTRIBUTIONS ON BEHALF OF THE MEMBER AND THE
27 APPLICABLE FORMS ARE COMPLETED AND SUBMITTED TO THE

1 ASSOCIATION.

2 **31-31.5-202. Reentering and affiliating employers.**

3 (1) MEMBERS OF EMPLOYERS WHO REENTER OR AFFILIATE PURSUANT TO
4 PART 7 OR PART 11 OF ARTICLE 31 OF THIS TITLE 31 SHALL PARTICIPATE IN
5 THE STATEWIDE RETIREMENT PLAN BEGINNING ON THE EMPLOYER'S
6 EFFECTIVE DATE PURSUANT TO RULES ADOPTED BY THE BOARD.

7 (2) MEMBERS COVERED BY SUBSECTION (1) OF THIS SECTION MAY
8 ELECT A TRUSTEE-TO-TRUSTEE TRANSFER IN ORDER TO TRANSFER ASSETS
9 FROM THE PREDECESSOR MONEY PURCHASE PLAN TO THE MEMBER'S
10 INDIVIDUAL ACCOUNT ESTABLISHED PURSUANT TO PART 5 OF THIS ARTICLE
11 31.5.

12 (3) AN ACTIVE MEMBER WHO IS REQUIRED TO TRANSFER MONEY
13 PURCHASE ASSETS TO THE STATEWIDE RETIREMENT PLAN MAY ALSO ELECT
14 TO CONVERT THE VESTED PROCEEDS FROM THE PREDECESSOR MONEY
15 PURCHASE PLAN INTO SERVICE CREDIT TOWARDS THE ACCRUAL OF
16 BENEFITS UNDER THE LIFETIME BENEFIT COMPONENTS AS MAY BE
17 ALLOWED PURSUANT TO THE BOARD'S RULES.

18 **31-31.5-203. Department chief - exemption by written**

19 **agreement - definition.** (1) A DEPARTMENT CHIEF HIRED ON OR AFTER
20 APRIL 8, 1978, IS EXEMPT FROM THE STATEWIDE RETIREMENT PLAN UPON
21 THE EXECUTION OF A WRITTEN AGREEMENT BETWEEN THE DEPARTMENT
22 CHIEF AND THE CHIEF'S EMPLOYER THAT PROVIDES FOR THE DEPARTMENT
23 CHIEF'S PARTICIPATION IN SOCIAL SECURITY OR IN A FEDERAL INSURANCE
24 CONTRIBUTION ACT REPLACEMENT PLAN AS ALLOWED UNDER RULES
25 ESTABLISHED BY THE BOARD AND IN COMPLIANCE WITH THE FEDERAL
26 "INTERNAL REVENUE CODE OF 1986". A DEPARTMENT CHIEF MAY SATISFY
27 THE FEDERAL INSURANCE CONTRIBUTION ACT REPLACEMENT PLAN

1 REQUIREMENT BY PARTICIPATING IN AN EMPLOYER SPONSORED PLAN, THE
2 STATEWIDE MONEY PURCHASE PLAN, OR A COMPONENT OF THE STATEWIDE
3 RETIREMENT PLAN.

4 (2) AS USED IN THIS SECTION, "DEPARTMENT CHIEF" MEANS THE
5 SENIOR COMMAND OFFICER OF ANY FIRE OR POLICE DEPARTMENT OF ANY
6 EMPLOYER BY WHATEVER TITLE KNOWN INCLUDING BUT NOT LIMITED TO
7 CHIEF, ADMINISTRATOR, OR DIRECTOR.

8 (3) A DEPARTMENT CHIEF EXEMPTED PURSUANT TO SUBSECTION
9 (1) OF THIS SECTION MAY MAINTAIN COVERAGE FOR DISABILITY AND
10 SURVIVOR BENEFITS UNDER PART 8 OF THIS ARTICLE IF THE DEPARTMENT
11 CHIEF PARTICIPATES IN THE STATEWIDE MONEY PURCHASE PLAN, THE
12 STATEWIDE RETIREMENT PLAN, OR A LOCAL MONEY PURCHASE PLAN THAT
13 IS QUALIFIED UNDER SECTION 401(a) OF THE FEDERAL "INTERNAL
14 REVENUE CODE OF 1986" AND THAT HAS A CONTRIBUTION RATE OF NOT
15 LESS THAN EIGHTEEN PERCENT.

16 **31-31.5-204. Reemployment.** (1) AN INACTIVE MEMBER WHO IS
17 SUBSEQUENTLY REEMPLOYED SHALL PARTICIPATE IN THE PLAN IN THE
18 MANNER PRESCRIBED BY RULES ADOPTED BY THE BOARD.

19 (2) (a) THE BOARD SHALL ADOPT RULES REGARDING THE
20 TREATMENT OF A MEMBER WHO PARTICIPATES IN THE STATEWIDE
21 RETIREMENT PLAN, INCURS A BONA FIDE SEPARATION FROM SERVICE,
22 ELECTS A RETIREMENT, AND SUBSEQUENTLY RETURNS TO WORK WITH AN
23 EMPLOYER WHO PARTICIPATES IN THE STATEWIDE RETIREMENT PLAN IN
24 CONFORMANCE WITH THE FEDERAL INTERNAL REVENUE CODE OF 1986, AS
25 AMENDED.

26 (b) SUCH RULES MUST INDICATE:

27 (I) WHETHER THE MEMBER CONTINUES TO RECEIVE BENEFIT

1 DISTRIBUTIONS DURING THE REEMPLOYMENT OR WHETHER THE MEMBER'S
2 BENEFIT DISTRIBUTION CEASES DURING REEMPLOYMENT;

3 (II) WHETHER THE MEMBER EARNS ADDITIONAL SERVICE CREDIT
4 AS DETERMINED BY THE PLAN IN WHICH THE SUBSEQUENT EMPLOYER
5 PARTICIPATES OR WHETHER THE MEMBER EARNS ADDITIONAL RETIREMENT
6 BENEFITS BY PARTICIPATING IN AN ALTERNATE MONEY PURCHASE PLAN;
7 AND

8 (III) WHETHER THE BENEFIT DISTRIBUTION, IF CEASED DURING
9 REEMPLOYMENT, RESUMES WHEN THE MEMBER SUBSEQUENTLY
10 SEPARATES FROM SERVICE.

11 PART 3

12 CONTRIBUTIONS AND SERVICE CREDIT

13 **31-31.5-301. Defined benefit component minimum**
14 **contributions.** (1) EVERY MEMBER COVERED UNDER THE DEFINED
15 BENEFIT COMPONENT OF THE STATEWIDE RETIREMENT PLAN SHALL PAY
16 INTO THE LIFETIME BENEFITS ACCOUNT TWELVE PERCENT OF BASE SALARY
17 PAID OR ANY HIGHER MEMBER CONTRIBUTION RATE ESTABLISHED
18 PURSUANT TO PART 6 OF THIS ARTICLE 31.5. THE PAYMENT SHALL BE
19 MADE BY THE EMPLOYER BY DEDUCTION FROM THE SALARY PAID TO THE
20 MEMBER.

21 (2) (a) EVERY EMPLOYER EMPLOYING MEMBERS WHO ARE
22 COVERED BY THE DEFINED BENEFIT COMPONENT OF THE STATEWIDE
23 RETIREMENT PLAN SHALL PAY INTO THE LIFETIME BENEFITS ACCOUNT NINE
24 PERCENT OF THE BASE SALARY PAID TO THE MEMBER OR ANY HIGHER
25 EMPLOYER CONTRIBUTION RATE ESTABLISHED PURSUANT TO PART 6 OF
26 THIS ARTICLE 31.5. THE EMPLOYER CONTRIBUTION RATE SHALL INCREASE
27 BY THREE PERCENT TO BE IMPLEMENTED THROUGH SIX ANNUAL INCREASES

1 AS FOLLOWS: BEGINNING IN 2023, AND EACH YEAR THEREAFTER THROUGH
2 2028, THE EMPLOYER CONTRIBUTION RATE SHALL INCREASE BY AN
3 ADDITIONAL ONE-HALF OF ONE PERCENT OF BASE SALARY UNTIL THE
4 TOTAL EMPLOYER CONTRIBUTION RATE, INCLUDING THE CUMULATIVE
5 CONTRIBUTION RATE INCREASES, IS TWELVE PERCENT OF BASE SALARY.

6 (b) IN ADDITION TO THE RATE ESTABLISHED IN SUBSECTION (2)(a)
7 OF THIS SECTION, THE EMPLOYER CONTRIBUTION RATE SHALL BE
8 INCREASED BY ONE PERCENT OF BASE SALARY TO BE IMPLEMENTED AS
9 FOLLOWS: BEGINNING IN 2029, AND CONTINUING THROUGH 2030, THE
10 EMPLOYER CONTRIBUTION RATE SHALL INCREASE BY AN ADDITIONAL
11 ONE-HALF OF ONE PERCENT OF BASE SALARY IN EACH YEAR FOR A TOTAL
12 OF A ONE PERCENT INCREASE IN ORDER TO PAY FOR THE COST OF
13 PROVIDING THE OPTION TO RETIRE CONTAINED IN SECTION 31-31.5-401
14 (2)(b).

15 (3) AFTER CONSIDERING THE RESULTS OF THE ACTUARIAL
16 VALUATION CONDUCTED PURSUANT TO SECTION 31-31.5-402, IF THE
17 ASSETS OF THE LIFETIME BENEFIT COMPONENTS OF THE PLAN COMBINED
18 WITH PROJECTED CONTRIBUTIONS ARE SUFFICIENT TO FULLY FUND THE
19 BENEFITS PROVIDED FOR IN PART 4 OF THIS ARTICLE 31.5 ON AN
20 ACTUARIALLY SOUND BASIS PLUS THE PROJECTED COST OF LIVING
21 ADJUSTMENTS AS DETERMINED BY THE BOARD, THE BOARD MAY, IN ITS
22 SOLE DISCRETION, ALLOCATE SURPLUS CONTRIBUTIONS TO THE MONEY
23 PURCHASE COMPONENT PURSUANT TO SECTION 31-31.5-304. THE BOARD
24 SHALL DESIGNATE WHETHER ANY SUCH ALLOCATION IS AN EMPLOYER
25 CONTRIBUTION OR A MEMBER CONTRIBUTION.

26 **31-31.5-302. Social security component minimum**
27 **contributions.** (1) THIS COMPONENT COVERS THE MEMBERS OF THOSE

1 EMPLOYERS THAT HAVE ELECTED COVERAGE UNDER THE PLAN PURSUANT
2 TO SECTION 31-31-704.5.

3 (2) EACH MEMBER SHALL MAKE CONTRIBUTIONS AT ONE-HALF OF

8 ON THE AMOUNT REQUIRED TO FUND THE BENEFIT PROVIDED UNDER THE

10 **31-31.5-304. Money purchase component contributions.**

11 (1) FOR MEMBERS WHO ELECTED THE MONEY PURCHASE ONLY OPTION
12 UPON REENTRY INTO A PREDECESSOR PLAN, THE CONTRIBUTION RATE FOR
13 EMPLOYERS AND MEMBERS IS EQUAL TO THE CONTRIBUTION RATES
14 ESTABLISHED IN THE PREDECESSOR PLAN.

15 (2) CONTRIBUTIONS, INCLUDING SEPARATE RETIREMENT ACCOUNT
16 BALANCES FROM THE PREDECESSOR STATEWIDE DEFINED BENEFIT PLAN
17 ESTABLISHED UNDER PART 4 OF ARTICLE 31 OF THIS TITLE 31, TRANSFERS
18 FROM THE PREDECESSOR STATEWIDE HYBRID PLAN MONEY PURCHASE
19 ACCOUNTS, SURPLUS CONTRIBUTIONS ALLOCATED FROM THE DEFINED
20 BENEFIT COMPONENT CONTRIBUTIONS PURSUANT TO SECTION 31-31.5-301
21 (3), THE PORTION OF THE MINIMUM CONTRIBUTIONS OF HYBRID
22 COMPONENT ALLOCATED TO THE MONEY PURCHASE COMPONENT
23 PURSUANT TO SECTION 31-31.5-303 (3), INCREASED LOCAL MANDATORY
24 CONTRIBUTIONS PURSUANT TO SECTION 31-31.5-307, AND INCREASED

27 (3) THE BOARD MAY PROVIDE THROUGH RULES FOR ROLLOVERS OR

1 TRANSFER OF FUNDS FROM OTHER PLANS TO BE DEPOSITED IN THE MONEY
2 PURCHASE COMPONENT SUBJECT TO REQUIREMENTS AND LIMITS
3 ESTABLISHED BY THE FEDERAL "INTERNAL REVENUE CODE OF 1986", AS
4 AMENDED.

5 **31-31.5-305. Continuing rates of contribution for reentry and**
6 **affiliating departments.** (1) AT THE TIME OF REENTRY OR AFFILIATION,
7 THE BOARD MAY ESTABLISH A CONTINUING RATE OF CONTRIBUTION FOR
8 DEPARTMENTS REENTERING OR AFFILIATING WITH THE STATEWIDE

25 APPROVAL OF AT LEAST SIXTY-FIVE PERCENT OF THE EMPLOYER'S ACTIVE
26 MEMBERS VOTING, A MANDATORY CONTRIBUTION RATE IN EXCESS OF THE
27 MINIMUM REQUIRED CONTRIBUTION RATE MAY BE REDUCED TO THE

1 MINIMUM REQUIRED CONTRIBUTION RATE OR THE EXCESS ABOVE THE
2 MINIMUM REQUIRED CONTRIBUTION RATE MAY BE REDIRECTED TO
3 ANOTHER AVAILABLE EMPLOYEE BENEFIT.

4 **31-31.5-308. Increased local voluntary contribution**
5 **requirements.** (1) ACTIVE MEMBERS MAY MAKE ADDITIONAL AFTER-TAX
6 CONTRIBUTIONS TO THE MONEY PURCHASE COMPONENT ACCOUNT UNDER
7 PART 5 OF THIS ARTICLE 31.5. VOLUNTARY MEMBER CONTRIBUTIONS ARE
8 NOT SUBJECT TO THE EMPLOYER PICK-UP PROVISIONS OF SECTION 414
9 (h)(2) OF THE FEDERAL "INTERNAL REVENUE CODE OF 1986", AS
10 AMENDED.

11 (2) EMPLOYERS MAY MAKE ADDITIONAL CONTRIBUTIONS TO THE
12 MONEY PURCHASE COMPONENT ACCOUNT UNDER PART 5 OF THIS ARTICLE
13 31.5 ON BEHALF OF MEMBERS. EMPLOYER VOLUNTARY CONTRIBUTIONS
14 VEST ON THE SCHEDULE ESTABLISHED IN SECTION 31-31.5-501.

15 **31-31.5-309. Remittance of contributions to the association.**
16 (1) REMITTANCES OF CONTRIBUTIONS ARE DUE NO LATER THAN TEN DAYS
17 FOLLOWING THE DATE OF PAYMENT OF SALARY TO A MEMBER. ALL
18 REMITTANCES OF CONTRIBUTIONS MUST BE CREDITED TO THE DEFINED
19 BENEFIT SYSTEM TRUST FUND.

20 (2) THE PAYMENTS REQUIRED BY THIS SECTION ARE SUBJECT TO
21 INTEREST AS ESTABLISHED BY THE BOARD IF NOT SUBMITTED WHEN DUE.

22 **31-31.5-310. Service credit purchases.** MEMBERS PARTICIPATING
23 IN THE LIFETIME BENEFIT COMPONENTS MAY PURCHASE, INCLUDING BY
24 ROLLOVER OR TRANSFER OF FUNDS, ADDITIONAL DEFINED BENEFIT
25 SERVICE CREDIT FOR OTHER PUBLIC EMPLOYMENT WITHIN THE UNITED
26 STATES NOT COVERED BY THE PLAN, UNITED STATES UNIFORMED
27 MILITARY SERVICE, OR UP TO FIVE YEARS OF PRIVATE EMPLOYMENT,

1 SUBJECT TO THE LIMITS ESTABLISHED BY THE FEDERAL "INTERNAL
2 REVENUE CODE OF 1986", AS AMENDED, AND AS MAY BE ALLOWED UNDER
3 THE RULES AND REGULATIONS ADOPTED BY THE BOARD.

13 YEARS OF SERVICE CREDIT AND HAS ATTAINED AGE FIFTY-FIVE; OR

14 (b) THE MEMBER HAS ATTAINED AGE FIFTY, THE MEMBER'S
15 COMBINED AGE AND YEARS OF ACCRUED SERVICE IS EQUAL TO AT LEAST
16 EIGHTY, AND THE MEMBER IS NOT RECEIVING BENEFITS PURSUANT TO
17 SECTION 31-31-803.

18 (3) A VESTED MEMBER WHO ATTAINS AGE FIFTY-FIVE IS ELIGIBLE
19 TO TERMINATE SERVICE AND BEGIN RECEIVING AN UNREDUCED BENEFIT.
20 A MEMBER WHO TERMINATES EMPLOYMENT BEFORE ATTAINING AGE
21 FIFTY-FIVE AND WHO HAS AT LEAST FIVE YEARS OF SERVICE CREDIT MAY
22 LEAVE CONTRIBUTIONS IN THE PLAN AND BEGIN RECEIVING AN
23 UNREDUCED BENEFIT UPON ATTAINING AGE FIFTY-FIVE.

24 (4) AN ACTIVE OR INACTIVE VESTED MEMBER WHO IS NOT ELIGIBLE
25 FOR NORMAL RETIREMENT, WHO HAS ATTAINED AGE FIFTY, WHO IS NOT
26 RECEIVING OR HAS TERMINATED BENEFITS PURSUANT TO SECTION
27 31-31-803, AND WHO HAS TERMINATED EMPLOYMENT IS ELIGIBLE FOR AN

1 EARLY RETIREMENT PENSION. THE EARLY RETIREMENT PENSION FOR A
2 MEMBER IS THE BENEFIT THAT THE MEMBER WOULD HAVE RECEIVED AT

4 DEEMED ADEQUATE TO MAINTAIN ACTUARIAL STABILITY.

5 (b) THE BOARD SHALL PERIODICALLY CONDUCT A REVIEW AND
6 STUDY OF THE ACTUAL EXPERIENCE OF THE ASSETS AND LIABILITIES OF
7 THE LIFETIME BENEFIT COMPONENTS OF THE STATEWIDE RETIREMENT
8 PLAN. THE BOARD SHALL ADJUST THE ASSUMPTIONS MADE WITH REGARD
9 TO EACH COMPONENT AS A RESULT OF THE REVIEW AND STUDY.

10 (3) THE BOARD SHALL DETERMINE AFTER EACH ANNUAL
11 ACTUARIAL VALUATION IF THE COST OF ALL BENEFITS ESTABLISHED BY

23 (a) THE BOARD MAY TERMINATE ALLOCATING SURPLUS
24 CONTRIBUTIONS TO THE MONEY PURCHASE COMPONENT PURSUANT TO
25 SECTION 31-31.5-301 (3);

26 (b) THE BOARD MAY TERMINATE MAKING COST OF LIVING
27 ADJUSTMENTS PURSUANT TO SECTION 31-31.5-410;

1 (c) (I) THE BOARD MAY ORDER THAT THE NORMAL RETIREMENT
2 PENSION COMMENCE SUCH NUMBER OF MONTHS AS ARE ACTUARIALLY
3 SUPPORTABLE, FROM ONE TO SIXTY, AFTER AGE FIFTY-FIVE FOR MEMBERS
4 WHO ARE OTHERWISE ELIGIBLE PURSUANT TO SECTION 31-31.5-401 (2)(a).
5 IF THE BOARD ADJUSTS THE AGE OF ELIGIBILITY PURSUANT TO THIS
6 SUBSECTION (4)(c)(I), IT SHALL ALSO ADJUST THE AGE OF ELIGIBILITY FOR
7 BENEFITS UNDER SECTION 31-31.5-401 (2)(b), (3), AND (4) IN A LIKE

7 (5) (a) IF THE ACTUAL FINANCIAL EXPERIENCE OF THE LIFETIME

9 ASSUMED EXPERIENCE DURING THE PREVIOUS PERIOD, ADJUSTMENTS MAY
10 BE MADE BY THE BOARD IN THE MEMBER AND EMPLOYER CONTRIBUTIONS
11 AS MAY BE DEEMED FEASIBLE AND ADVISABLE SO LONG AS THE EMPLOYER
12 CONTRIBUTION RATE ADJUSTMENT IS EQUAL TO THE MEMBER

19 (6) NOTHING IN THIS SECTION SHALL BE CONSTRUED TO REQUIRE
20 THE REDUCTION OF BENEFITS BELOW THE LEVEL SUSTAINABLE BY THE
21 HIGHER MEMBER OR EMPLOYER CONTRIBUTION RATES ESTABLISHED
22 PURSUANT TO SECTION 31-31.5-601.

23 **31-31.5-403. Defined benefit component benefits.** (1) IN
24 CALCULATING THE RETIREMENT PENSION FOR A MEMBER WHO HAS
25 SERVICE CREDIT IN THE DEFINED BENEFIT COMPONENT, THE BENEFIT IS THE
26 SUM OF THE FOLLOWING:

27 (a) TWO PERCENT MULTIPLIED BY THE SERVICE CREDIT EARNED OR

1 PURCHASED IN THE DEFINED BENEFIT COMPONENT, NOT TO EXCEED TEN
2 YEARS OF SERVICE CREDIT, MULTIPLIED BY THE AVERAGE OF THE
3 MEMBER'S HIGHEST THREE YEARS' BASE SALARY IN THE DEFINED BENEFIT
4 COMPONENT; PLUS

5 (b) TWO AND ONE-HALF PERCENT MULTIPLIED BY THE SERVICE
6 CREDIT EARNED OR PURCHASED IN THE DEFINED BENEFIT COMPONENT IN
7 EXCESS OF TEN YEARS MULTIPLIED BY THE AVERAGE OF THE MEMBER'S
8 HIGHEST THREE YEARS' BASE SALARY IN THE DEFINED BENEFIT
9 COMPONENT.

10 **31-31.5-404. Social security component benefits.** (1) IN
11 CALCULATING THE RETIREMENT PENSION FOR A MEMBER WHO HAS
12 SERVICE CREDIT IN THE SOCIAL SECURITY COMPONENT, THE BENEFIT IS THE
13 SUM OF THE FOLLOWING:

14 (a) ONE PERCENT MULTIPLIED BY THE YEARS OF SERVICE CREDIT
15 IN THE SOCIAL SECURITY COMPONENT, NOT TO EXCEED TEN YEARS OF
16 SERVICE CREDIT, MULTIPLIED BY THE AVERAGE OF THE MEMBER'S HIGHEST
17 THREE YEARS' BASE SALARY IN THE SOCIAL SECURITY COMPONENT; PLUS

18 (b) ONE AND ONE-QUARTER PERCENT MULTIPLIED BY THE YEARS
19 OF SERVICE CREDIT IN THE SOCIAL SECURITY COMPONENT IN EXCESS OF
20 TEN YEARS MULTIPLIED BY THE AVERAGE OF THE MEMBER'S HIGHEST
21 THREE YEARS' BASE SALARY IN THE SOCIAL SECURITY COMPONENT.

22 **31-31.5-405. Hybrid component benefits.** (1) IN CALCULATING
23 THE NORMAL RETIREMENT PENSION FOR A MEMBER WHO HAS YEARS OF
24 SERVICE CREDIT IN THE HYBRID COMPONENT, THE BENEFIT SHALL BE:

25 (a) A MULTIPLIER TO BE ESTABLISHED BY THE BOARD MULTIPLIED
26 BY THE YEARS OF SERVICE CREDIT EARNED OR PURCHASED IN THE
27 STATEWIDE HYBRID PLAN PRIOR TO JANUARY 1, 2023, MULTIPLIED BY THE

1 AVERAGE OF THE MEMBER'S HIGHEST THREE YEARS' BASE SALARY. THE
2 BOARD SHALL ESTABLISH THE MULTIPLIER BY ADJUSTING THE FUNDING
3 STATUS OF THE PREDECESSOR STATEWIDE HYBRID PLAN TO EQUAL THE
4 FUNDING STATUS OF THE PREDECESSOR STATEWIDE DEFINED BENEFIT PLAN
5 USING VALUATIONS AS OF DECEMBER 31, 2021, AND BASED ON THE
6 RECOMMENDATIONS MADE BY THE PLAN'S ACTUARY; PLUS

7 (b) ONE AND ONE-HALF PERCENT MULTIPLIED BY THE YEARS OF
8 SERVICE CREDIT EARNED OR PURCHASED IN THE HYBRID COMPONENT ON
9 OR AFTER JANUARY 1, 2023, MULTIPLIED BY THE AVERAGE OF THE
10 MEMBER'S HIGHEST THREE YEARS' BASE SALARY.

11 **31-31.5-406. Optional survivor benefits.** (1) A MEMBER
12 ELIGIBLE FOR A NORMAL, LATE, OR EARLY RETIREMENT PENSION MAY
13 ELECT TO RECEIVE A REDUCED PENSION PAYABLE TO THE MEMBER AND,
14 UPON THE MEMBER'S DEATH A REDUCED BENEFIT TO THE MEMBER'S
15 DESIGNATED BENEFICIARY. THE BOARD SHALL ESTABLISH SUCH OPTIONS
16 BY RULE IN A MANNER THAT PROVIDES FOR AN ACTUARIAL EQUIVALENT
17 BENEFIT OF THE NORMAL OR EARLY RETIREMENT PENSION OTHERWISE

26 DEATH. PAYABLE TO THE MEMBERS SPOUSE, DEPENDENT CHILD, OR
27 DESIGNATED BENEFICIARY, SUCH REDUCED PENSION SHALL BE PAYABLE

1 TO THE MEMBER'S DESIGNATED. A SPOUSE, DEPENDENT CHILD, OR
2 DESIGNATED BENEFICIARY OF A MEMBER WHO HAS NOT YET REACHED AGE
3 ELIGIBILITY MAY ELECT TO RECEIVE AN ACTUARIALLY REDUCED BENEFIT
4 BEGINNING ON THE DATE THAT THE MEMBER WOULD HAVE REACHED AGE
5 ELIGIBILITY IN LIEU OF A DEATH BENEFIT UNDER PART 8 OF ARTICLE 31
6 AND IN LIEU OF A REFUND OF MEMBER CONTRIBUTIONS PURSUANT TO
7 SECTION 31-31.5-411.

8 **31-31.5-407. Minimum benefit.** (1) IF THE TOTAL AMOUNT OF
9 PENSION BENEFITS PAID UNDER THE LIFETIME BENEFIT COMPONENT AS
10 PROVIDED IN THIS ARTICLE 31.5 AT THE TIME OF DEATH IS LESS THAN THE
11 AMOUNT OF THE MEMBERS' CONTRIBUTIONS TO THE LIFETIME BENEFIT
12 COMPONENT, THE DIFFERENCE SHALL BE PAID TO:

13 (a) THE MEMBER'S ESTATE, IF NO PENSION PAYMENT WAS MADE
14 PURSUANT TO AN OPTION UNDER SECTION 31-31.5-406; OR

15 (b) THE SURVIVOR'S ESTATE, IF PENSION PAYMENTS WERE MADE
16 PURSUANT TO AN OPTION UNDER SECTION 31-31.5-406.

17 **31-31.5-408. Late retirement.** (1) ANY MEMBER RETIRING AND
18 ELIGIBLE FOR A NORMAL OR VESTED RETIREMENT BENEFIT MAY ELECT TO
19 DEFER RECEIPT OF THE PENSION UNTIL ATTAINING AGE SIXTY-FIVE YEARS,
20 BUT NO LATER. IN THE CASE OF SUCH AN ELECTION, THE LATE RETIREMENT
21 PENSION IS THE ACTUARIAL EQUIVALENT OF THE NORMAL RETIREMENT
22 PENSION AS DETERMINED BY THE BOARD.

23 (2) THE BOARD MAY PROMULGATE RULES TO ALLOW MEMBERS
24 WHO ARE ELIGIBLE TO RECEIVE ANY TYPE OF RETIREMENT BENEFITS TO
25 DEFER RECEIPT OF THE BENEFITS TO THE EXTENT PERMITTED UNDER THE
26 FEDERAL "INTERNAL REVENUE CODE OF 1986" AS AMENDED, AND THE
27 REGULATIONS PROMULGATED PURSUANT TO SECTION 401(a)(9) OF SAID

1 CODE.

2 **31-31.5-409. Deferred retirement option plan (DROP).** THE
3 BOARD MAY ESTABLISH BY RULE A DEFERRED RETIREMENT OPTION PLAN
4 FOR VESTED MEMBERS WHO HAVE ATTAINED AGE FIFTY. THE PURPOSE OF
5 THE **DROP** IS TO ALLOW AN ELIGIBLE MEMBER TO ELECT, IN LIEU OF
6 IMMEDIATE TERMINATION OF EMPLOYMENT AND RECEIPT OF A LIFETIME
7 RETIREMENT BENEFIT, TO CONTINUE EMPLOYMENT FOR A SPECIFIED
8 PERIOD OF TIME OF UP TO FIVE YEARS AND TO HAVE THE MEMBER'S
9 OTHERWISE DEDUCTIBLE EMPLOYEE CONTRIBUTION AND RETIREMENT
10 BENEFITS PAID INTO THE MEMBER'S INDIVIDUAL ACCOUNT CREATED BY
11 SECTION 31-31.5-503 UNTIL THE END OF THE SPECIFIED PERIOD OF THE
12 MEMBER'S PARTICIPATION, AT WHICH TIME EMPLOYMENT CEASES.

13 **31-31.5-410. Cost of living adjustments - definitions.** (1) THE
14 BENEFITS PAYABLE UNDER THE LIFETIME BENEFIT COMPONENTS OF THE
15 PLAN MAY BE REDETERMINED EFFECTIVE OCTOBER 1 EACH YEAR. TO BE
16 ELIGIBLE FOR REDETERMINATION, THE BENEFITS MUST HAVE BEEN PAID
17 FOR AT LEAST TWELVE CALENDAR MONTHS PRIOR TO THE EFFECTIVE DATE
18 OF REDETERMINATION.

19 (2) (a) ANY REDETERMINATION OF BENEFITS MADE PURSUANT TO
20 SUBSECTION (1) OF THIS SECTION SHALL BE DETERMINED BY THE BOARD
21 IN ITS DISCRETION AS A FIDUCIARY OF THE STATEWIDE RETIREMENT PLAN
22 AFTER CONSIDERING THE FUNDING LEVEL OF THE LIFETIME BENEFIT
23 COMPONENTS, THE COST OF THE REDETERMINATION, THE COMPONENTS'
24 ABILITY TO FUND FUTURE BENEFITS, AND ANY OTHER FACTORS THAT THE
25 BOARD DEEMS APPROPRIATE. THE REDETERMINED BENEFITS SHALL NOT
26 EXCEED THE GREATER OF:

27 (I) ONE HUNDRED THREE PERCENT OF THE BENEFITS PAID FOR THE

1 PRIOR TWELVE-MONTH PERIOD; OR

2 (II) THE BENEFITS PAID DURING THE PRIOR TWELVE-MONTH PERIOD
3 MULTIPLIED BY A FRACTION USING THE CONSUMER PRICE INDEX FOR THE
4 IMMEDIATELY PRECEDING CALENDAR YEAR AS THE NUMERATOR AND THE
5 CONSUMER PRICE INDEX FOR THE CALENDAR YEAR PRIOR TO THE
6 IMMEDIATELY PRECEDING CALENDAR YEAR AS THE DENOMINATOR.

7 (b) AS USED IN THIS SECTION, "CONSUMER PRICE INDEX" MEANS
8 THE NATIONAL CONSUMER PRICE INDEX FOR URBAN WAGE EARNERS AND
9 CLERICAL WORKERS PREPARED BY THE UNITED STATES DEPARTMENT OF
10 LABOR.

11 **31-31.5-411. Refunds of member contributions.** (1) (a) ANY
12 MEMBER COVERED BY THE STATEWIDE RETIREMENT PLAN WHO
13 TERMINATES SERVICE MAY ELECT TO HAVE THE MEMBER'S ACCUMULATED
14 CONTRIBUTIONS TO ONE OR MORE LIFETIME BENEFIT COMPONENTS OF THE
15 PLAN REFUNDED TOGETHER WITH FIVE PERCENT OF THE MEMBER'S TOTAL
16 ACCUMULATED CONTRIBUTIONS AS INTEREST IN A LUMP SUM AND
17 THEREAFTER SHALL HAVE NO RIGHT TO LIFETIME BENEFITS PROVIDED BY
18 THE PLAN.

19 (b) IF THE MEMBER WHO TERMINATES SERVICE AND RECEIVES A
20 REFUND OF MEMBER CONTRIBUTIONS SUBSEQUENTLY RETURNS TO SERVICE
21 AS AN ACTIVE MEMBER WITH AN EMPLOYER THAT COVERS ITS MEMBERS
22 UNDER THE STATEWIDE RETIREMENT PLAN, THE MEMBER'S PRIOR SERVICE
23 CREDIT SHALL BE RESTORED WHEN THE MEMBER RETURNS THE MEMBER'S
24 REFUNDED CONTRIBUTIONS TO THE LIFETIME BENEFIT COMPONENTS, WITH
25 INTEREST ACCRUED FROM THE DATE OF REFUND TO THE DATE OF RETURN,
26 ACCORDING TO THE TERMS AND CONDITIONS ESTABLISHED BY THE BOARD.
27 IF THE MEMBER FAILS TO RETURN THE CONTRIBUTIONS AND INTEREST, THE

1 MEMBER SHALL BE TREATED AS A NEW MEMBER, AND THE MEMBER'S PRIOR
2 SERVICE SHALL NOT BE RECOGNIZED IN DETERMINING PENSION ELIGIBILITY
3 OR PENSION BENEFITS. THE RESTORATION OF A MEMBER'S SERVICE CREDIT
4 PURSUANT TO THIS SUBSECTION (1)(b) SHALL NOT ENTITLE THE MEMBER
5 TO REINSTATEMENT OF ANY PREVIOUSLY FORFEITED BALANCE IN THE
6 MEMBER'S MONEY PURCHASE COMPONENT ACCOUNT OR THE SEPARATE
7 RETIREMENT ACCOUNT.

8 (2) (a) IF A MEMBER DIES AFTER TERMINATION OF SERVICE, IS NOT
9 ELIGIBLE FOR A VESTED, NORMAL, OR EARLY RETIREMENT, AND HAS NOT
10 YET RECEIVED A REFUND OR BEGAN RECEIVING BENEFIT PAYMENTS, THE
11 ASSOCIATION SHALL REFUND THE MEMBER'S LIFETIME BENEFIT
12 COMPONENT CONTRIBUTIONS TO THE MEMBER'S DESIGNATED
13 BENEFICIARY, SURVIVING SPOUSE, OR DEPENDENT CHILDREN. WHERE
14 THERE IS NO DESIGNATED BENEFICIARY, SURVIVING SPOUSE, OR
15 DEPENDENT CHILDREN, THE REFUND SHALL BE MADE TO THE DECEASED
16 MEMBER'S ESTATE.

17 (b) IF A MEMBER WHO HAS NOT TERMINATED SERVICE DIES, AND
18 THERE IS NO SPOUSE OR DEPENDENTS ELIGIBLE FOR SURVIVOR BENEFITS
19 UNDER PART 8 OF ARTICLE 31 OF THIS TITLE 31, THE DECEASED MEMBER'S
20 LIFETIME BENEFIT COMPONENT CONTRIBUTIONS MAY BE REFUNDED TO:

21 (I) THE MEMBER'S DESIGNATED BENEFICIARY IF THE MEMBER IS
22 NOT ELIGIBLE FOR VESTED, EARLY, OR NORMAL RETIREMENT. THE
23 DESIGNATED BENEFICIARY MAY IN THE ALTERNATIVE ELECT A LIFETIME
24 BENEFIT PURSUANT TO SECTION 31-31.5-406.

25 (II) IF THERE IS NO DESIGNATED BENEFICIARY, THE MEMBER'S
26 ESTATE.

27 (3) THE DESIGNATED BENEFICIARY OF A MEMBER ELIGIBLE FOR

1 VESTED, EARLY, OR NORMAL RETIREMENT SHALL RECEIVE THE BENEFIT
2 DESCRIBED IN SECTION 31-31.5-406 (2) AND NO REFUND OF
3 CONTRIBUTIONS SHALL BE MADE.

4 (4) UPON PAYMENT OF A REFUND OF MEMBER CONTRIBUTIONS, NO
5 LIFETIME BENEFIT COMPONENTS BENEFITS SHALL BE PAYABLE.

6 (5) REFUNDS OF CONTRIBUTIONS TO THE LIFETIME BENEFIT
7 COMPONENTS SHALL NOT BE MADE TO ANY MEMBERS OF EMPLOYERS WHO
8 HAVE FAILED TO REMIT ALL CONTRIBUTIONS REQUIRED UNDER THE
9 PROVISIONS OF THE STATEWIDE RETIREMENT PLAN.

10 (6) A MEMBER OR THE MEMBER'S DESIGNATED BENEFICIARY,
11 SURVIVING SPOUSE OR PARTNER IN A CIVIL UNION, OR DEPENDENT
12 CHILDREN WHO IS ENTITLED TO RECEIVE A REFUND OF THE MEMBER'S
13 DEFINED BENEFIT CONTRIBUTIONS MAY ELECT TO HAVE THE REFUND
14 CREDITED TO THE MEMBER ACCOUNT IN THE MONEY PURCHASE
15 COMPONENT. UPON THE REFUND BEING CREDITED, THE MEMBER OR THE
16 MEMBER'S DESIGNATED BENEFICIARY, SURVIVING SPOUSE OR PARTNER IN
17 A CIVIL UNION, OR DEPENDENT CHILDREN ARE TREATED AS HAVING TAKEN
18 A REFUND FROM THE DEFINED BENEFIT COMPONENT FOR ALL PURPOSES.

21 **31-31.5-501. Vesting.** (1) A MEMBER IS ONE HUNDRED PERCENT
22 VESTED IN THE INDIVIDUAL ACCOUNT IN THE MONEY PURCHASE BENEFIT
23 ACCOUNT PURSUANT TO SECTION 31-31.5-503.

24 (2) EMPLOYER CONTRIBUTIONS MADE TO THE STATEWIDE
25 RETIREMENT PLAN THAT ARE CREDITED TO THE MONEY PURCHASE
26 COMPONENT ACCOUNT ARE SUBJECT TO THE FOLLOWING VESTING RULES:

27 (a) IN THE EVENT OF PERMANENT OCCUPATIONAL OR TOTAL

1 DISABILITY RETIREMENT OR AN AWARD OF A SURVIVOR BENEFIT DUE TO A
2 DEATH OF AN ACTIVE MEMBER PURSUANT TO PART 8 OF ARTICLE 31 OF
3 THIS TITLE 31, A MEMBER SHALL BE ONE HUNDRED PERCENT VESTED IN
4 THE EMPLOYER CONTRIBUTIONS MADE TO THE MONEY PURCHASE
5 COMPONENT ACCOUNT.

6 (b) A MEMBER SHALL BE ONE HUNDRED PERCENT VESTED IN THE
7 EMPLOYER'S CONTRIBUTIONS MADE TO THE MONEY PURCHASE COMPONENT
8 ACCOUNT UPON ATTAINING NORMAL RETIREMENT AGE IF EMPLOYED BY
9 THE EMPLOYER ON OR AFTER THAT DATE.

10 (c) EXCEPT AS PROVIDED IN SUBSECTIONS (2)(a) AND (2)(b) OF THIS
11 SECTION, A MEMBER IS VESTED IN THE EMPLOYER CONTRIBUTIONS MADE
12 TO THE MONEY PURCHASE COMPONENT ACCOUNT IN THE AMOUNT OF
13 TWENTY PERCENT FOR EACH FULL YEAR OF SERVICE PERFORMED FOR A
14 COVERED DEPARTMENT. UPON ATTAINING FIVE FULL YEARS OF SERVICE,
15 A MEMBER IS ONE HUNDRED PERCENT VESTED. VESTING ALSO APPLIES TO
16 EMPLOYER CONTRIBUTIONS ALLOCATED PURSUANT TO SUBSECTION
17 31-31.5-301 (3) OR ALLOCATED UNDER THE PREDECESSOR STATEWIDE
18 DEFINED BENEFIT PLAN PURSUANT TO SECTION 31-31-405.

19 (3) UPON DISTRIBUTION, THE PORTION OF THE MEMBER'S
20 EMPLOYER CONTRIBUTIONS TO THE MONEY PURCHASE COMPONENT
21 ACCOUNT THAT IS NOT VESTED SHALL BE TREATED AS A FORFEITURE.

22 (4) (a) YEARS OF SERVICE IN THE MONEY PURCHASE COMPONENT
23 FOR PURPOSES OF THIS SECTION CANNOT BE PURCHASED BY THE MEMBER
24 OR THE EMPLOYER.

25 (b) A MEMBER WHO ONLY PARTICIPATES IN THE MONEY PURCHASE
26 COMPONENT DOES NOT RECEIVE SERVICE CREDIT FOR PURPOSES OF THE
27 LIFETIME BENEFIT COMPONENTS.

1 (c) FOR MEMBERS WHO PARTICIPATE IN BOTH THE LIFETIME
2 BENEFIT COMPONENTS AND THE MONEY PURCHASE COMPONENT
3 CONCURRENTLY, YEARS OF SERVICE INCLUDE ALL YEARS OF SERVICE WITH
4 THE EMPLOYER WHILE IN THE PLAN OR A PREDECESSOR PLAN, REGARDLESS
5 OF WHETHER CONTRIBUTIONS WERE MADE TO THE MONEY PURCHASE
6 COMPONENT FOR EACH YEAR.

7 (5) A MEMBER WHO IS RESTORED TO ACTIVE SERVICE AFTER A
8 DISABILITY CEASES TO EXIST RECEIVES CREDIT FOR YEARS OF SERVICE IN
9 THE MONEY PURCHASE COMPONENT WITH THE EMPLOYER PRIOR TO THE
10 DISABILITY AS WELL AS TIME WHILE OUT ON DISABILITY.

11 (6) SUBJECT TO RULES ADOPTED BY THE BOARD, YEARS OF SERVICE
12 OF A MEMBER WHO IS EMPLOYED BY SUCCESSIVE EMPLOYERS MAY BE
13 AGGREGATED FOR DETERMINING ELIGIBILITY AND BENEFITS PROVIDED BY
14 THE MONEY PURCHASE COMPONENT OF THE STATEWIDE RETIREMENT PLAN
15 IF THE SERVICE FOR EACH EMPLOYER WAS RENDERED WHILE THE
16 EMPLOYER COVERED ITS MEMBERS UNDER THE STATEWIDE RETIREMENT
17 PLAN, THE PREDECESSOR STATEWIDE DEFINED BENEFIT PLAN, OR THE
18 PREDECESSOR STATEWIDE HYBRID PLAN.

19 **31-31.5-502. Normal retirement age.** THE NORMAL RETIREMENT
20 AGE FOR THE MONEY PURCHASE COMPONENT IS AGE FIFTY-FIVE.

21 **31-31.5-503. Individual accounts - investment and account**
22 **administration.** (1) (a) THE BOARD SHALL CREATE AND MAINTAIN
23 ADEQUATE RECORDS TO DISCLOSE THE INTEREST OF EACH MEMBER AND
24 BENEFICIARY WITH ASSETS IN THE MONEY PURCHASE COMPONENT OF THE
25 PLAN. THE RECORDS MUST BE IN THE FORM OF INDIVIDUAL ACCOUNTS, AND
26 CREDITS AND CHARGES MUST BE MADE TO SUCH ACCOUNTS IN THE
27 MANNER PRESCRIBED BY THE BOARD THROUGH RULEMAKING.

1 (b) THE BOARD SHALL DESIGNATE A RECORD KEEPER RESPONSIBLE
2 FOR THE ADMINISTRATION OF THE INDIVIDUAL ACCOUNTS. THE

10 SELF-DIRECTED INVESTMENT FUND MUST BE ALLOCATED AS DETERMINED
11 BY THE RECORD KEEPER.

12 (2) (a) THE BOARD MAY CREATE AND OFFER TO EACH MEMBER
13 WITH AN INDIVIDUAL ACCOUNT IN THE MONEY PURCHASE COMPONENT
14 VARIOUS INVESTMENT OPTIONS, INCLUDING AT LEAST THREE
15 ALTERNATIVES THAT ALLOW A MEMBER A BROAD RANGE OF INVESTMENTS,
16 DIVERSIFICATION, AND A MEANINGFUL CHOICE BETWEEN RISK AND RETURN
17 IN THE INVESTMENT OF THE MEMBER'S ACCOUNT.

18 (b) (I) ONE HUNDRED PERCENT OF EACH INDIVIDUAL ACCOUNT
19 MAY BE INVESTED AS DIRECTED BY THE MEMBER IN ANY ONE OR A
20 COMBINATION OF THE INVESTMENT OPTIONS. IF A MEMBER OR DESIGNATED
21 BENEFICIARY DOES NOT HAVE A VALID INVESTMENT ELECTION ON FILE FOR

3 PURCHASE ACCOUNT CREATED IN PART 1 OF ARTICLE 31.5 OF THIS TITLE

5 (2) ALL REMAINING DEFINED BENEFITS AND OTHER OBLIGATIONS
6 OF THE STATEWIDE HYBRID PLAN PAYABLE ON AND AFTER JANUARY 1,
7 2023, SHALL BE PAID FROM LIFETIME BENEFITS ACCOUNT OF THE
8 STATEWIDE RETIREMENT PLAN. THE MONEY PURCHASE OBLIGATIONS OF
9 THE STATEWIDE HYBRID PLAN SHALL BE TRANSFERRED TO AND BE
10 PAYABLE FROM THE MONEY PURCHASE COMPONENT OF THE STATEWIDE
11 RETIREMENT PLAN. SAID OBLIGATIONS SHALL BE PAID PURSUANT TO THE
12 STATUTORY PROVISIONS AND RULES ADOPTED BY THE BOARD REGARDING

8 **SECTION 22. Act subject to petition - effective date.** Sections
9 2 through 4, 6, 8 through 19, and 21 of this act take effect January 1,
10 2023, and the remainder of this act takes effect at 12:01 a.m. on the day
11 following the expiration of the ninety-day period after final adjournment
12 of the general assembly; except that, if a referendum petition is filed
13 pursuant to section 1 (3) of article V of the state constitution against this
14 act or an item, section, or part of this act within such period, then the act,
