Bill Summary

Opioid and Other Substance Use Disorders Interim Study Committee. The bill:

- Requires the executive director of the department of public health and environment to convene a stakeholder group to identify, or facilitate the identification of, best practices for operating recovery housing (section 1); and
- Requires the center for research into substance use disorder prevention, treatment, and recovery support strategies to administer a program designed to test innovative models for recovery support services (section 2).

Be it enacted by the General Assembly of the State of Colorado:
