A BILL FOR AN ACT

101 **CONCERNING A SURVEY RELATED TO SCHOOL SAFETY.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. School Safety Committee. The bill requires the school safety resource center to develop a school safety climate survey (survey) to provide school districts, the state charter school institute (institute), and schools with information to evaluate the climate of a school as it relates to school safety.

The bill requires school districts and the institute to administer the survey to school employees who work in schools of the district or institute, students who attend schools of the district or institute, and those

The survey must be conducted every other school year, and the responses to the survey are anonymous. School districts and the institute shall provide the results of the survey publicly online; to the department of education and the school safety resource center; and to each school of the school district or institute. Each school must make the survey results available to school employees and students' parents and guardians.

7 DISTRICT PURSUANT TO PART 1 OF ARTICLE 30.5 OF THIS TITLE 22.

8 (c) "School district" means a school district authorized 9 By Section 15 of Article IX of the state constitution and 10 Organized pursuant to Article 30 of this title 22, and a board of 11 Cooperative services created pursuant to Article 5 of this title 12 22.

13 (d) "School Employee" MEANS A PERSON WHO WORKS IN A
14 SCHOOL AND WHO IS EMPLOYED BY A SCHOOL DISTRICT, THE CHARTER
15 SCHOOL INSTITUTE, OR SCHOOL.

16 (e) "School safety resource center" means the school
17 safety resource center established in section 24-33.5-1803.

18 (f) "SURVEY" MEANS THE SCHOOL SAFETY CLIMATE SURVEY
19 DEVELOPED BY THE SCHOOL SAFETY RESOURCE CENTER PURSUANT TO
20 SECTION 24-33.5-1803 (3)(o).

21 (g) "SURVEY PARTICIPANT" MEANS A PERSON WHO IS INVITED TO
 22 PARTICIPATE IN THE SURVEY.

(2) (a) EXCEPT AS PROVIDED IN SUBSECTION (2)(e) OF THIS
SECTION, BEGINNING IN THE 2020-21 SCHOOL YEAR, AND EVERY OTHER
SCHOOL YEAR THEREAFTER, EACH SCHOOL DISTRICT SHALL ADMINISTER
THE SURVEY TO ALL SCHOOL EMPLOYEES WHO WORK IN A SCHOOL OF THE
DISTRICT, STUDENTS WHO ATTEND A SCHOOL OF THE DISTRICT, AND THE

1 PARENTS OR GUARDIANS OF THOSE STUDENTS.

2 (b) EACH SCHOOL DISTRICT SHALL MAKE THE SURVEY AVAILABLE
3 TO SURVEY PARTICIPANTS IN MARCH OF THE SCHOOL YEAR IN WHICH THE
4 SURVEY IS ADMINISTERED.

5 (c) THE SURVEY IS ANONYMOUS, AND THE DEPARTMENT, EACH
6 SCHOOL DISTRICT, AND EACH SCHOOL SHALL ENSURE THAT THE RESPONSES
7 COLLECTED REMAIN ANONYMOUS.

8 (d) A SCHOOL DISTRICT MAY INCLUDE THE SCHOOL SAFETY 9 CLIMATE SURVEY QUESTIONS AS A PART OF A GENERAL SURVEY PROVIDED 10 TO SURVEY PARTICIPANTS THAT INCLUDES QUESTIONS REGARDING 11 ADDITIONAL SUBJECTS, SO LONG AS THE SCHOOL SAFETY CLIMATE SURVEY 12 QUESTIONS ARE CLEARLY DESIGNATED AND PARTICIPANTS' RESPONSES TO 13 SCHOOL SAFETY CLIMATE SURVEY QUESTIONS ARE COLLECTED 14 ANONYMOUSLY.

15 (e) A SCHOOL DISTRICT IS EXEMPT FROM ADMINISTERING THE 16 SCHOOL SAFETY CLIMATE SURVEY DESCRIBED IN THIS SECTION IF THE 17 DISTRICT ADMINISTERS A DIFFERENT SURVEY THAT PROVIDES THE SCHOOL 18 DISTRICT AND SCHOOLS OF THE DISTRICT WITH INFORMATION TO 19 EVALUATE THE CLIMATE OF A SCHOOL AS IT RELATES TO SCHOOL SAFETY. 20 A SCHOOL DISTRICT THAT DOES NOT ADMINISTER THE SCHOOL SAFETY 21 CLIMATE SURVEY SHALL REPORT THAT TO THE DEPARTMENT AND THE 22 SCHOOL SAFETY RESOURCE CENTER.

23 (3) (a) EACH SCHOOL DISTRICT SHALL:

24 (I) PUBLISH THE RESULTS OF THE SURVEY ONLINE;

25 (II) REPORT THE RESULTS OF THE SURVEY TO THE DEPARTMENT26 AND THE SCHOOL SAFETY RESOURCE CENTER; AND

27 (III) MAKE THE RESULTS OF EACH SURVEY FROM AN INDIVIDUAL

SCHOOL OF THE DISTRICT AVAILABLE TO THE SCHOOL IN WHICH THE
 SURVEY WAS ADMINISTERED.

3 (b) Each school shall make the results of the survey
4 AVAILABLE TO EACH SCHOOL EMPLOYEE AND ANY PARENT OR GUARDIAN
5 OF A STUDENT WHO ATTENDS THE SCHOOL.

6 SECTION 3. In Colorado Revised Statutes, 22-30.5-505, add
7 (21) as follows:

8 22-30.5-505. State charter school institute - institute board -9 **appointment - powers and duties - rules.** (21) THE INSTITUTE SHALL 10 ADMINISTER THE SCHOOL SAFETY CLIMATE SURVEY IN THE MANNER 11 DESCRIBED IN SECTION 22-32-148 (2) TO ALL EMPLOYEES IN EACH 12 INSTITUTE CHARTER SCHOOL, ALL STUDENTS WHO ATTEND AN INSTITUTE 13 CHARTER SCHOOL, AND THOSE STUDENTS' PARENTS AND GUARDIANS. THE 14 INSTITUTE SHALL REPORT THE RESULTS OF THE SURVEY IN THE MANNER 15 DESCRIBED IN SECTION 22-32-148(3).

16 SECTION 4. Act subject to petition - effective date. This act 17 takes effect at 12:01 a.m. on the day following the expiration of the 18 ninety-day period after final adjournment of the general assembly (August 19 5, 2020, if adjournment sine die is on May 6, 2020); except that, if a 20 referendum petition is filed pursuant to section 1 (3) of article V of the 21 state constitution against this act or an item, section, or part of this act 22 within such period, then the act, item, section, or part will not take effect 23 unless approved by the people at the general election to be held in 24 November 2020 and, in such case, will take effect on the date of the 25 official declaration of the vote thereon by the governor.
