
Higher Education Mission & Vision

Strategic Plan for Higher Education

Increase the number of Coloradans benefiting from valuable career skills, obtained while in high school or via postsecondary education, that –at a minimum– enable additional lifetime earnings greater than the cost of attendance.

Three strategic pillars underpin the goal and the opportunities available to institutions, policymakers, and others that affect change.


Pillar #1 Identify and improve pathways with a negative return on investment. Pillar #2 Focus on equity and enable more learners to succeed. Pillar #3 Catalyze increased postsecondary and workforce collaboration, alignment, and co-creation of new pathways that offer a positive return on investment.



Higher Education FY 2023-24 Wildly Important Goals

Cost Containment and Affordability for Learners: Decrease the overall number of students graduating with debt from 45% to 42% by June 30, 2024.

Decrease the average amount of debt per graduating student from \$22,469 to \$21,000 by June 30, 2024.










Higher Education FY 2023-24 Wildly Important Goals

Erasing equity gaps in postsecondary education:

Increase the number of credential completions by students of color and low-income students by 5% by June 30, 2024.



Context: Successful completion of this goal will reduce postsecondary completion disparities that persist across race, ethnicity, socioeconomic status, and geography.


We will achieve this goal through the following leading indicators:

- Expand the number of school counselors (both higher education and high school) who complete the Advisors LEAD training from **568 to 650** by June 30, 2024
 - Currently, **597 counselors** have completed the training

Higher Education FY 2023-24 Wildly Important Goals

Workforce Development: Increase the number of postsecondary programs with a required work-based learning component from 70% to 73% by June 30, 2024.



Context: Successful completion of this goal will further align the postsecondary space to workforce needs and enhance the empowerment of learners of all ages with more agency, intentionality, and flexibility around their education/training choices.



How Higher Education will accomplish the WIGs

We will achieve this goal through the following leading indicators:

- Develop 10 stackable credential pathways by June 30, 2024
 - **SB22-192** improve access to quality credentials of value in the workplace and create greater alignment between credentials and work-based learning
 - CDHE to work with other agencies and stakeholders from industry, K12, and higher education on stackable credential pathways across five highdemand, high-growth industries
 - <u>Recently released report</u> summarizing 6 of 10 pathways in behavioral health, cybersecurity, and education


Higher Education Performance Management






Colorado Talent Pipeline Report

Attainment Value in Colorado's Workforce






2023 ROI Report Highlights: Declining Debt & Bolstered Wages Over Time






Students with Disabilities

- HB22-1255 (CRS 23-79-102) requires CDHE to collect <u>available data</u> of students with disabilities from Colorado IHEs this is the first report year
- According to NCES, **37% inform** their IHE of their disability
- A total of **25,684 (6.6%)** students with disabilities enrolled in AY '23
- CU Boulder reported highest number (**4,629**), University of Denver reported highest percentage (**14.5**%).
- 5.5% of male, and 7.4% of female students were reported as having a disability
