## **Bill Summary**

**Transportation Legislation Review Committee.** The bill prohibits a local government from imposing inspection requirements for

underground petroleum storage tanks or charging inspection fees for the inspection of underground petroleum storage tanks.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, 8-20.5-205, amend

(1) as follows:

8-20.5-205. More stringent requirements prohibited. (1) No municipality, city, home rule city, city and county, county, or other political subdivision of the state shall adopt or enforce any requirement more stringent than the provisions of this part 2. This section does not apply to requirements established pursuant to the uniform fire code or the national fire protection association codes, nor does it BUT A MUNICIPALITY, CITY, HOME RULE CITY, CITY AND COUNTY, COUNTY, OR OTHER POLITICAL SUBDIVISION SHALL NOT IMPOSE INSPECTION REQUIREMENTS FOR UNDERGROUND PETROLEUM STORAGE TANKS OR CHARGE INSPECTION FEES FOR THE INSPECTION OF UNDERGROUND PETROLEUM STORAGE TANKS. THIS SECTION DOES NOT apply to requirements established pursuant to local zoning regulations.

SECTION 2. Act subject to petition - effective date. This act takes effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly (August 9, 2017, if adjournment sine die is on May 10, 2017); except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part will not take effect unless approved by the people at the general election to be held in
