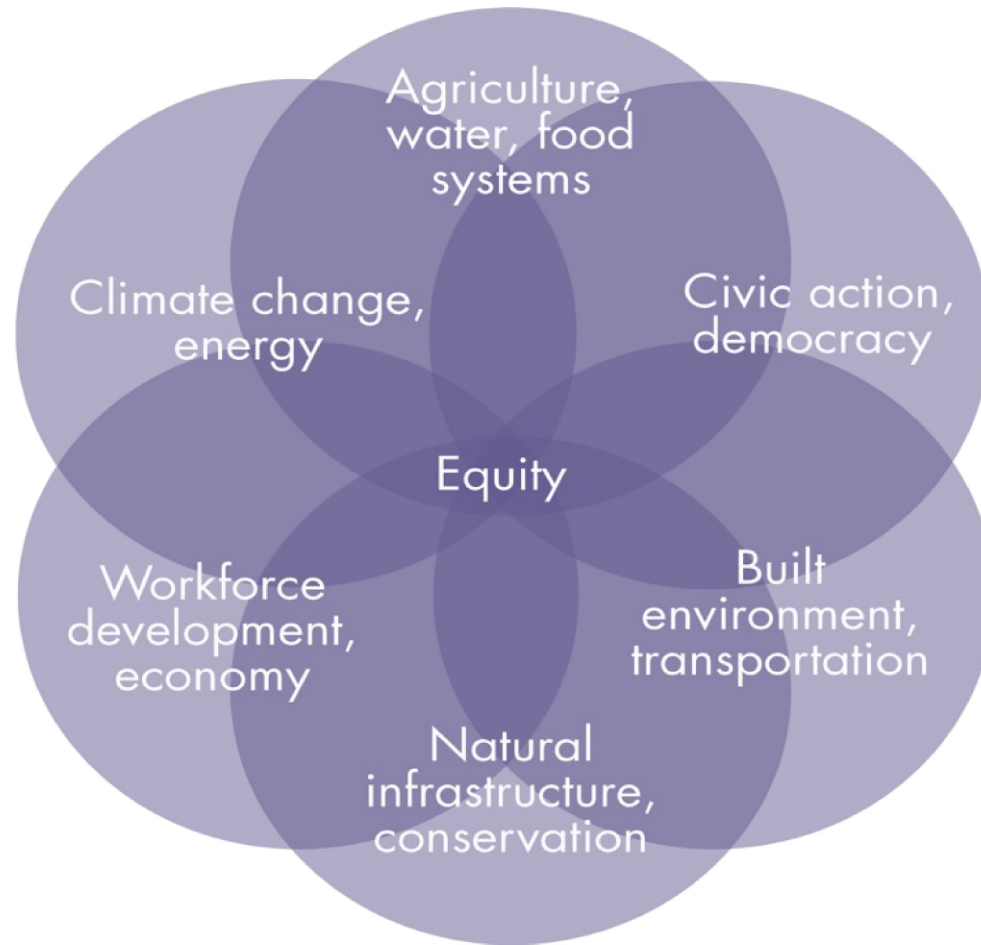

Crowd Sourced Policy



Open call for policy ideas the summer of 2021

- Hundreds of ideas submitted
- 58 policy packages created
- 10 top ARPA recommendations

ARPA Compliance

- (1) To respond to COVID-19 or its negative economic impacts;
- (2) Premium pay for eligible workers;
- (3) For government services to the extent of the reduction in revenue;
- (4) Investments in water, sewer, and broadband infrastructure



Colorado Public Bank

- Establish a large state public bank in Colorado that is owned by and serves Colorado citizens
- Can provide economic recovery during a time of financial recession
- Model after North Dakota's successful public bank instituted in early 1900s

Just Transition for Oil & Gas Communities

- Oil & Gas workers negatively impacted by pandemic
- 21,000 direct jobs in the workforce
- Massive amounts of resources and planning to ensure no one is left behind
- Expand scope of Office of Just Transition

Investments in Resilient Infrastructure and Workforce

- Address job losses and workforce opportunities through expanding the clean energy sector
- Prepare Colorado economy for incoming energy transition
- Create high-paying, dignified jobs

Air Quality Investments

- Improve circulation of air in buildings to reduce COVID-19 transmission
- Studies show correlation between high air pollution rates and comorbidities that make people more at risk from COVID-19

Racial Equity

- Support for communities who have experienced outsized impacts from COVID-19 pandemic
- Dedicated funds to support upward economic mobility, access to resources, and representation in key decision making bodies
