The vice-chair called the meeting to order and welcomed fellow members of the task force.

1:02 PM: Presentation from Council on State Taxation

Stephanie Do and Fred Nicely, representing the Council on State Taxation, presented to the committee on sales and use tax base extension. Their presentation may be found here:

Ms. Do and Mr. Nicely began their presentation by discussing the principles of good taxation. They noted that the largest share of the tax burden on state and local businesses are property taxes with sales and use tax coming in second. Mr. Nicely also discussed how services have grown as a share of total personal consumption. Mr. Nicely responded to several task force questions regarding the methodology of data in the tax burden study.

Ms. Do continued by discussing existing challenges with expanding the sales tax base including the lack of uniformity amongst the states. They continued by discussing the SSUTA and that one of the major impediments to sales tax modernization is avoiding taxation on business inputs. They continued by discussing sales taxation of digital commerce and manufacturing and resale. They provided several examples of states that have expanded their sales tax base and highlighted several issues those states faced.

The task force had a robust discussion on several topics including a value added tax, economic tax theories, taxing philosophy, and data collection.
