SUMMARY

The project updates a pair of elevators serving two buildings by replacing the elevator controllers, door operators, operating panels, lamps, and fixtures, along with the wiring for these elevators. The project also upgrades the finishes in the elevator cabs. The elevator in Noble Hall recently experienced a five-month outage due to a failed processing board. The elevator in Concert Hall is currently not in service due to equipment obsolescence, diminishing ADA accessibility.

REASON FOR WAIVER

The college says contract reviews have slowed the process of encumbering the appropriation and moving forward with the project. The college provided its chosen contractor with a draft contract in mid-November, which is still under review by the contractor's legal department. Once it is approved by the contractor, the Attorney General will need to review the contract on behalf of Fort Lewis before it is executed.

SUMMARY

The five-phase project replaces fire alarm panels in ten buildings on campus. The existing panels are approaching obsolescence and replacement parts are difficult to obtain. This year's request for Phase III replaces the panels in the Art and Design and Noble Halls, while Phases IV and V will replace panels in Skyhawk Hall, Physical Plant Services East, and the Education Business Hall. Phase I conducted design work and replaced panels in Reed Library and Jones Hall. Phase II replaced panels in the Community Concert Hall, the Center of Southwest Studies, and Kroeger Hall.

REASON FOR WAIVER

The college says contract reviews have slowed the process of encumbering the appropriation and moving forward with the project. The college sought to amend its existing contract with the contractor in mid-September, and subsequent negotiations lasted until mid-November. Further contract review resulted in a contract amendment being signed in mid-December.
