 - Engagement with Colorado legislators during and after Justice Action Network Foundation convening in October.
 - Paul Pazen (retired) Denver Police Chief sat on a panel on violent crime and clearance rates to share insights from the Denver PD FAST unit at CSG National in Raleigh.
