The chair called the meeting to order and welcomed fellow members of the task force.

2:00 P.M. – Facial Recognition in Colorado Schools

Former Senator Brandon Shaffer, Richard Peebles, and Mai Vu, representing St. Vrain Valley Schools, presented to the task force on facial recognition and its use in Colorado schools.

Senator Shaffer began by discussing current laws in Colorado related to the use of facial recognition schools. He continued by highlighting specific educational privacy laws and Colorado Schools Public Contract Acts. He noted that are several exemptions to the current ban on the use of facial recognition in schools, but that those exemptions may need to be expanded. Senator Shaffer discussed the possible need for additional exemptions such as exigent emergency circumstances and classroom curriculum use.

Ms. Vu continued by highlighting artificial intelligence (AI) and machine learning in public schools. The task force watched a video presentation. She also discussed the use of technology for social and emotional learning as well as facial sensing, detection, and recognition. Mr. Peebles continued by discussing the use of facial recognition for school safety. Task Force Member Matt Cook noted that, as there are 178 school districts in Colorado, the use of facial recognition varies widely.

Task force discussion ensued on ChatGPT, parental permission, data retention, and misidentification.

2:55 P.M. – Artificial Intelligence Deepfake Issues

Ms. Heather Morton, representing the National Conference of State Legislatures (NCSL), presented to the artificial intelligence and deepfake issues. She began by discussing deepfakes and how they are created. She continued by discussing online impersonation state statutes. She noted that few states have specific online impersonation laws. A handful of states have specific deepfake laws with civil or criminal penalties. She noted that there are five bills pending in state legislatures related to watermarking and disclosure requirements (separate from election-related bills).

She continued by discussing the use of deepfake in campaigns and elections. She noted that some states have laws related to misrepresentation related to candidates or referendums, but the majority of states do not have specific laws related to the use of deepfake in elections.

Committee discussion ensued on the effectiveness of the state laws, enforcement provisions, first amendment considerations, and watermarking and disclosure.
