#### **RUU IT CC Business Case**

- Electronic Citation capability to reduce the duration of time required for troopers and citizens exposed to roadway dangers during issuance of traffic citations.
- Comprehensive records management system capabilities to support case file management as well as integrate numerous standalone law enforcement records system functions, that are housed in legacy SharePoint, Spreadsheet and Forms data systems.
- It is imperative to advance the integration and interoperability across the single point systems to reduce the complexity facing CSP law enforcement and professional staff that rely on the information across multiple information systems on a daily basis.


## Four Phases: RUU IT CC Project

"Phases" provide stakeholders a defined path/budget that is more readily understood in a logical and linear description

- Phase 1: Blueprint and Roadmap, Systems (Current and Future State)
- Phase 2: eCitation Capability (Cloud Mobile Native, Tier 1 LEA Capable)
- Phase 3: RMS Replace (FRAE) (Cloud Mobile Native, Tier 1 LEA Capable)
- Phase 4: Unified Intelligence (Analysis, Fusion, Reporting) Leverage 1-3

# Phase 1: Blueprint & Roadmap

- Baseline the CSP current catalog of information systems, in size, activity level, interfaces, vintage, sustainability and suitability in the Colorado network operating environment and OIT standards guidelines
- Technology Roadmaps focus on future technology needs, and the necessary steps to meet them. This roadmap aligns technology selection with business aims, to support a well-articulated technology strategy

- SIPA vendor selected: Slalom Consulting. Onboard complete at end December 2024
- Pre-staged CSP discovery data is ready for Slalom Consulting analysis in January 2025

# Phase 2: eCitation Capability

- The CSP is completing a planning effort with an expert consultancy that started July 2023. This informs all phases of the RUU project with Mission Needs Analysis, Requirements and Functional Specifications. To finalize: January 2025
- This preparation allows expedient selection, procurement and award for rapid onboarding of the Phase 2 eCitation vendor at the start of FY 2026 (July 1, 2025)
- In concert with the Phase 1 Blueprint and Roadmap deliverable that outlines requirements and standards for CSP system architecture and Colorado network compatibility that must be provided by a selected eCitation capability provider.
