Tough Fire Season Takes Toll on Firefighters' Mental Health

A Disturbing Trend

- Firefighters are more likely to die from suicide than in the line of duty
 - Ruderman Family Foundation, 2018
- Wildland firefighters at higher risk of suicide than urban couterparts
 - Stanley, Hom, Gai, Joiner, 2018
- Firefighters face higher odds of experiencing depression, stress, PTSD, and suicide attempts/suicidal thoughts than the general public
 - Stanley, Boffa, Hom, Kimbrel & Joiner, 2017



Data is Scarce - Stories are Plenty

"Even your 30 year veterans, they're being brought to their knees by the stuff we're seeing that's atypical in our careers"

"Climate change is completely obliterating all the parameters that they used to live within"

"I lived in denial, then fear, then self medicated"

"It was hard to find joy in general. It's hard for that not to start to become your own internal personal identity. It's exhausting"

Unique Challenges Firefighters Face

- Traffic Incidents and Medical Calls with Injured Victims
- Seasonal Wildland Firefighters Employment Ending (losing support network, busy to cold turkey)
- Compounding Experiences with Little Time to Process
- Victim Interactions (e.g. Smokey Top 2 Fire, Remnants of Burned Down Homes)
- Time Away from Home and Family (2 Week Fire Assignments)

- Peer Support Program
- Six Counseling Sessions with Professional Trained in First Responder Mental Health
- Colorado State Employee Assistance Program
- Firefighter Safety and Disease Prevention Grant (for Local Fire Agencies)
- Responder Strong, Foundation 1023 (Nonprofits dedicated to Firefighter Mental Health)
