Medicaid Enterprise Services (MES) Procurement Quarterly Update Why do we need to do this?

• State and Federal Regulations are that a contract maximum term is 10 years (including 2 extensions).

The Department executed contracts with core MMIS vendors which expire in 2025:

Gainwell: Medicaid Management Information System (MMIS)

IBM: Business Intelligence Data management (BIDM)

Magellan: Pharmacy Benefits Management System (PBMS)

24 months prior approval planning from CMS is minimum required for these procurements

The Department executed contract with CBMS vendor expires in 2026:

Deloitte: Colorado Benefits Management System (CBMS)




Colorado's Medicaid Enterprise Services (CMES) Procurement Update

- On December 4, 2015, CMS published a final rule at 80 FR 75817-Medicaid Program; Mechanized Claims Processing and Information Retrieval Systems (90/10). This final rule updated the CMS standard and conditions to include the standard and condition for modularity, which requires states to meet in order to receive enhanced federal match for development, maintenance and operations.
- Under the revised rule 42 CFR Part 433, Subpart C Mechanized Claims Processing and Information Retrieval Systems, CMS requires states to follow a modular approach that supports timely, cost-effective projects.




Colorado's Medicaid Enterprise Solutions (CMES) Procurement Update







Colorado Medicaid Enterprise Solutions (CMES) Ecosystem

CMES Procurement Year 1 Update Quarterly Update Questions 1 & 3

- Overall implementation is on schedule.
 - There are no delays the Department did not account for in the timelines for contract award dates and contract finalization.
- In the next quarterly update, the Department expects contracts will be finalized and have been submitted to CMS for approval.



CMES Procurement Year 1 Update Quarterly Update Question 4

- Reviewed 43 proposals across 17 different modules
- Entered into negotiations with 11 different vendors
- Awarded 13 of the 17 modules and continue negotiations with the remaining 4
- 9 of 13 awarded modules will be transitioning to new vendors
- Finalizing contract scope and price of the 13 awarded modules, anticipating contract executions by June 2024
- Remaining 4 modules expected to be awarded by January 2024
- Based on current schedules, the Department anticipates that the full project will be complete by June 2025, with some modules anticipated to be completed in 2024.

CMES Procurement Year 2

FY 24/25 budget request is a continuation of last

- year's funded project—this will be the final request.
- 90/10 FFP has been approved by CMS
- FY 2024-25 Budget Impact: \$36,865,695 in Total Funds, including \$4,239,554 in Capital Construction Fund
- FY 2025-26 Budget Impact: \$0 in Total Funds, including \$0 in Capital Construction Fund



CMES Procurement Year 2

- Continuation of request to implement transition
- Enterprise Testing Vendor
 - Support Department in End to End testing across modules/vendors
 - Automated testing tools
- Additional Resources
 - Term limited FTE to support operations (4)
 - Contracted Technical Resources (28)

CC-IT-02: CBMS Re-Procurement



Colorado Benefits Management System (CBMS) Procurement

First of a multi-phase request:

- FY 2024-25 Budget Impact: \$1,705,158 in Total Funds, including \$318,028 in Capital Construction Fund
- FY 2025-26 Budget Impact: TBD, fiscal impact of future phases will be determined in a future budget cycle

Re-Procurement will be modularized to continue to receive CMS-enhanced matching funds.



CBMS Procurement

- This funding request is for resources to assist the Department in drafting requirements for the ITNs

 Utilizing lessons learned from CMES procurement current underway.
- Supplementing HCPF staff with contracted resources, due to need for HCPF staff focus on critical priorities such as the Public Health Emergency unwind
