Severance Tax 2020 Distributions Report Per Colorado Revised Statute 39-29-110 (3)

2020 Annual Report - Severance Tax Fund Distribution

In accordance with Colorado Revised Statute Title 39, Taxation, Specific Taxes, Severance Tax 39-29-110 (3) which states in part,

“The executive director of the department of local affairs shall deliver to the state auditor and file with the general assembly annually before February 1 a detailed report accounting for the distribution of all funds for the previous year. The energy impact assistance advisory committee shall review the report prior to it being delivered and filed.”

The Colorado Department of Local Affairs (DOLA) hereby submits the aforementioned report for calendar year 2020 in response to this statutory requirement. Below is a summary of 2020 calendar year distributions from severance dollars through both discretionary grants (awards), formulaic direct distributions and loans made by DOLA. In summary, \$62,902,708.73 was distributed between January 1 and December 31, 2020.

In addition, with the passing of House Bill 16-1141 beginning State Fiscal Year 2016-2017, the Uranium Mill Tailings Remedial Action Oversight Committee was repealed. As a result, distributions from severance grant dollars that may have been reported through this Committee to the General Assembly has ceased. The Department of Local Affairs annual report now includes the distribution of those funds to the Colorado Department of Public Health and Environment (CDPHE) from the Local Government Mineral and Energy Impact Grants and Disbursements line. For 2020, \$328,671.00 in severance funds were distributed to CDPHE for purposes of the Uranium Mill Tailings Remedial Action Program.
