Taskforce wanted to clarify that this bill does include individuals transitioning out of state mental health institutions

Bill 5: Rental applications

Already voted on this one, but have amendments that are being sent through drafters. The following language was rough draft for a starting point:

- -Page 4: add subsection c, as of 5 years from date of conviction
- -Definitions: Criminal history only includes conviction, shall not include arrests that do not result in conviction nor successfully completed deferred judgements
- -Definition of rental application fee: reasonable and covering cost only to administrative or evaluative process (page 4 line 11)
- -Upon request of a potential tenant, a written notice for reason of denial shall be given within 5 days
