The Mental Health Hold Task Force was created to examine the issues of concern regarding mental health (M-1) holds in Colorado. Guest speaker Ryan Templeton, Office of Behavioral Health, described the final recommendations issued by the Mental Health Hold Task Force. These are the final recommendations:

- End the Use of Law Enforcement Facilities for M-1 Holds
- Streamline Regulations and Establish a Stronger System of Accountability.
- Establish a Tiered System for Carrying Out M-1 Holds
- Ensure Network Adequacy
- Expand and Extend the Behavioral Health Workforce
- Create a Sustainable and Reliable Data Monitoring System
- Ensure Proper Payment for Treatment of Individuals on Mental Health Holds
- Identify and Pilot Client Transportation Solutions that Reduce the Costs, Stigma, and Trauma Associated with M-1 Transport

A general question and answer discussion occurred after the presentation to include law enforcement issues, emergency departments, and insufficient data regarding M-1 holds. There was discussion regarding Justice and mental health collaboration opportunities which mostly funds programs the data group could try to fund a communication system that would provide continuity of care.

#### VIII. Behavioral Health Transformation Council (BHTC) Update

The Smart Act presentation was on January 9, 2017. A facilitator was hired to frame the scope of work for BHTC. The reporting structure for BHTC will need to be reviewed and corrected as the Governor's Behavioral Health Cabinet no longer exists.

This \$16 million dollar request would be for Permanent Supportive Housing and providing safe transition for those coming from the institute and needing wraparound services.
