

OEDIT Organizational Chart








Equity, Diversity, and Inclusion

In accordance with the Governor's Executive Order <u>2020 175</u>, the Department has implemented the following efforts in accordance with its equity, diversity, and inclusion plan:

- Partner Outreach Program
 - Collaborating with trusted leaders of under-resourced communities to conduct grassroots outreach to communicate available OEDIT funding and business support programs.
- Intentionally Inclusive Idea (i3)
 - Dedicated team creating internal resources for program managers to assist in designing inclusive and accessible programs.
- IDEA Committee
 - Building a strategic plan in order to address several external and internal improvements such as identifying and addressing factors deterring under-resourced communities' from engaging with OEDIT, integrating IDEA values across all 14 divisions, improving hiring and retention protocols, and measuring equity in OEDIT's programming.
- Improved Marketing and Communications
 - OEDIT's Small Business Accelerated Growth Market Research program integrated marketing campaign generated 700+ applications (including 239 Spanish language) from a wide range of constituencies and garnered earned media across the state
 - Increasing language accessibility.
- Community Business Preservation Program
 - Provides grants and consulting support to groups of culturally similar businesses that are facing displacement pressures. There
 is an added preference for businesses in economically disadvantaged areas.



Opportunity Now Update, HB22-1350

Phase 1 Highlights:

- 425 Applications were received from over 1K education and industry partners.
- Opportunity Now awarded \$27 million in grants to 46 grantees across all 14 economic regions.
- Grantees anticipate serving nearly 10K Coloradans, with more than 3K individuals placed into Colorado's most in-demand industries: infrastructure/construction, health care, education and early childhood.

Phase 2 & 3 Progress:

- Phase 2 will award approximately \$50 million in funding. We plan to announce Phase 2 grantees in March 2024.
- Phase 3 will award the remaining \$8-10 million. Application will launch in August 2024, and grantee announcements will be made in November 2024.

OEDIT Housing Programs Update

The Innovative Housing Incentive Program (IHIP) HB22-1282, supports the development and expansion of the state's innovative housing manufacturing businesses through grants and loans.

- Performance based funds launched December 2022
 - Nine businesses approved for a total of \$8.9M (5 modular, 3 panelized & 1 3D printed)
 - To date \$837,000 disbursed incentivising 173 units
- IHIP loan program closed November 2023 (combined with Prop 123 Modular Loans)
 - 16 applications received, requesting \$89 million. OEDIT, CHFA & DOLA are finalizing the selection, awards will be announced this month. IHIP & Prop 123 Modular loan programs are expected to finance over 4000 units a year for the next 3 years.



OEDIT Housing Programs Update Cont.

The **Middle Income Housing Authority** (MIHA) SB22-232 & SB23-035, is a special purpose authority, authorized to acquire, rehabilitate, construct, finance, own and operate affordable rental housing projects for middle-income workforce housing. MIHA received \$1 million in 2022 for start up assistance.

- MIHA is authorized to issue tax free revenue bonds for projects. Bonds will be sold at market rates.
- Contracted with OEDIT for administrative services, and Sierra Mgmt Group as the Financial Advisor.
- Conditionally selected six projects/994 units, projects teams are seeking gap funds to fill project funding gaps.

Program Updates:

• High interest rates and construction costs are some of the challenges facing the middle-income housing market. Current MIHA projects have a range of funding gaps. MIHA will be accepting project proposals again in February.



OEDIT Housing Programs Update Cont.

State Affordable Housing Financing Fund (Prop 123) OEDIT is working with program administrator CHFA, to implement the first year of Prop 123 programs. 1/2 of regular annual funding was available for FY24 (\$96 million). Program updates:

- Land Banking (\$24.5 million available)
 - Launched July 2023 / 113 applications received / \$256 million requested in total
 - Awards announced in late January / Estimated 21 projects / 1380 units
- **Concessionary Debt** Low & middle income multifamily rental (\$14 million available)
 - Launched September 2023 / 38 applications received / \$113 million in requests
 - 7 project with 722 units are in underwriting
- **Concessionary Debt** Modular (\$18 million available) One time investment to boost modular housing supply
 - Launched in October with IHIP Factory Loan Program / 7 applications received (Prop 123) / \$25 million requested
 - Final selection being finalized / 4000 units annually estimated
- Equity (\$38.7 million available) Launch planned in February / 300 units estimated



Community Revitalization Grant, SB21-252 & HB22-1409

- This grant supported creative projects that combined creative industry workforce housing, commercial spaces, performance space, community gathering spaces, child care centers, and retail partnerships for the purpose of economic recovery and diversification by supporting creative sector entrepreneurs, artisans, and community non-profit organizations.
- Community Revitalization Grants and its partners are generating 748 affordable housing units while elevating the arts across the state.
- 59 total projects were awarded through \$98M in awards from two legislative appropriations and additional ARPA funding. In total:
 - 56% are located in rural areas
 - 40% are located in Opportunity Zones
 - 85% include energy efficiency improvement or renewable energy




Community Revitalization Grants Update



Loveland Feed and Grain (\$5 million): This completes the Artspace Loveland Arts campus by redeveloping the historic Feed & Grain into affordable live/work housing for creatives and 6,000 square feet of sustainable commercial space. The grant funding will provide 39 units of live/work space for artists and creative sector workers.




COLORADO Office of Economic Development & International Trade **SPMDTU (\$1.076 million):** the grant will complete the structural stabilization, restoration and rehabilitation of the Sociedad Protección de Trabajadores Unidos (SPMDTU) Concilio Superior building in Antonito, Colorado. It is the oldest active Hispanic organization in the U.S.





State Small Business Credit Initiative (SSBCI) Update

- Authorized under the American Rescue Plan Act of 2021, administered by US Treasury.
- Implemented through Economic Development Commission.
- Application approved to fund the CO Venture Capital Authority, the CLIMBER Loan Fund, and Cash Collateral Support programs increasing access to capital for small businesses and socially and economically disadvantaged individuals.
- Capital received in 3 tranches. OEDIT will request tranche 2 in Q1-2, 2024.






Small Business COVID-19 Grant Program Update

- Overview of Small Business COVID-19 Grant Program
 - The grant program put more than \$25 million into the hands of small business owners who had been hard hit by restrictions enacted to stem the spread of COVID-19.
 - The program launched on August 1, 2020 through a collaborative effort led by the Colorado Office of Economic Development and International Trade (OEDIT), the Colorado Housing and Finance Authority (CHFA), and Energize Colorado.
 - There was significant diversity in grant awardees across the state.

2023 Talent Pipeline Report

The 2023 Talent Pipeline Report was published on Dec. 15, 2023. The report identifies:

- Top jobs & critical industries
- Key features of the current labor force
- Strategies to align supply with industry demand

Policy Recommendations:

- Strengthen support for employers' talent development.
- Increase the availability of career-connected learning opportunities.
- Establish a statewide longitudinal data system.
- Invest in high-impact opportunities.
