AN ACT

**CONCERNING THE CREATION OF LOCAL ADVISORY BOARDS FOR STATE AND VETERANS NURSING HOMES
IN THE DEPARTMENT OF HUMAN SERVICES.**

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. Part 1 of article 12 of title 26, Colorado Revised Statutes, is amended BY THE ADDITION OF A NEW SECTION to read:

26-12-121. State and veterans nursing homes - local advisory boards - repeal. (1) THE STATE BOARD, WITH INPUT FROM THE DIVISION WITHIN THE STATE DEPARTMENT THAT IS RESPONSIBLE FOR STATE AND VETERANS NURSING HOMES, SHALL PROMULGATE RULES TO ESTABLISH THE REQUIREMENTS AND PROCEDURES GOVERNING THE CREATION AND OPERATION OF LOCAL ADVISORY BOARDS AT EACH OF THE STATE AND VETERANS NURSING HOMES WITHIN THE STATE DEPARTMENT LOCATED IN HOMELAKE, FLORENCE, TRINIDAD, RIFLE, AURORA, AND WALSENBURG, COLORADO.

(2) EACH LOCAL ADVISORY BOARD SHALL CONSIST OF AT LEAST FIVE MEMBERS. AT LEAST ONE OF THE MEMBERS SHALL BE A RESIDENT OF THE STATE NURSING HOME OR VETERANS NURSING HOME OR A PERSON WHO, AT THE TIME OF HIS OR HER APPOINTMENT, IS A FAMILY MEMBER OF A RESIDENT OF THE NURSING HOME.

(3) (a) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2017.

(b) PRIOR TO REPEAL, THE LOCAL ADVISORY BOARDS APPOINTED PURSUANT TO THIS SECTION SHALL BE REVIEWED AS PROVIDED IN SECTION 2-3-1203, C.R.S.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.

SECTION 2. 2-3-1203 (3), Colorado Revised Statutes, is amended BY THE ADDITION OF A NEW PARAGRAPH to read:

2-3-1203. Sunset review of advisory committees. (3) The following dates are the dates for which the statutory authorization for the designated advisory committees is scheduled for repeal:

(dd) JULY 1, 2017: EACH OF THE LOCAL ADVISORY BOARDS FOR STATE AND VETERANS NURSING HOMES, CREATED IN SECTION 26-12-121, C.R.S.

SECTION 3. Effective date. This act shall take effect July 1, 2007.

SECTION 4. Safety clause. The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
