INTRODUCTION

C.R.S. 17-33-101 (b) states the following:

The Department shall track the long-term recidivism rates of persons who were formerly incarcerated who participated in reentry services and programs. The department shall provide data on all individuals who participate in reentry services and programs regarding:

- (I) The type and level of offense of the controlling sentence;
- (II) Length of the controlling sentence;
- (III) Risk of re-offense based on a risk assessment instrument validated for individuals on parole;
- (IV) Number of individuals in prison past the individual's parole eligibility date;
- (V) Number of individuals grants discretionary parole at the individual's first parole application hearing;
- (VI) Number of individuals granted discretionary parole at any subsequent parole application hearing;
- (VII) Number of individuals released at mandatory release date;
- (VIII) Recidivism at six months, one year, two years, and three years following release, disaggregated by whether the return to prison was the result of a new conviction, including the type and level of offense, or only for a violation of a condition of release; and
- (IX) For sections (I) through (X) the data must be disaggregated by race and gender

The following data provided by the Colorado Department of Corrections includes reentry data specific to the Work and Gain Education and Employment Skills (WAGEEs) program. Electronic data was not collected by the Latino Coalition until November 6, 2018. The data provided includes all individuals who participated in WAGEEs from November 6, 2018 – July 13, 2023. The list of individuals was provided directly by the Latino Coalition. All recidivism data is broken down by calendar year.






