Committee Charge

Pursuant to Section 2-3-1602, C.R.S., the Wildfire Matters Review Committee is charged with reviewing and proposing legislation or other policy changes related to wildfire prevention, mitigation, and related matters, including public safety and forest health issues. Senate Bill 13-082 created the committee and <u>Senate Bill 18-039</u> extended the repeal date of the committee to September 1, 2025. <u>Senate Bill 21-012</u> added a requirement for the committee to review policy changes to maximize the utilization of wildland fire services through the inmate disaster relief program.

Committee Activities

The committee held five meetings during the 2024 interim and took one field trip. Briefings and presentations were made by state agencies, special interest groups, and members of the public on a wide range of subjects, including statewide mitigation efforts, wildfire response, and workforce issues. The following sections discuss the committee's activities during the 2024 interim.

Statewide Mitigation Efforts

State agency efforts. The Department of Natural Resources (DNR) presented on mitigation programs they administer, including the Colorado Strategic Wildfire Action Plan (COSWAP); the use of the Department of Corrections (DOC) State Wildland Inmate Fire Team (SWIFT) crews; and projects initiated through the Colorado Water Conservation Board (CWCB) as part of the Wildfire Ready Action Plan. The Colorado State Forest Service (CSFS) also presented on forest management activities and mitigation programs it administers, including the Forest Restoration and Wildfire Risk Mitigation (FRWRM) program and the operation of the CSFS tree nursery. Both the CSFS and the Colorado Tourism Board presented on wildfire public outreach efforts.

Forest health. A variety of state agencies and special interest groups presented on forest health, highlighting the impact wildfires have on forests and the many forest types in the state. Difficulties in managing forests that span multiple land ownership categories were addressed. Strategies, methods, and technologies for forest health management and cross-jurisdictional collaboration were also discussed. A common theme was investment in mitigation activities as an effective method to reduce the overall impact of wildfires.

Prescribed fires. The use of prescribed fires as a mitigation tool was discussed by stakeholders. These groups highlighted challenges and barriers to the effective use of prescribed fires as a mitigation tool. State agencies also presented on prescribed fires, including the Colorado Fire Commission.

Committee recommendations. As a result of its discussions, the committee recommends Bill E, which concerns prescribed fires. The committee also recommended that a bill on modifying the natural disaster mitigation enterprise be drafted, but the draft bill was not approved by the committee.

Wildfire Response

Local government efforts. Several local government entities presented on emergency response to wildfires. Methods for effective emergency communications to residents were highlighted, as well as issues with safe evacuation of areas impacted by wildfires. Language access issues regarding emergency communications were also discussed.

State agency efforts. The Department of Public Safety (CDPS) and its Division of Fire Prevention and Control (DFPC) presented on wildfire response by the state. The availability of additional state-owned aviation resources was highlighted as having a positive impact on wildfire response in the current wildfire season. The increasing use of sophisticated technology to predict and respond to wildfires was also discussed.

Impacts to the public. Both state agencies and special interest groups presented on how wildfire impacts the public. The Colorado Department of Public Health and Environment (CDPHE) and the Center for Improving Value in Healthcare (CIVHC) presented on public health impacts of wildfires, including smoke pollution and ground-level ozone generated by wildfires.

The Colorado Division of Insurance and other insurance industry stakeholders presented on the persistence of availability and affordability challenges for home insurance coverage.

Committee Recommendations. As a result of its discussions, the committee recommends Bill A, which concerns the use of artificial intelligence in wildfire response, Bill B, which concerns access of private land during wildfire evacuations, and Bill D, which concerns the creation of a statewide wildfire information and resource website. The committee also recommended bills on emergency power shutoff guidelines and mobile home park preparedness, but these bill drafts were not approved by the committee.

Workforce Issues

Firefighting workforce. The committee heard about how firefighting workforce challenges impact wildfire management. The Colorado Fire Commission indicated a need for additional firefighting staff across the state to meet a growing service demand, including both full-time and volunteer firefighters. Recruitment and retention for these positions is especially difficult in rural areas. Additionally, a need for expanded training and certification opportunities for current firefighters to allow for career development was expressed.

Wildfire management workforce. Both the CSFS and the Colorado Fire Commission mentioned challenges with the workforce that supports wildfire management other than direct response. Mitigation activities on publicly owned land are hindered by a lack of forestry workforce. Prescribed fires on privately owned land are underutilized due to a similar lack of workforce that specializes in these activities.

Federal wildfire management. U.S. Representative Brittany Pettersen presented on federal wildfire management. As wildfire frequency increases not only in Colorado but also other states, federal wildfire resources are stretched thin. Although federal resources are still available for wildfire management, this dynamic means that the state may need to rely more heavily on its own resources in the future. A representative from the federal Wildland Fire Mitigation and Management Commission presented a summary of recommendations from the commission's most recent report.

Committee recommendations. As a result of its discussions, the committee recommends Bill C, which concerns workforce development in firefighting and other wildfire management professions.

Field Trip Activities

The committee took a field trip to Jefferson and Grand Counties. The trip included:

- a presentation of a sand-table simulator for wildfire response by the Jefferson County Sheriff's Office;
- a round table discussion with Jefferson County officials and community stakeholders on mitigation efforts;
- tour of the Alderfer/Three Sisters Park area highlighting recent mitigation projects;
- a presentation by Grand Fire Protection District on the response and recovery to the East Troublesome Fire in 2022; and
- a tour of sites near Grand Lake that were affected by the East Troublesome Fire.

Summary of Recommendations

As a result of the committee's activities, the committee recommended five bills to the Legislative Council for consideration in the 2025 session. At its meeting on October 15, 2024 the Legislative Council approved the recommended bills for introduction. The approved bills are described below.

Bill A — Applying Artificial Intelligence to Fight Wildfire

The bill requires the General Assembly to appropriate \$7.5 million in FY 2025-26 to the Division of Fire Prevention and Control in the Department of Public Safety. This appropriation is to study, develop, or contract for applications of artificial intelligence to assist in fighting wildfires. This appropriation may be spent through FY 2026-27.

Bill B — Landowner Immunity for Emergency Access to Property

The bill provides immunity from civil liability for damage or injury to persons or property that to landowners that allow access through their property during emergencies. Immunity is not granted when damage or injury arises from gross negligence or willful misconduct caused by the landowner.

Bill C — Forestry & Firefighter Workforce & Education

The bill authorizes the creation or expansion of certain forestry and firefighter workforce and education programs administered by Colorado State University and the Department of Public Safety.

Bill D — Wildfire Information & Resource Center Website

The bill requires the Department of Public Safety to include on its wildfire status website emergency information and wildfire updates for each county. The division must coordinate with county governments to gather the necessary information.

Bill E — Concerning Support to Increase Prescribed Burns

The bill creates the Prescribed Fire Claims Cash Fund with a \$1.0 million General Fund transfer. The Department of Public Safety administers the fund to pay damage claims resulting from pre-registered prescribed fire projects. The bill also allows reciprocity eligibility for certified burner status which is granted to individuals that conduct prescribed fires by the Division of Fire Prevention and Control.
