REQUEST FOR DRAFT OF INITIATIVE TO DRAFTING COMMITTEE

Comes Now, Douglas Burns and Laura McFall, of Total Recall Petition Drives, President and Vice President, WHO DECLARES:

Greetings and Salutations to:

Servants and Employees there of : Legislative Drafting Committee

You are hereby requested by the Sovereign of the State and United States to perform your duty and functions according to Article V section I. A clause 5 Colorado Constitution to review and comment on the below or attached proposed initiative. Be it also requested, pursuant to Title One, Article Forty- parts one and three. Colorado Revised Statues to properly draft the below measure to conform to constitutional requirements with suggested ballot title if so incline; Be it known

Tom Walters Initiative

To bring accountability to all Law Enforcement. All Govern- Officials whether appointed, elected, employed or otherwise.

Hereby be it known. The perception and truth among the majority of citizens in this state know that no real substantial accountability or punishments rendered to said Government officials for their bad acts. This has turned into a chaste system. The condition worsens. Whereby the protection of the citizens due process Constitutional and Statutory rights as well as common

courtesy and respects are greatly diminished or entirely un-observed. To turn this tide and secure the protection and observance of rules and law of individual citizens by Government Officials, it is the purpose and intent of this Initiative to : Require mandatory investigation, require mandatory prosecution of all said officials Who are said to have violated 18-8-401et-seq, as provided for therein.

Accusations will meet constitutional requirements in Article II section 7 & 8 and investigated by Douglas Burns/ Total Recall Petition Drives, and his appointees(fourteen other corporate members) (one being Laura McFall) who decide whether what charges may issue.

The citizens are asked to fund this aspect of Total Recall, through the Treasury to fund deputies, assistants, and employees appropriations at the same percentage equal to the amount of Government officials in each county as funding given to each District Attorneys office for the prosecution of citizens in their respective counties. Statewide, we anticipate one office (branch office), in counties that exceed 50,000 citizens funded by the above ratio of percentile.

Mr. Burns and his corporation seek to establish him and his members as a new creation under the constitution granting powers to said corporation to require prosecutions are put to a vote by this body. Requirements to hold positions; prior felony convictions, at least three, service in penitentiary of at least 10 years with no current crimes or convictions for 7 years. Parole time and prison time count toward clean time as proof of repentance or redemption of character.

Terms are for 15 years. The President will select his officers and waive the above requirements while the corporation establishing itself.

Once the Prosecution decision is made the evidence will be collected and investigated by the usual authorities, any evidence recall has, will be turned over as well. Any Sheriff or District Attorneys who refuse to prosecute shall be subject to sanction or removal by Recall subject to Recall Petition funded by the State or Order of Governor, per Article IV sec 6 or XIII sec 3.

Salaries: as set by other Elected or Appointed officials. Venue as selecting by the injured parties and mandatory fines payable to injured parties under 18-1.3.401. CRS, or 18-1.3-501 CRS.
