## Proposed Changes to Colorado Revised Statute Section 19, C.R.S.

In regards to the legal parent-child relationship, the definition of "court" be expanded to include the option for a jury as a single subject petition pursuant to Article V, section 1 (5.5) of the Colorado Constitution:

## Be it Enacted by the People of the State of Colorado,

SECTION 1. In Colorado Revised Statutes, 19-1-103 amend (70) as follows:

**19-1-103. Definitions.** (70) "Juvenile court" or "court" means the juvenile court of the city and county of Denver or the juvenile division of the district court outside of the city and county of Denver OR A JURY BEFORE TERMINATING THE LEGAL PARENT-CHILD RELATIONSHIP.

SECTION 2. In Colorado Revised Statutes, 19-1-104 amend (d) as follows:

**19-1-104. Jurisdiction.** (d) To terminate the legal parent-child relationship, EXCEPT PARENTS SHALL ALSO HAVE THE RIGHT TO A JURY.

The fiscal impact estimate is as follows: Unknown ongoing net fiscal impact on state courts that would depend significantly on (1) how the measure is interpreted and implemented by the juvenile court or court; (2) how parents respond to the ability to choose a jury trial in termination of a legal parent-child relationship; (3) how children respond when able to stay within the care, companionship and control of their legal parent-child relationship as a result of a jury nullifying its termination.

Would the option for a jury trial include temporary or emergency orders relating to child custody? NO

Would the option for a jury trial include hearings on motions to modify legal custody orders? NO

Would the option for a jury trial include the determination of parenting time after legal custody or decision-making responsibility has been allocated? NO
