Summary of Measure

This initiative amends the state constitution to change the voting age to 16 for all state and local elections.

State Expenditures

In FY 2018-19 only, this initiative will increase state cash fund expenditures in the Department of State cash fund by \$336,000 to modify the state's voter registration database, SCORE, and associated web applications. It is estimated that this work will take 3,000 hours of contractor time at a rate of \$112 per hour. Additionally, workload will increase for the Driver Control Section in the Department of Revenue for an increase in voter registration activities. It is assumed that this workload increase can be accomplished within existing appropriations.

Local Government

This bill will increase county expenditures by approximately \$300,000 per election. These expenditures are described below.

Assumptions. According to data from the State Demography Office in the Department of Local Affairs, the number of 16 and 17 year olds in the state is estimated to be approximately 146,220. Additionally, for the last two primary elections held in the state, the average cost to counties per voter was \$2.68 per eligible voter. Assuming approximately 75 percent of 16 and 17 year olds will be eligible and choose to vote, this initiative will increase county costs by around \$300,000 for election related expenses.

Additionally, as voters who are 16 and 17 would be unable to vote in federal elections, counties will have costs to create a new ballot style specifically for 16 and 17 year old voters. This cost will vary by count and has not been estimated.

Effective Date

If approved by voters, the ballot initiative takes effect upon proclamation of the Governor within 30 days of the official canvas of votes at the 2018 general election.
