
## Support Strategic Planning & Collaboration on Behalf of Deaf/Hard of Hearing Children & Their Families



1996: Passed Deaf Child's Bill of Rights; 1996: Hands & Voices begins

1997: Passed Minimum standards for Educational Interpreters (now outdated)

2002, 2004 Creation of Blueprint for Closing the Gap and the CDE CO Quality Standards (now outdated),

2004 ASL as a Foreign Language Credit in High School,

2007: Hearing Aid Insurance Mandate, 2008 Last CO Deaf Symposium.

### Timeline of Deaf Education Improvement Events:

**November 2012**: Inspiring Change Grant accepted: **Feb & April 2013** Presentations from **Iowa, Washington, and Minnesota's** exemplary programs to jumpstart Colorado's discussion of system improvements after 7 years without action (aging list of best practices, stalled regional programs, foundering academic outcomes.)

April 2013: 56 stakeholders identified what they found useful in the plans of the other states and prioritized our own list.

- •Need for full access to **data** that accurately depicts the students we serve, most of whom are educated in their neighborhood schools.
- •Need for a collaborative team/network to design a statewide strategic plan to improve student outcomes (not just respond to requests).
- •Increase Deaf involvement at all levels; focus on the Cultural Connection

The Superintendent of CSDB announced at the closing session: would work with H&V, CCDHH and CDE on strategic plan before all stakeholders. *No action on that pledge to date.* 

CCDHH multi-org grant: *H&V/CAD/RMDS* grant proposal for "Implementing Inspired Change Task Force:"to revise 2002 Blueprint. Active participation by CSDB with 2 or more reps at most meetings. CDE was unable to attend two meetings. **Consensus reached on Blueprint items 2-6** Jan-April; May/June focused on remaining two recommendations. Added two meetings. Consensus reached October 2015 except for **CDE limited approval and CSDB no approval, finally given Jan-Feb 2015**. Final report to CCDHH June 2015. Recommendation for Coordinator of Task Force: CCDHH Final Report Fall 2015. Jan 5, 2016: JBC denies CCDHH request without input from grassroots community. Nov –Dec 2016: Grassroots second attempt with JBC.

### 1. Introduction: (Sara Kennedy, CO Hands & Voices)

- Thank you to the JBC for inviting us to share our concerns.
- Daughter: was late identified with hearing loss, but doing great today because of the strong collaboration and emphasis on professional development in her early years. At Hands & Voices, we advocate for other parents and children: Pueblo story of preschooler who has no access to a strong sign language model or a team who understands implants, Cherry Creek teen who has a significant hearing loss and is using verbal communication without the supports he needs, most of which do not cost anything to provide. (lack of access to prepared professionals, sign language or to visual aids)
- Our group of parents and deaf/hard of hearing adults and concerned professionals has been working **since 2012** to improve outcomes in Deaf Education. (see timeline)
- We have written two grants to bring stakeholders together. One brought in presenters from three states and focused a discussion about our current needs (2013) called *Inspiring Change*. The second was focused on updating the past Blueprint for Closing the Gap and that was completed in June 2015, called the Seven Agreements for short (see link)
- What is the issue? Student Achievement for this Low-Incidence group
  Last data available: 2012 (shared with the Inspiring Change conferences in Feb 2012 by CDE in
  front of 86 stakeholders)

out of 821 3<sup>rd</sup> grade through 10<sup>th</sup> grade students, only **29%** were proficient or advanced on the state assessment in reading. **40% were rated unsatisfactory.** 

Those numbers do not include any who took the Alternative Assessment, which by its very nature is intended for students with extremely low language. Those numbers were not available to us.

Yet, **out of 296 children in the birth to three program (2015 data)** served locally statewide, the majority reach a level commensurate with their hearing peers or with their cognitive ability on standardized measures. CO is recognized as a leader in birth to three supports for deaf and hard of hearing children.

We want to know what happens to those children by 3<sup>rd</sup> grade. If adequately supported, far more should be proficient and advanced.

• At the end of *Inspiring Change*, agencies promised to work with us voluntarily on a statewide strategic plan to address gaps. *Nothing happened*. Then we had the Seven Agreements grant in 2014-15 (CAD, H&V, Rocky Mountain Deaf School) with good participation from all key stakeholders. All agreed that there were gaps in a comprehensive state plan and coordinated system, in quality standards and program assessment, availability of meaningful data given the amount of funds that the state and local districts expend on special education, targeted professional development and recruitment/retention, family engagement and deaf/hard of hearing mentors. *Nothing happened*.

We need your help to bring about the reasonable request of the CCDHH for:

- Creation of a statewide deaf education steering committee
- Create a position under the CCDHH for a neutral, impartial facilitator
- Including a statewide policy summit/education offering each year to showcase barriers and victories
- We vehemently agree with those recommendations in full.

### 2. Paul Simmons: Veditz Policy Institute (VPI)

- The Deaf community continue to witness the quality of education deteriorating due to inconsistent models and ineffective programs both for deaf students and for hard of hearing students, which differs greatly.
- Statistics still show that Deaf students graduate reading below grade level (some statistics say 4<sup>th</sup> grade) on average. We know that students can graduate reading at grade level with effective supports.
- Silo-syndrome continues to weaken Deaf education in CO.
- Sharing a fellow board member's story: Lack of adequate instruction in ASL for her age-appropriate level son in the state: despite regular advocacy in school districts and at the state school for the Deaf, she finally sent him out of state to a deaf school in California so he could be educated in a language rich environment.

### VPI supports the CCDHH proposal for

- Creation of a statewide deaf education steering committee
- Create a position under the CCDHH for a neutral, impartial facilitator
- Including a statewide policy summit/education offering each year to showcase barriers and victories

### 3. Janet DesGeorges, Hands & Voices (HQ)

- Here as a parent and as a past director of Colorado Hands & Voices
- Raised a daughter who is deaf during a time of strong collaboration, interagency agreements, the Symposium, strong support of parent organizations,
- Example to illustrate some of the challenges of deaf education as seen by hearing people: Student in northern Colorado who couldn't get accommodation of captioning for in-class videos/films/YouTube. "It's okay. I understand it is difficult. But just so everyone has equal access, let's turn off the volume whenever a non-captioned film is shown. "
- The complexities of educating deaf education require that many have a seat at the table: deaf/hard of hearing professionals, parents, deaf educators, audiologists, district personnel. We want to see a statewide vision for deaf education. Other states like Minnesota and Washington have strong models. Colorado can, too.



#### References and other facts:

CDE has been attempting to raise the standards of educational interpreters for the last four years on the advice of the Educational Interpreting Advisory Committee. The licensure change was stalled at the State School Board last year, asking us to work with special interest groups (CO Association of School Boards, CASE, CEA, CO BOCES, CO Rural Schools Alliance, Consortium of Special Ed Directors.) Very little progress has been made, and meanwhile, students work with interpreters who aren't meeting an acceptable standard.

The Consultant for CDE Deaf/Hard of hearing programs is not a full time position. Hours have been given to general education monitoring as well as deaf education.


# **Brief Biographical Backgrounds**

## George W. Veditz (1861-1937)



Founder and President of the Colorado Association of the Deaf (33 years from 1904 to 1937) and the 7<sup>th</sup> President of the National Association of the Deaf (1904 to 1910). Primarily responsible for the creation of the Motion Picture film collection at the US Library of Congress.

## Olof Hanson (1862-1933)



A nationally known architect who designed the United States Court House in Juneau, Alaska among several other prominent buildings in Minnesota and Washington DC. Hanson was the 8<sup>th</sup> President of the National Association of the Deaf (1910 to 1913).
