Department of Health Care Policy & Financing, Medicaid Recovery Audit Contractor Program, Update on Potential Legislation

Ms. Colin introduced staff.

Discussion ensued regarding stakeholder concerns regarding the bill draft.

Ms. Bimestefer (Department of Health Care Policy and Financing) was introduced.

Discussion ensued regarding the processes for ensuring the Recovery Audit Contractor (RAC) vendor uses appropriate and reliable criteria when conducting RAC audits, , allowing providers more time to respond to audit findings based on the complexity of an audit, creating a tiered approach to compensating the vendor based on the complexity of the audit that is capped at the current limit of 18 percent, , establishing time frames for HCPF to reimburse providers for underpayments and errors in recovery, shortening the lookback period for audits to 3 years, holding additional feedback meetings between the Department of Health Care Policy & Financing (HCPF) and providers, and incorporating the additional items discussed during the hearing in the revised draft.

A revised draft of the bill, incorporating stakeholder feedback, will be presented at the December 9. 2024, hearing.
